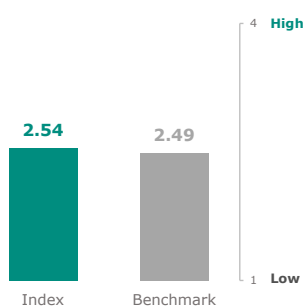
## Objective

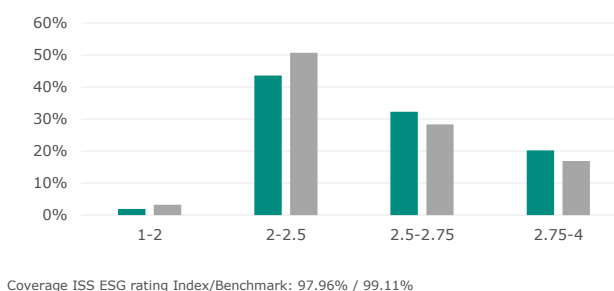

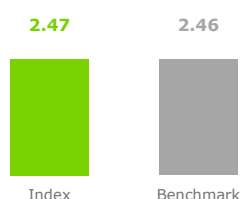
**Weighted average ESG rating**



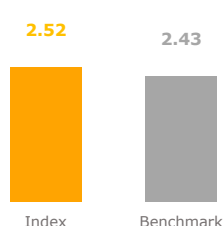
**ESG score distribution**



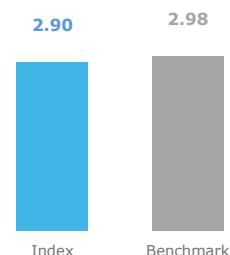

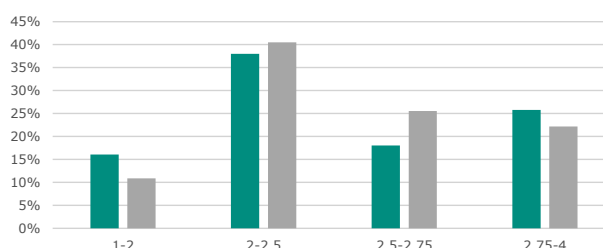

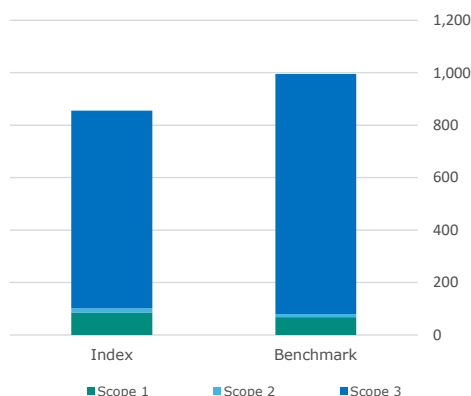
### Environmental score distribution



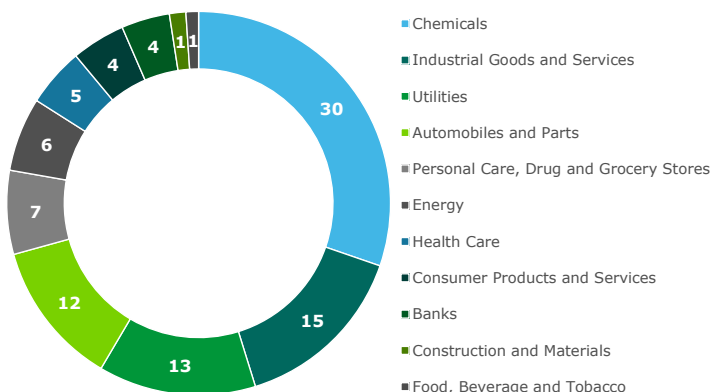

Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 14.03% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 9.92% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 97.95% of the total weight of the index, 98.12% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 75.66% for the index and 80.87% for the benchmark.

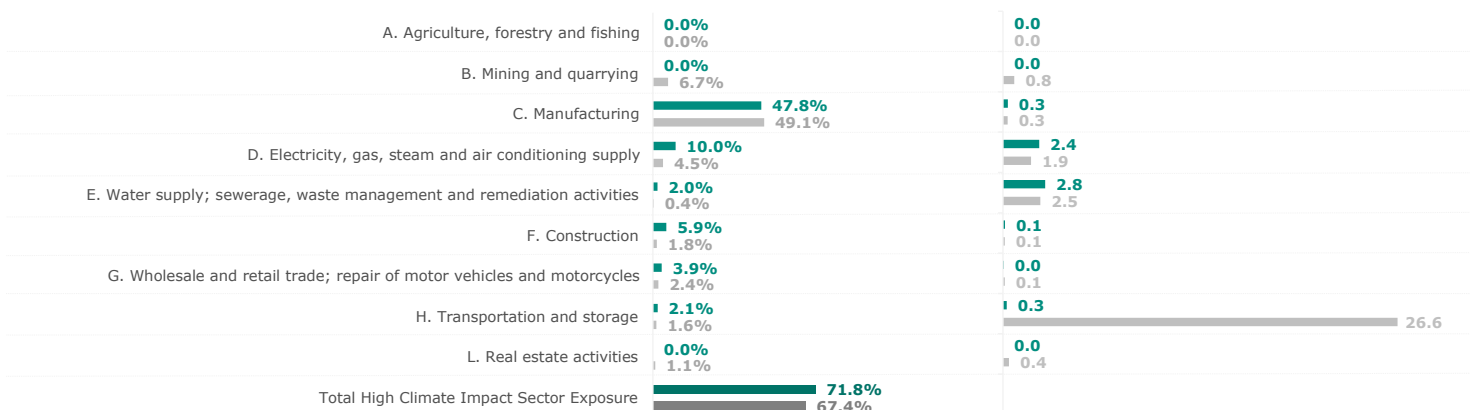

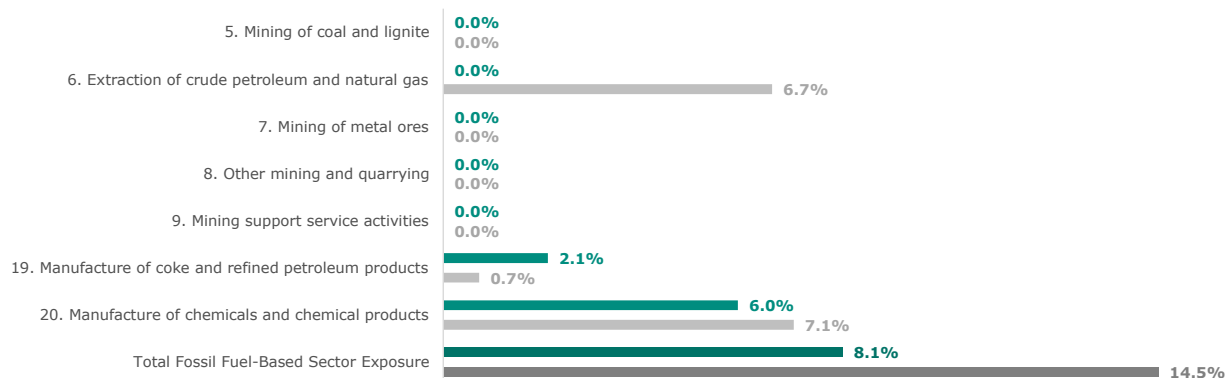

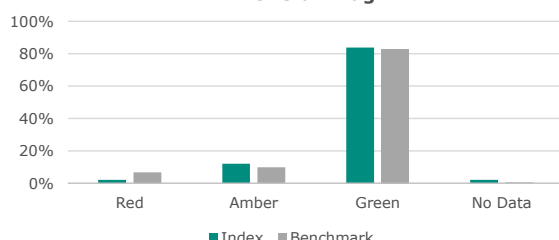

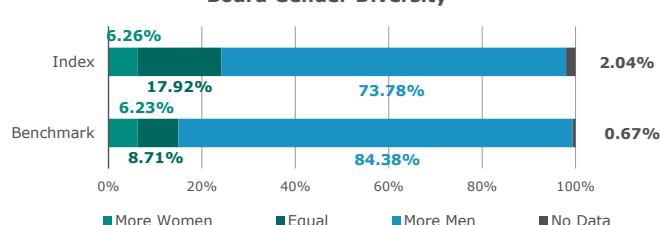

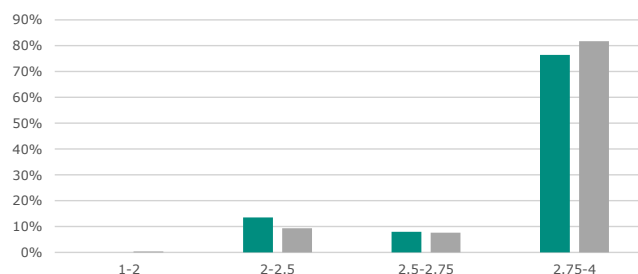

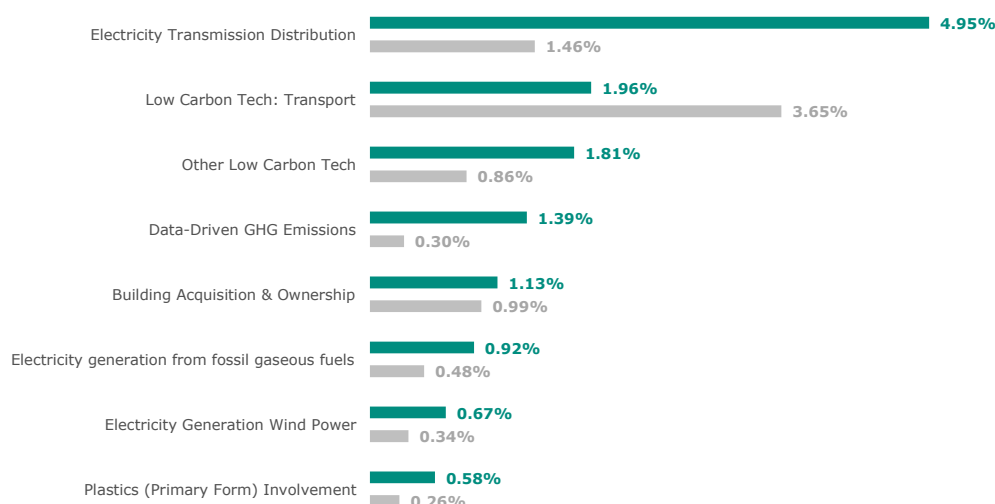

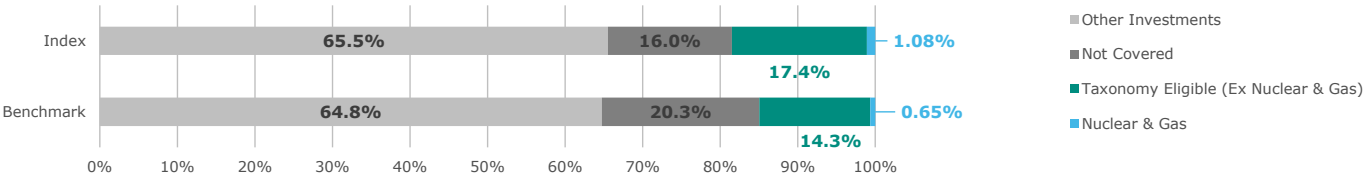

Eligibility Breakdown - Nuclear & Gas



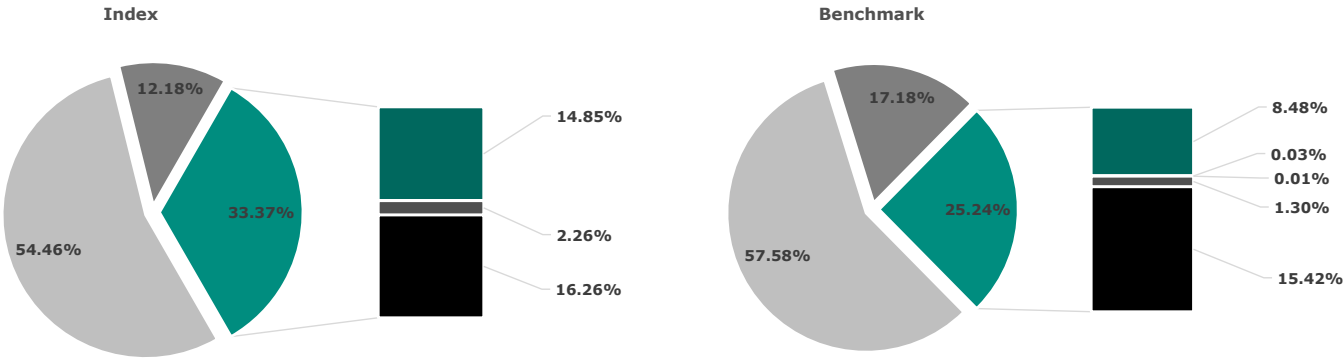
