## Objective

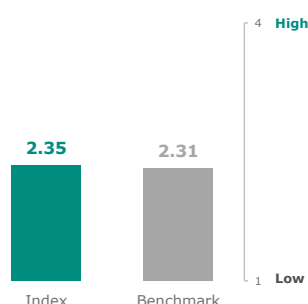

The index serves as a benchmark for biodiversity indices. The index serves as an underlying for structured products, funds, exchange traded funds and futures. 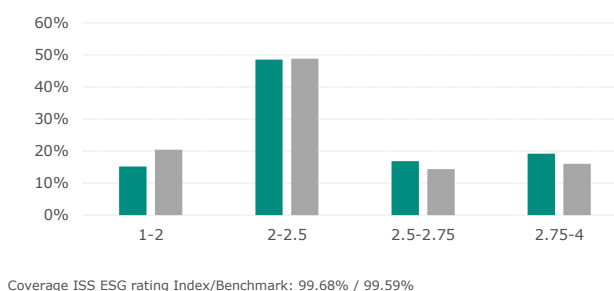

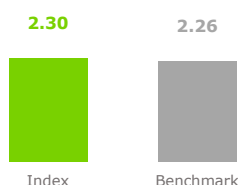
Weighted average ESG rating



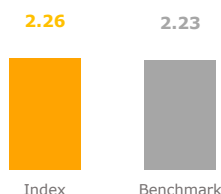
ESG score distribution



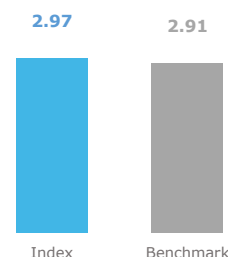

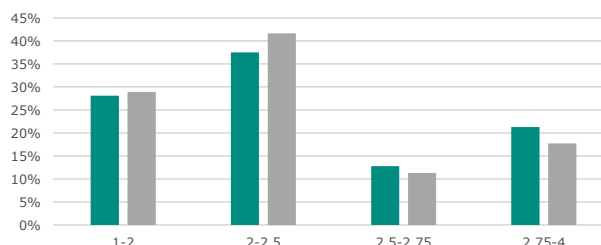

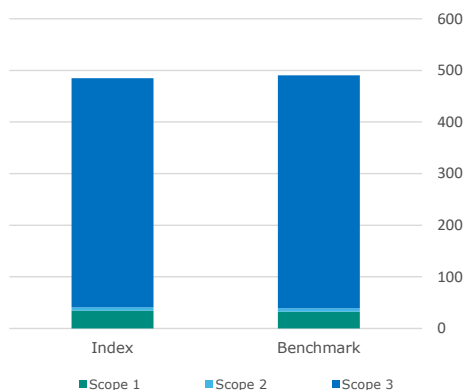
### Environmental score distribution



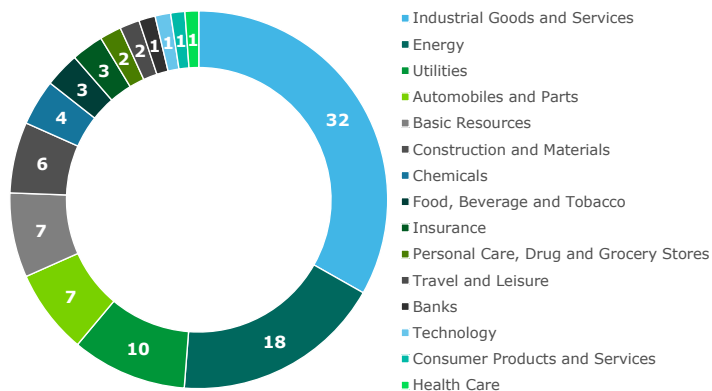

Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 1.09% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 6.37% higher than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 97.09% of the total weight of the index, 97.25% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 72.28% for the index and 72.76% for the benchmark.

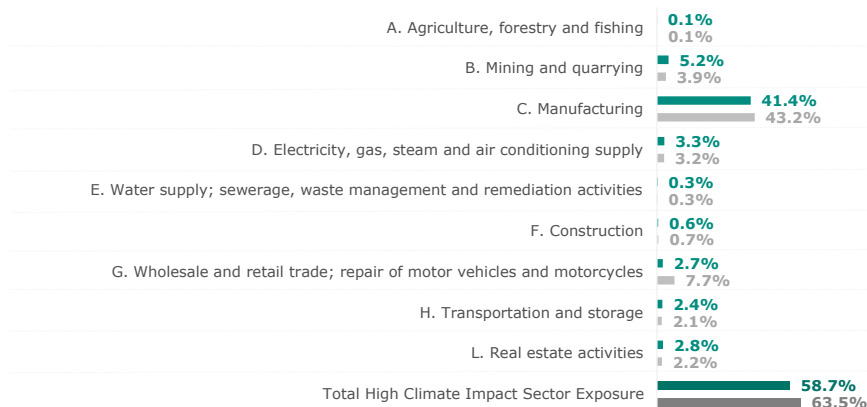

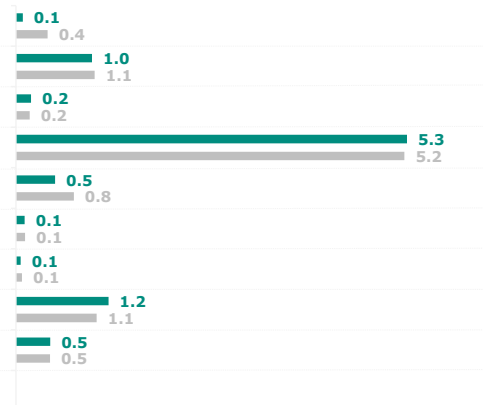

## High Climate Impact Sectors Exposure (NACE)



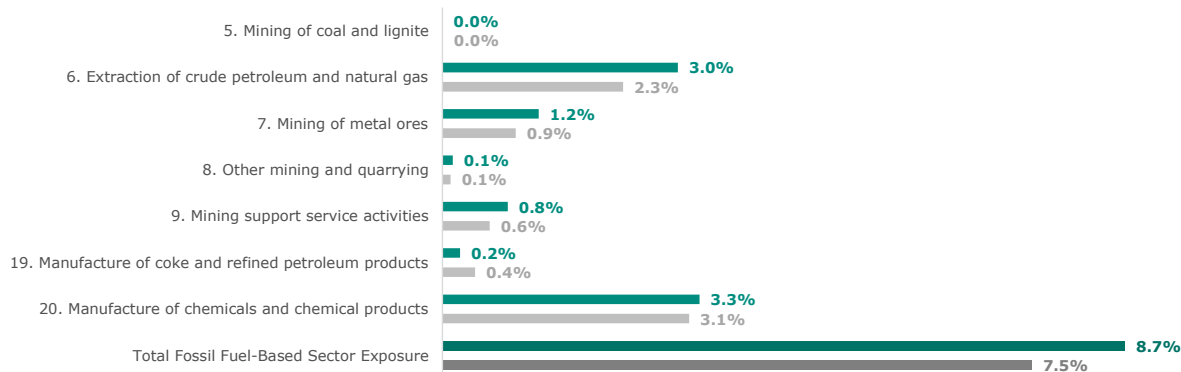

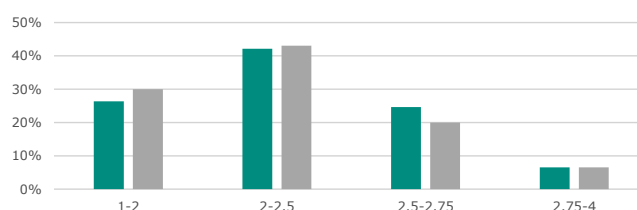

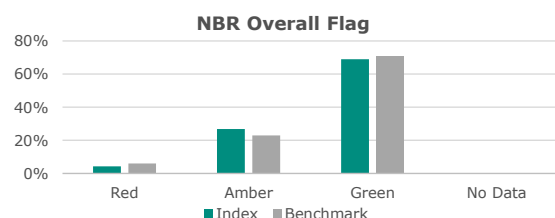

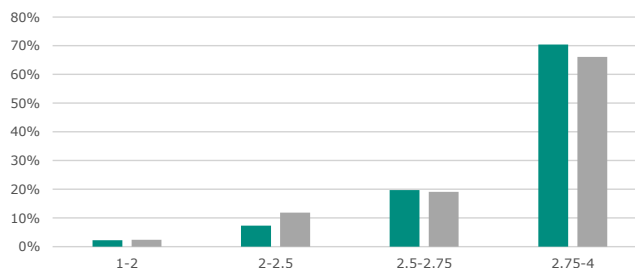

### Top Eligible Activities of the Index (%)



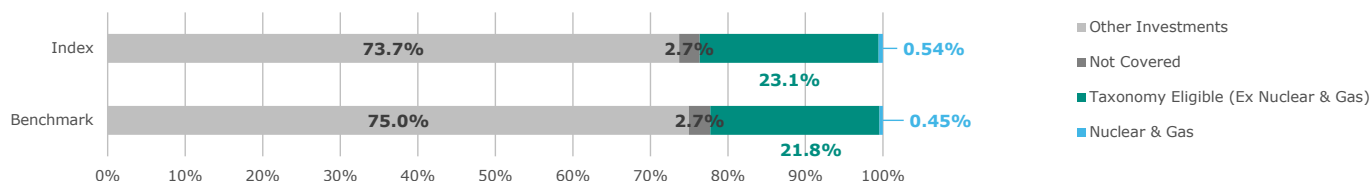
