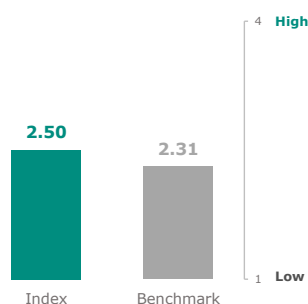

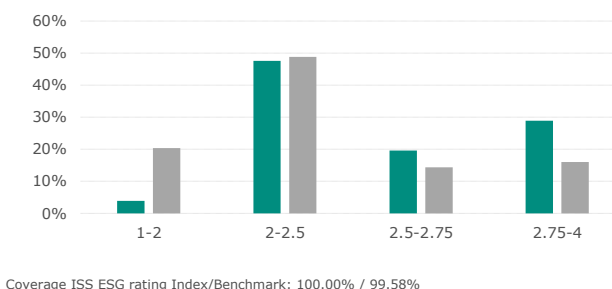

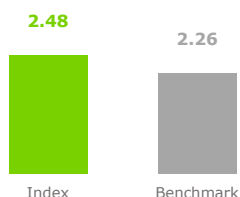
Weighted average ESG rating



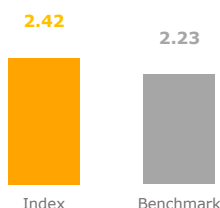
ESG score distribution



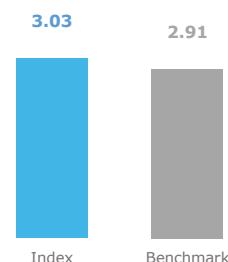

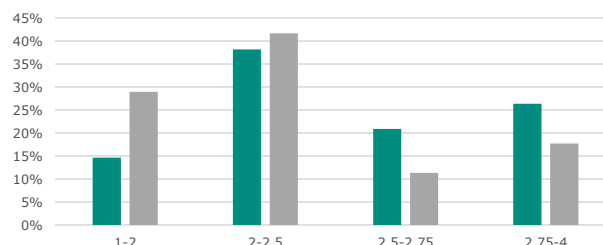

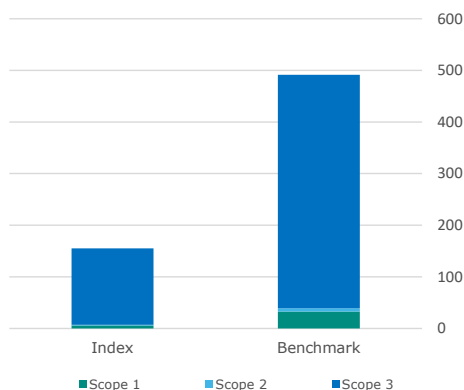
Environmental score distribution



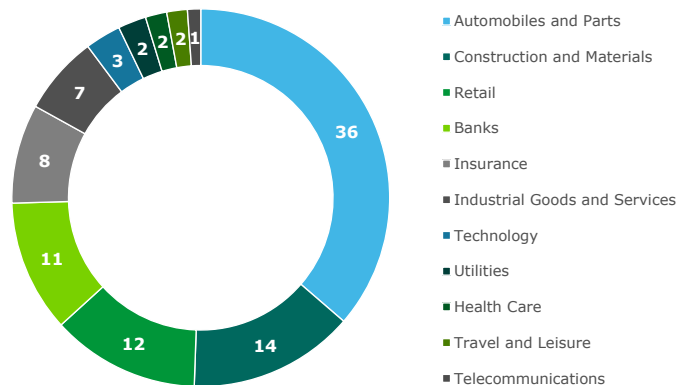

Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 68.40% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 53.81% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 99.05% of the total weight of the index, 97.25% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 79.31% for the index and 72.75% for the benchmark.

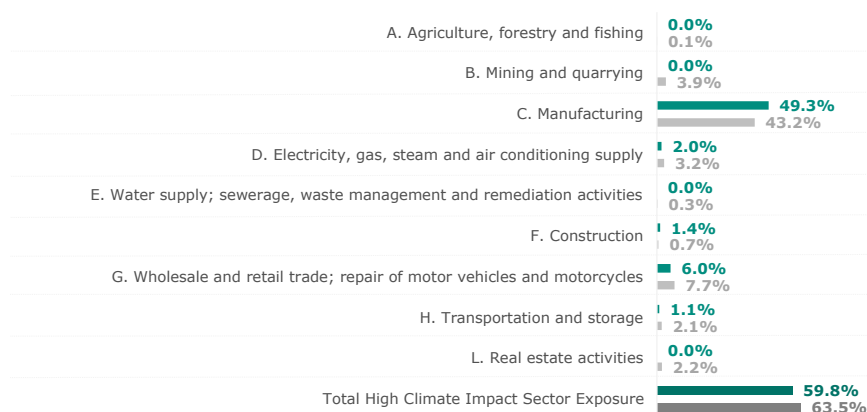

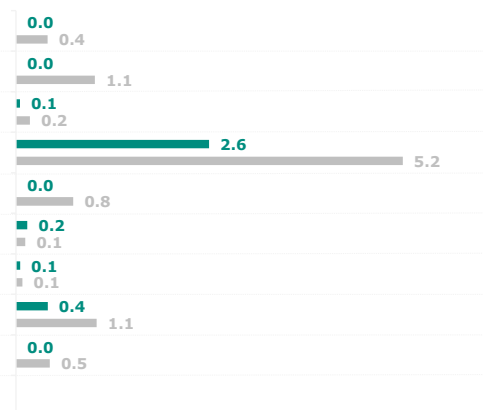

High Climate Impact Sectors Exposure (NACE)



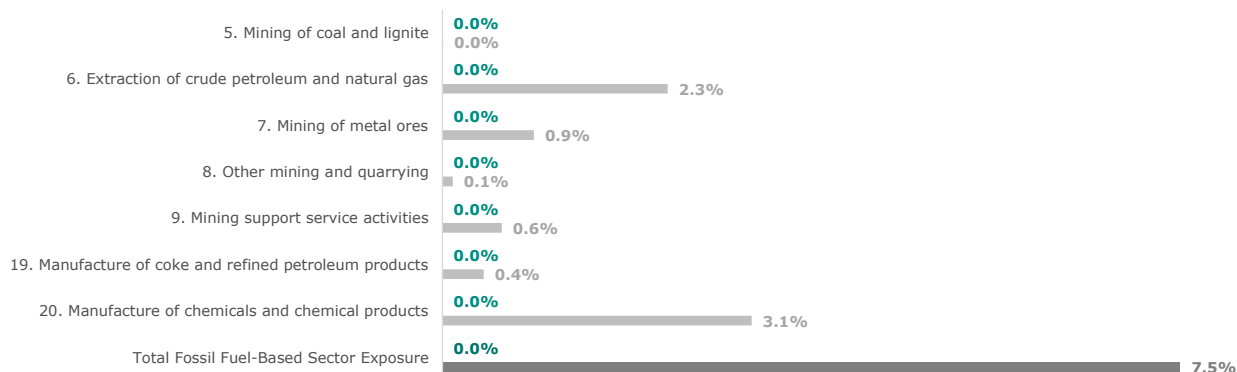

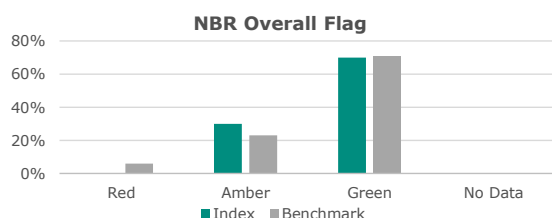

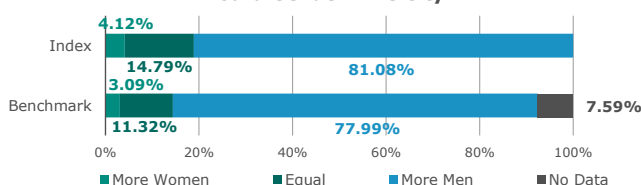

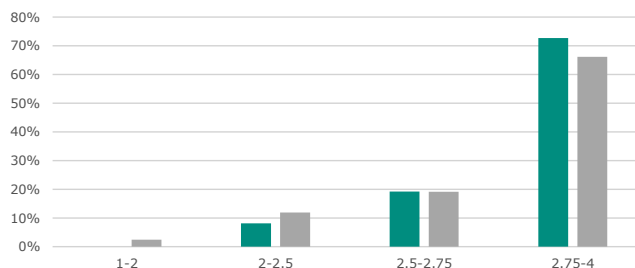

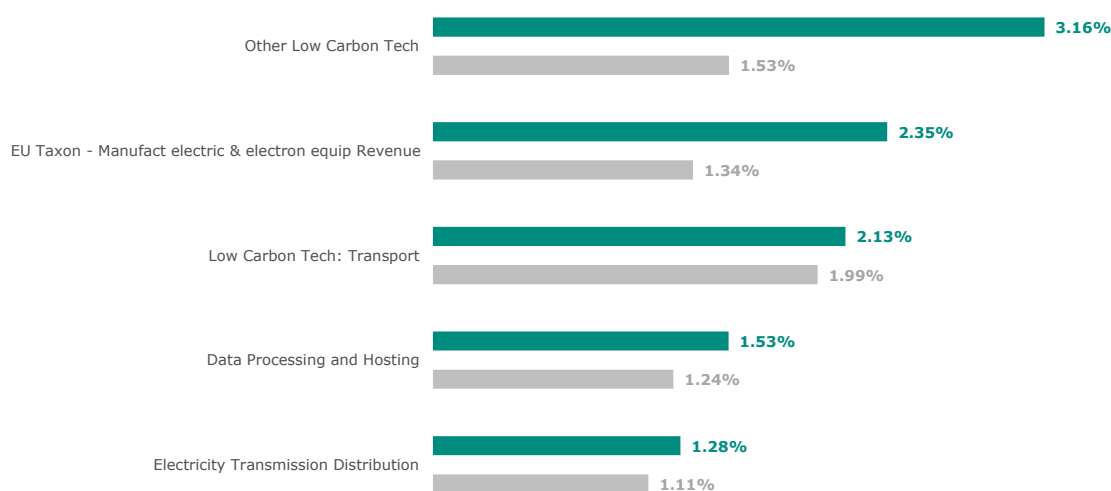

Top Eligible Activities of the Index (%)

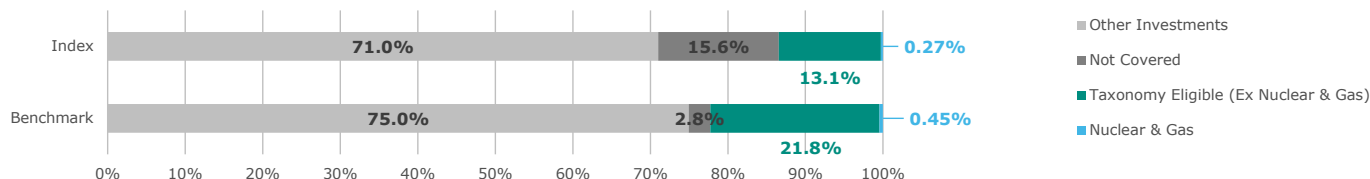

Eligibility Breakdown - Nuclear & Gas



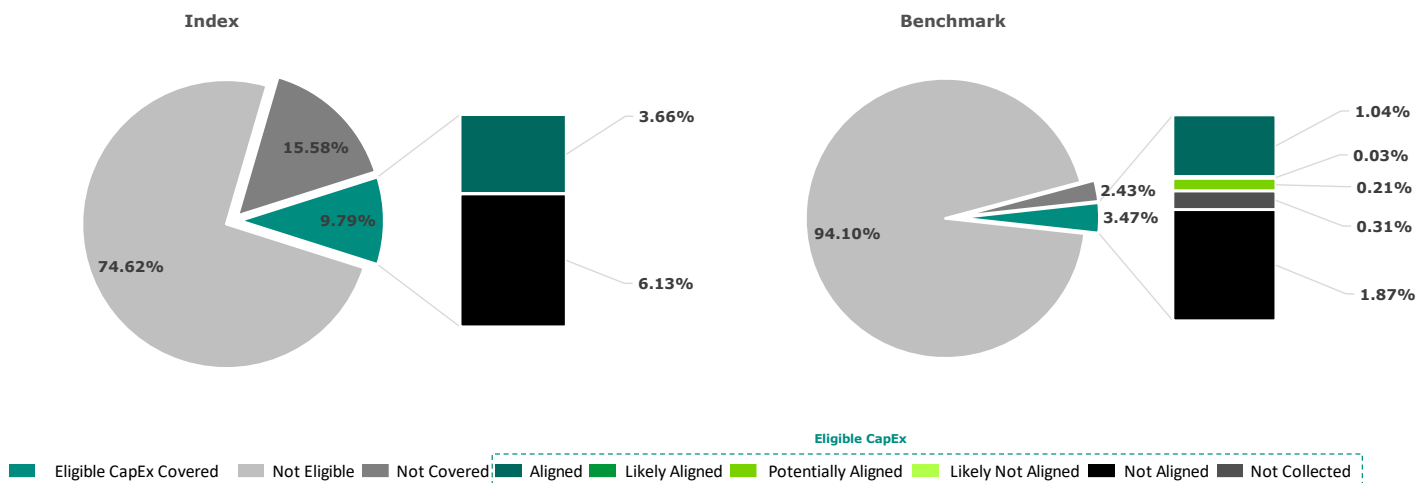

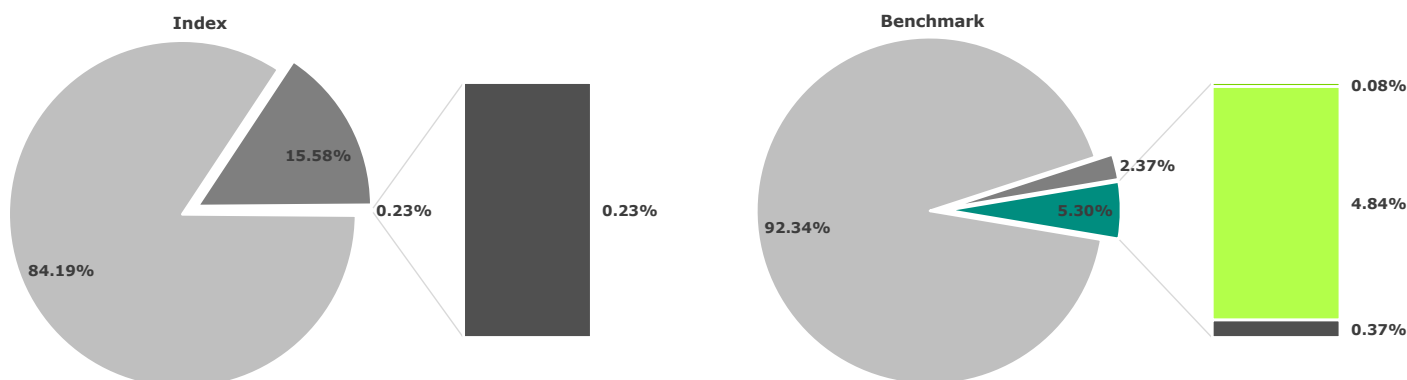
Circular economy
