## Objective

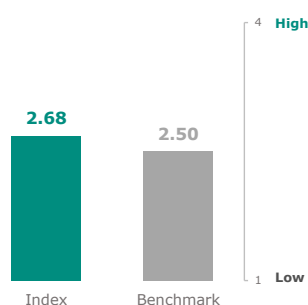

Constituents are reviewed on a quarterly basis and their weights are reset to equal weight at the quarterly rebalances. 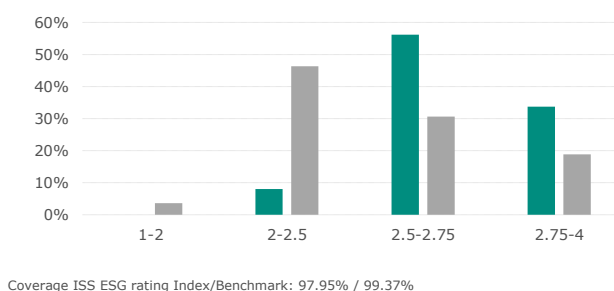

Weighted average ESG rating



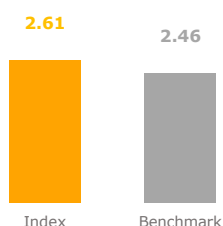
ESG score distribution



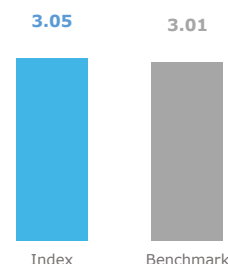

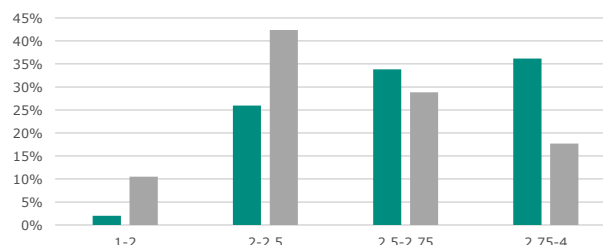

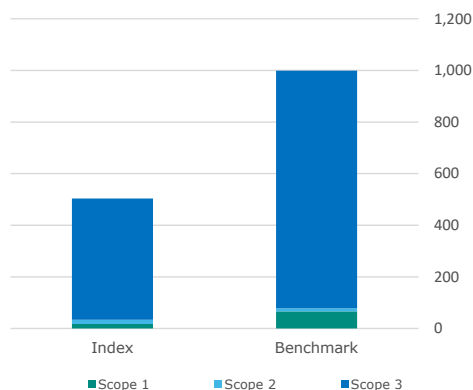
### Environmental score distribution



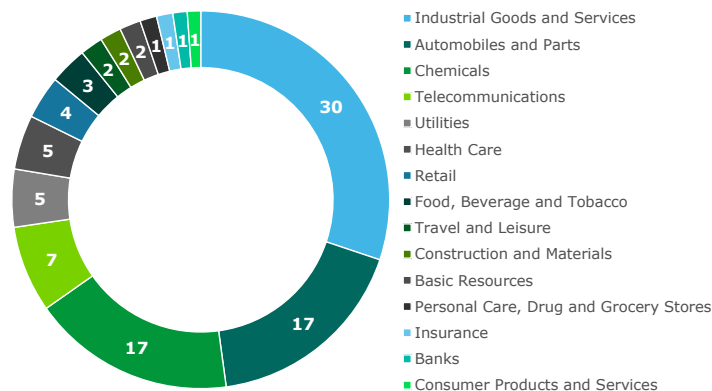

Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 49.62% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 39.79% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 98.04% of the total weight of the index, 97.93% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 88.25% for the index and 79.99% for the benchmark.

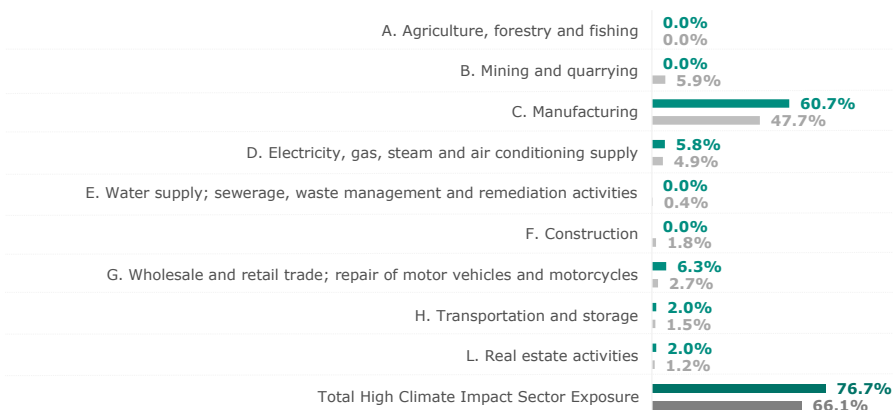

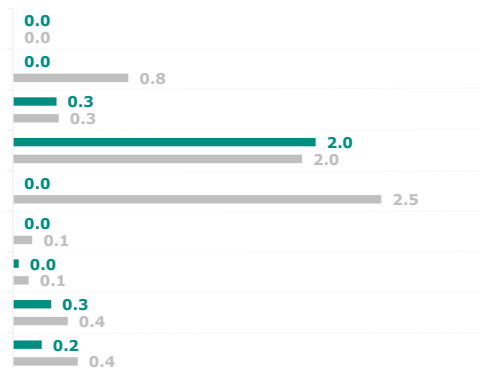

## High Climate Impact Sectors Exposure (NACE)



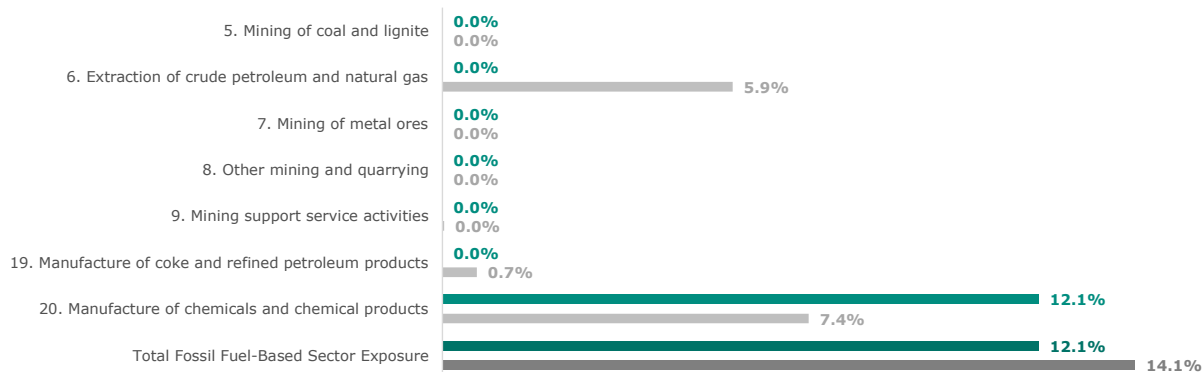

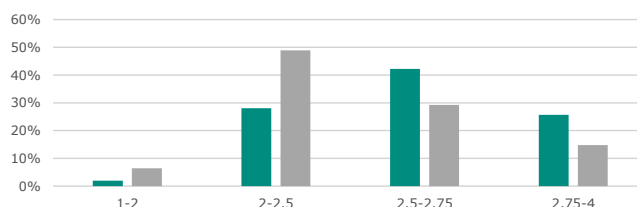

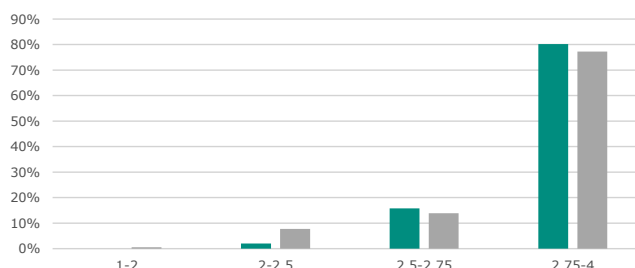

### Top Eligible Activities of the Index (%)



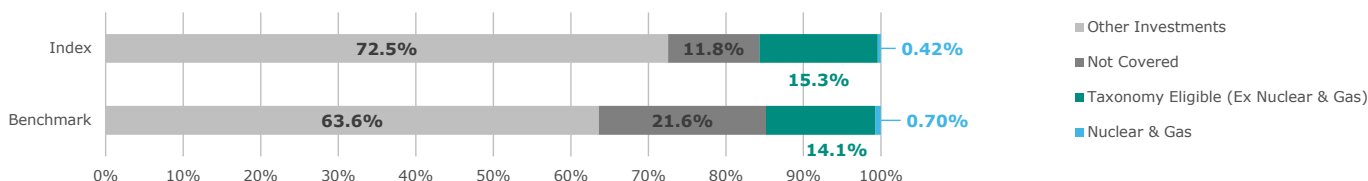
