## Objective

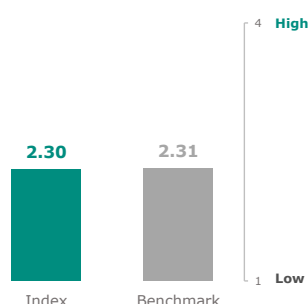

Euronext® Social Goods and Services World index is an equal-weighted index. The index serves as an underlying for structured products, funds and exchange traded funds. 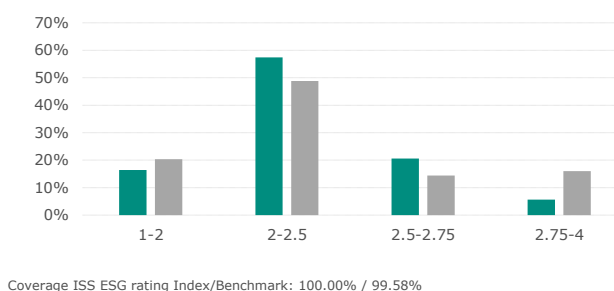

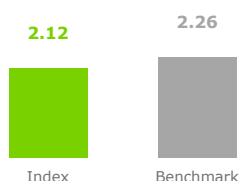
Weighted average ESG rating



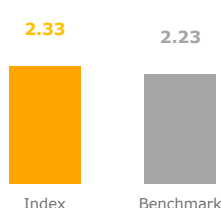
ESG score distribution



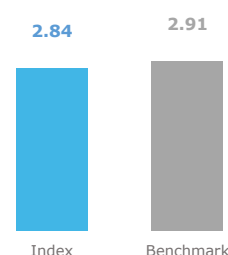

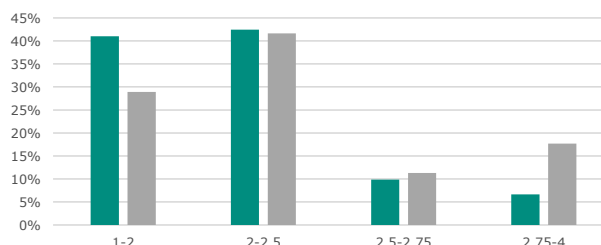

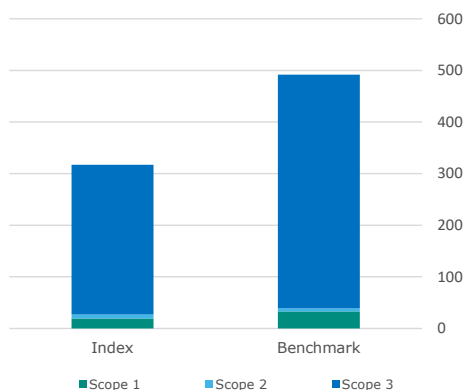
### Environmental score distribution



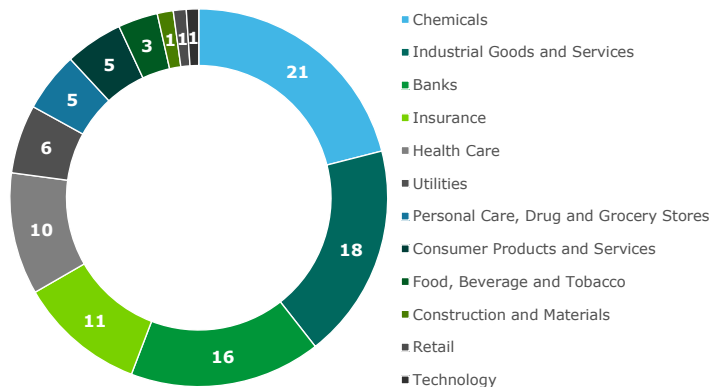

Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 35.44% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 24.26% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 97.83% of the total weight of the index, 97.25% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 58.87% for the index and 72.75% for the benchmark.

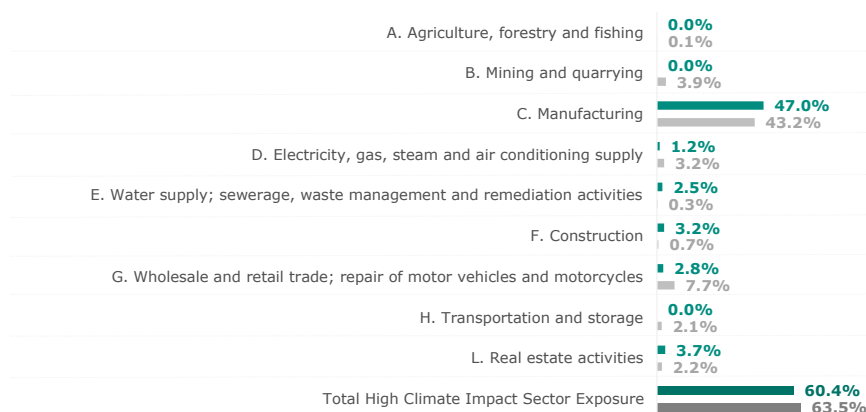

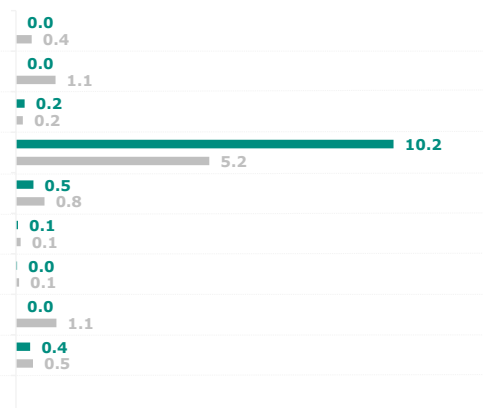

## High Climate Impact Sectors Exposure (NACE)



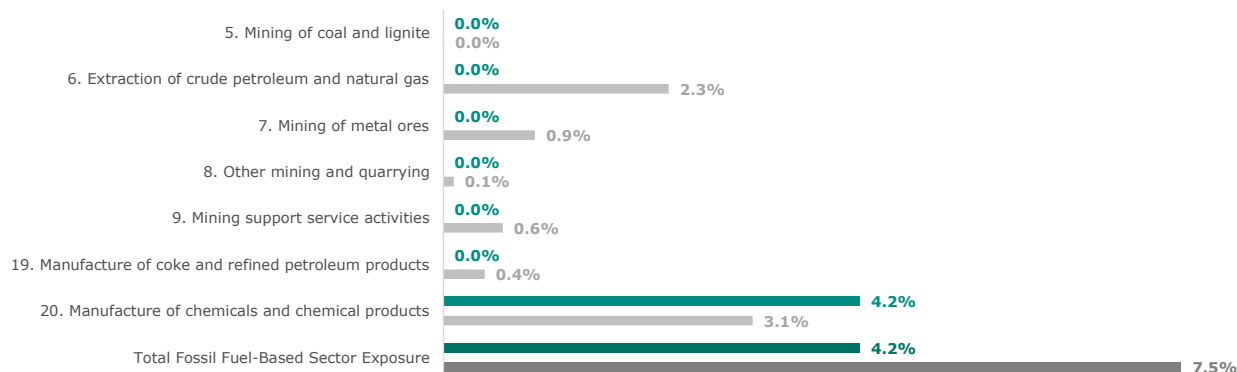

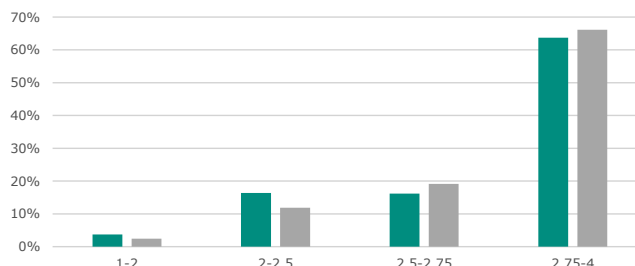

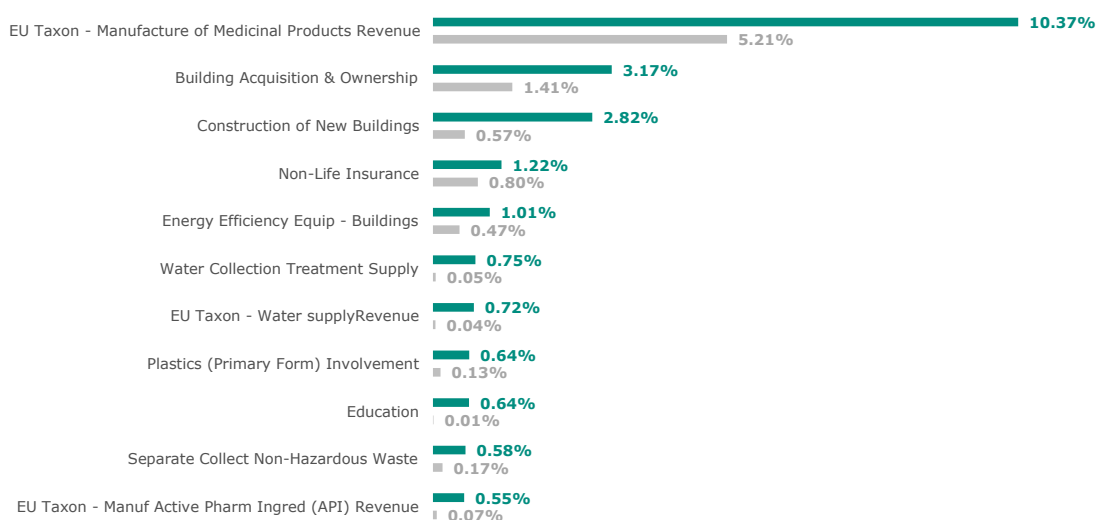

### Top Eligible Activities of the Index (%)



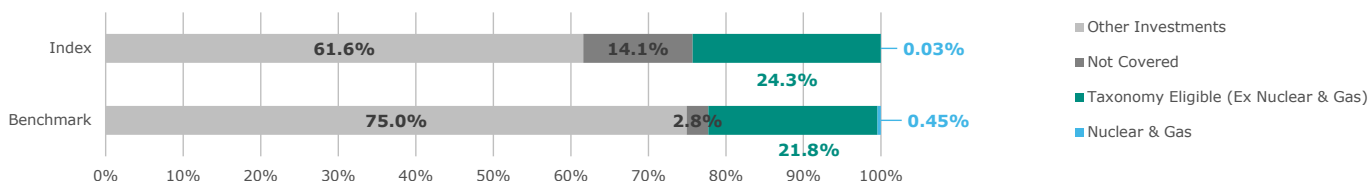
