## Objective






### Weighted average ESG rating




### ESG score distribution








### Environmental score distribution





Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 56.33% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 36.16% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 95.86% of the total weight of the index, 97.77% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 85.91% for the index and 79.38% for the benchmark.





## High Climate Impact Sectors Exposure (NACE)












### Top Eligible Activities of the Index (%)

## Eligibility Breakdown - Nuclear & Gas








## EU Taxonomy Alignment by pillars


### Climate Change Mitigation


### Climate Change Adaptation




## Circular economy


