

Euronext® Core Europe PAB 50 index meets the requirement of the "EU Paris-aligned Benchmarks" (PAB). The index serves as an underlying for structured products, funds and exchange traded funds. 


Weighted average ESG rating




ESG score distribution








Environmental score distribution





Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 76.15% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 60.50% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 97.68% of the total weight of the index, 97.77% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 80.58% for the index and 79.38% for the benchmark.





High Climate Impact Sectors Exposure (NACE)









Top Eligible Activities of the Index (%)



Eligibility Breakdown - Nuclear & Gas




