## Objective


The Euronext® ESG Eurozone Biodiversity Leaders PAB index selects the 30% top ranked company per ICB Super Sector included in Euronext® Eurozone 300 index in term of biodiversity score (CBF) as provided by Iceberg Data Lab - after exclusion of companies involved in UNGC controversies, controversial weapons, tobacco, coal, tar sands and oil shale, fossil fuel and among the 20% worst ESG score as assessed by Moody's ESG. Index weights are constructed using an optimization process that aims to achieve the PAB decarbonisation objectives while minimizing the sectorial weights' deviation relative to the Index Starting Universe. Euronext® ESG Eurozone Biodiversity Leaders PAB index meets the requirement of the "EU Paris-aligned Benchmarks" (PAB). The index serves as an underlying for structured products, funds and exchange traded funds. The index rules are available on our website. Euronext acts as Supervisor. 


### Weighted average ESG rating




### ESG score distribution








### Environmental score distribution





Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 72.40% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 50.10% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 98.82% of the total weight of the index, 97.77% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 74.87% for the index and 79.38% for the benchmark.





## High Climate Impact Sectors Exposure (NACE)













## Eligibility Breakdown - Nuclear & Gas




