




Weighted average ESG rating




ESG score distribution








### Environmental score distribution





Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 51.32% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 36.72% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 99.53% of the total weight of the index, 97.77% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 90.95% for the index and 79.38% for the benchmark.





## High Climate Impact Sectors Exposure (NACE)











## Eligibility Breakdown - Nuclear & Gas




