## Objective

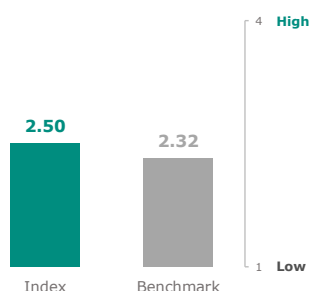

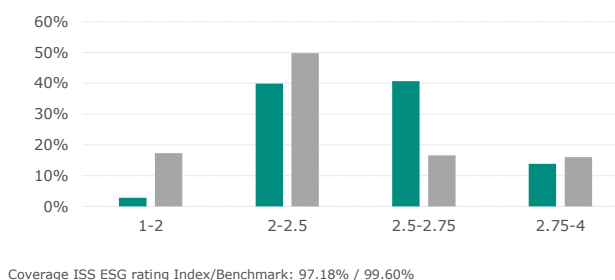

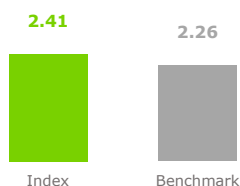
**Weighted average ESG rating**



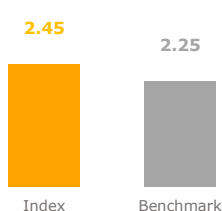
**ESG score distribution**



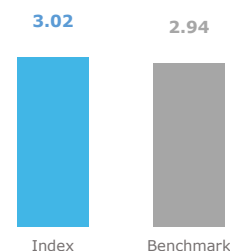

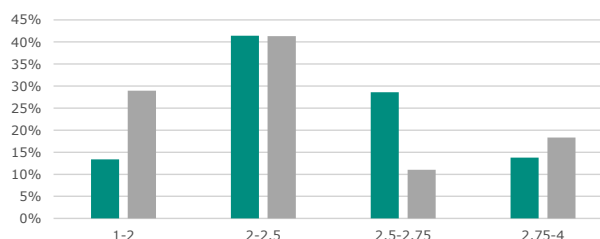

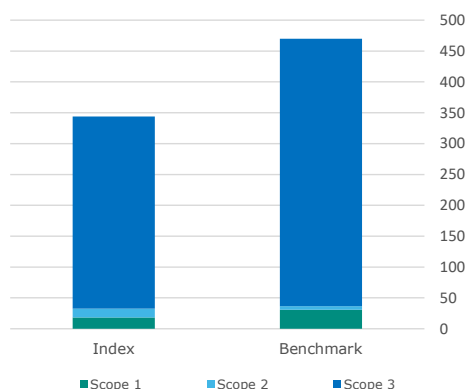
### Environmental score distribution



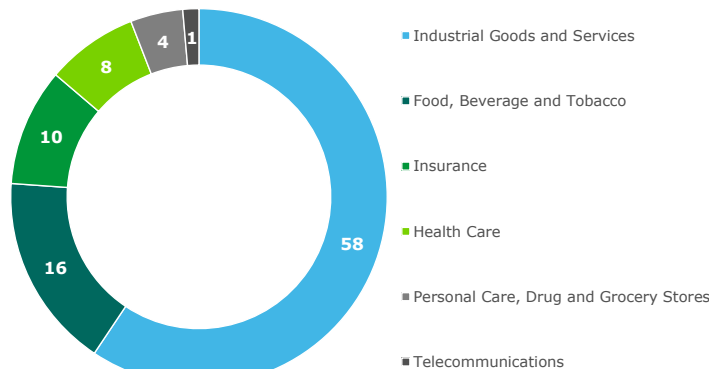

Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 26.78% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 41.61% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 100.00% of the total weight of the index, 97.12% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 70.27% for the index and 72.32% for the benchmark.

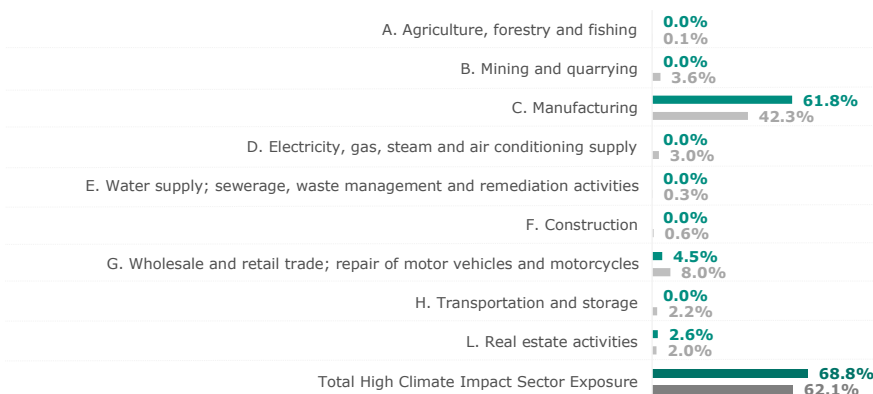

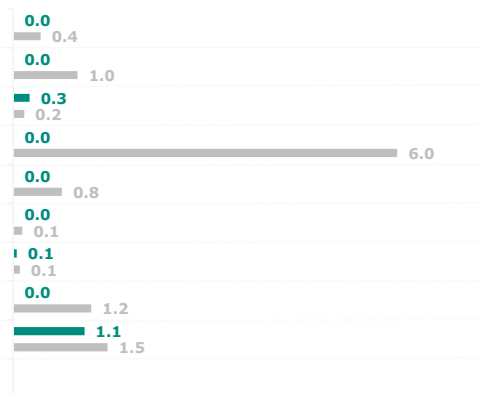

## High Climate Impact Sectors Exposure (NACE)



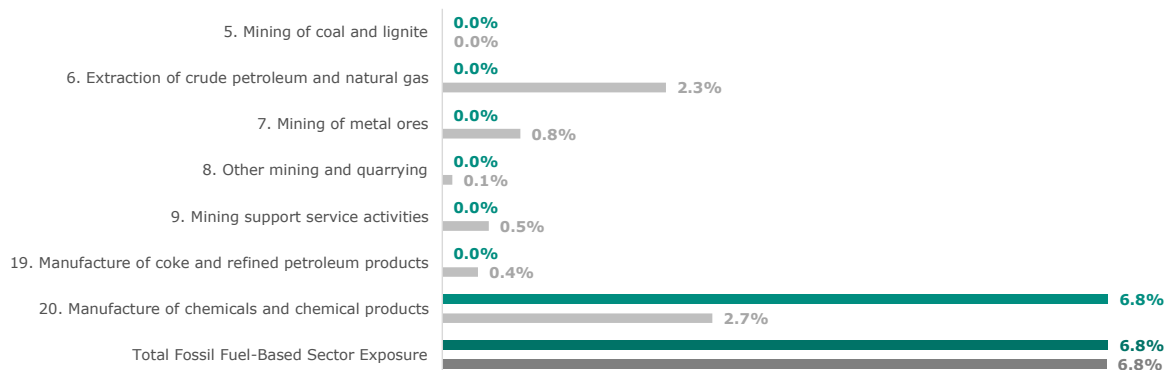

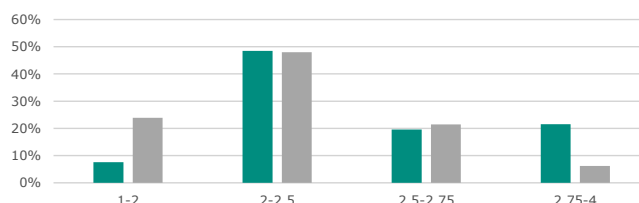

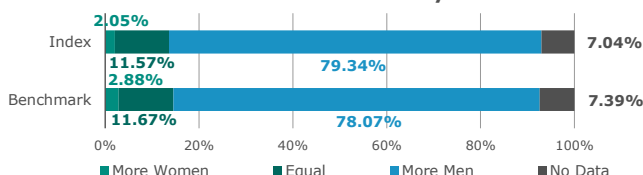

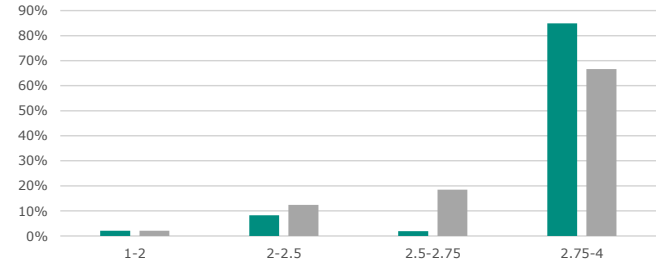

## Eligibility Breakdown - Nuclear & Gas



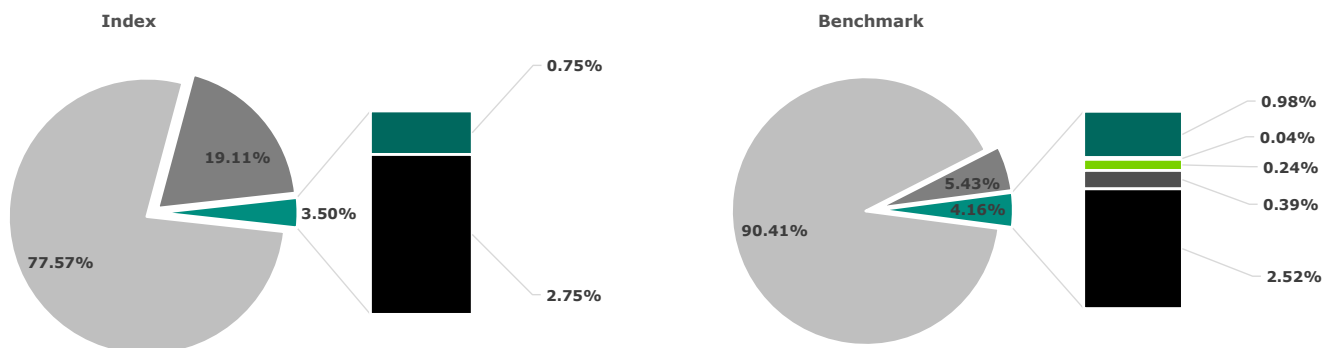
