## Objective

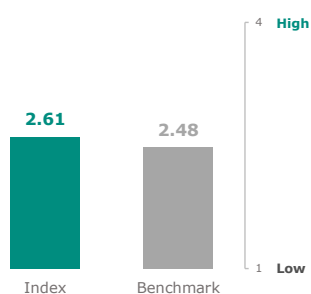
The Euronext® Switzerland 20 PAB index selects the 60 largest companies included in Euronext® Eurozone 300 index with as main market Switzerland, after exclusion of companies involved in controversial weapons, production of tobacco, coal, fossil fuel and with the worst SDG Climate Impact Ratings. Index weights are constructed using an optimization process that aims to achieve the PAB decarbonisation objectives while minimizing the weights' deviation relative to the Free Float Market Cap (FFMC) weights. Euronext® Switzerland 20 PAB index meets the requirement of the "EU Paris-aligned Benchmarks" (PAB). The index serves as an underlying for structured products, funds and exchange traded funds. 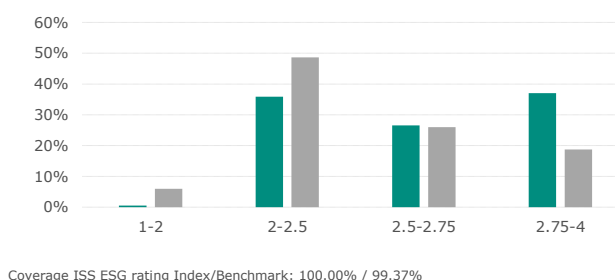

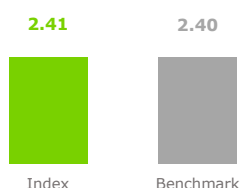
Weighted average ESG rating



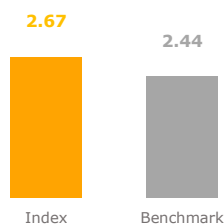
ESG score distribution



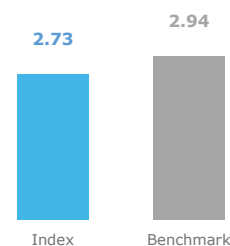

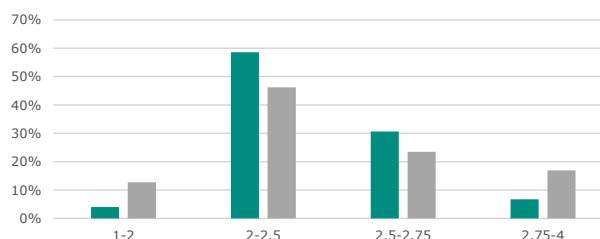

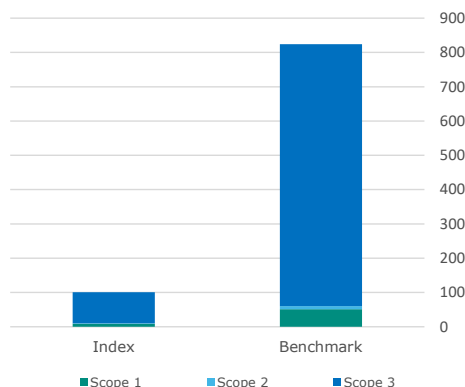
### Environmental score distribution



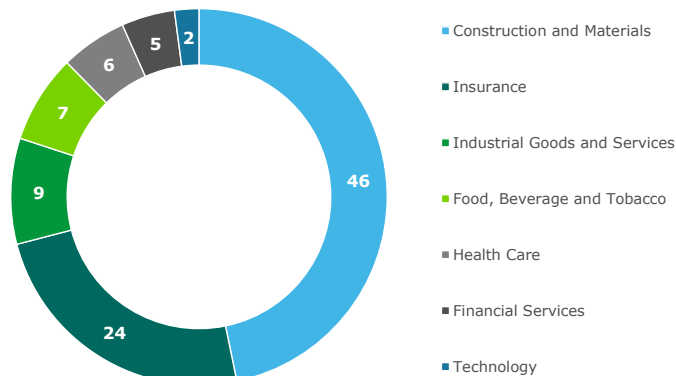

Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 87.79% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 72.81% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 100.00% of the total weight of the index, 98.69% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 86.22% for the index and 77.72% for the benchmark.

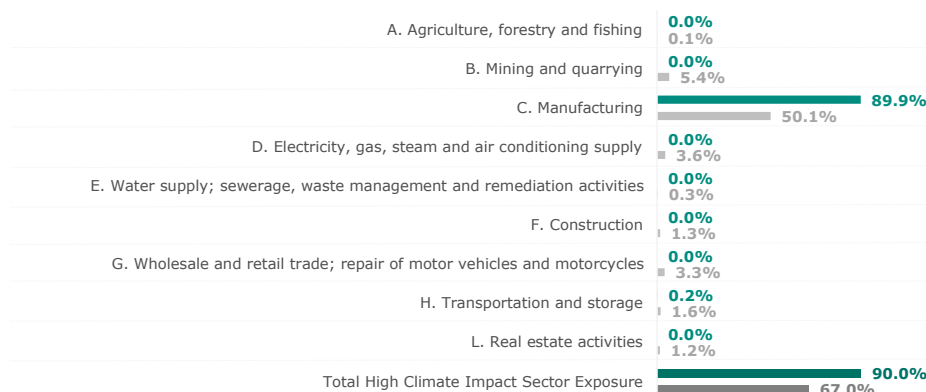

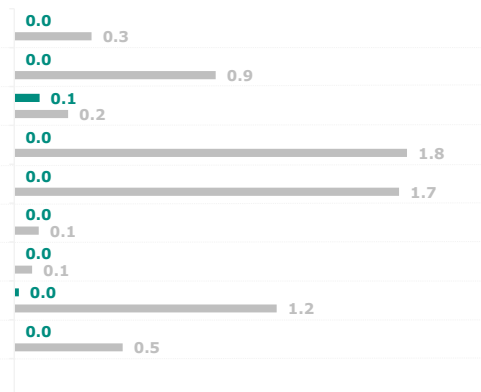

## High Climate Impact Sectors Exposure (NACE)



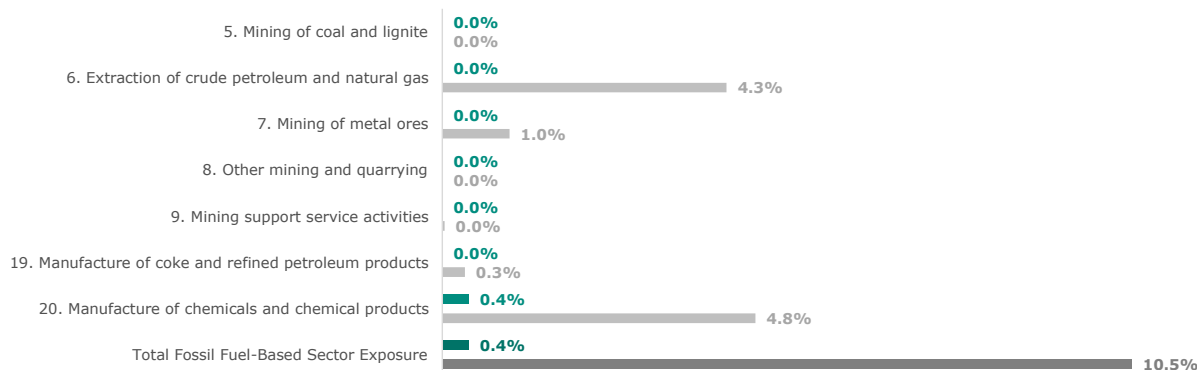

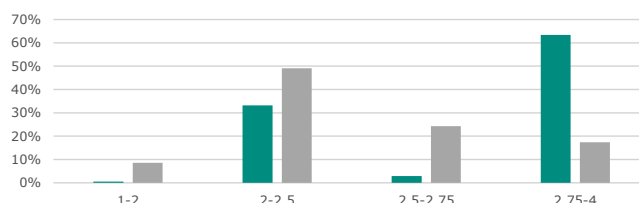

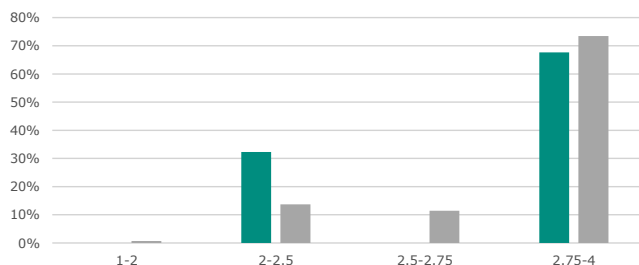

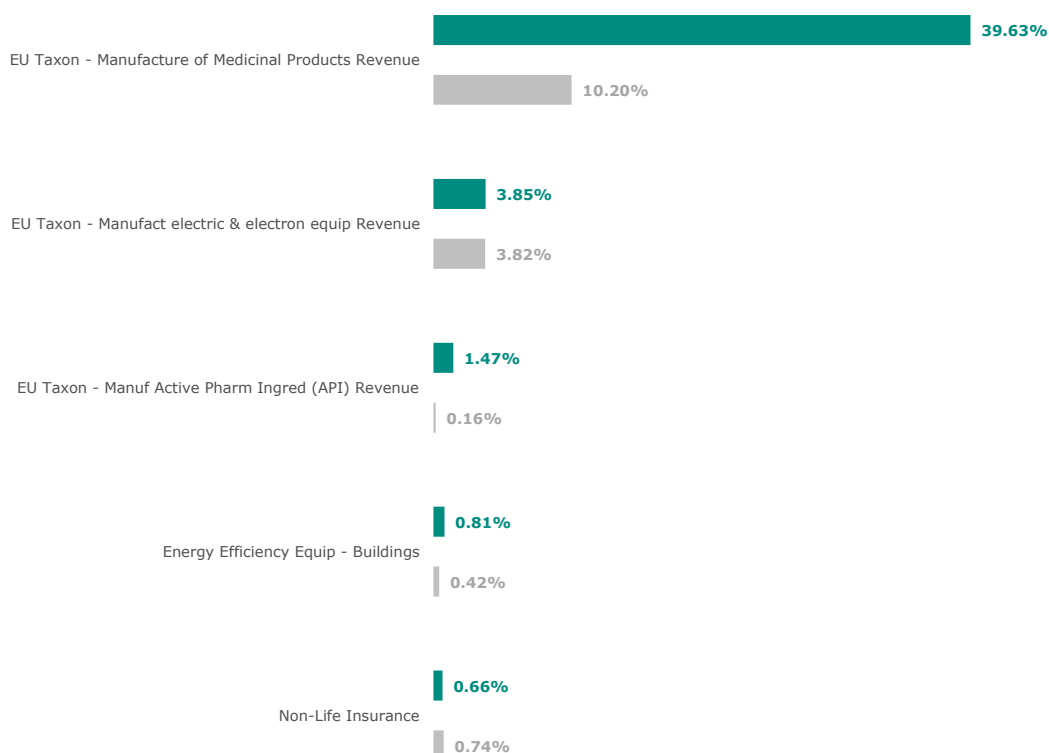

### Top Eligible Activities of the Index (%)

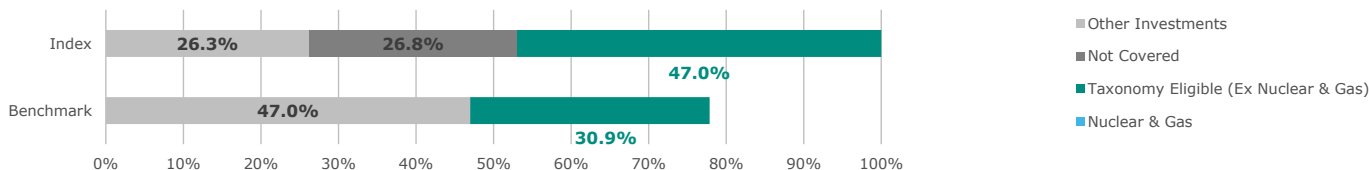

## Eligibility Breakdown - Nuclear & Gas



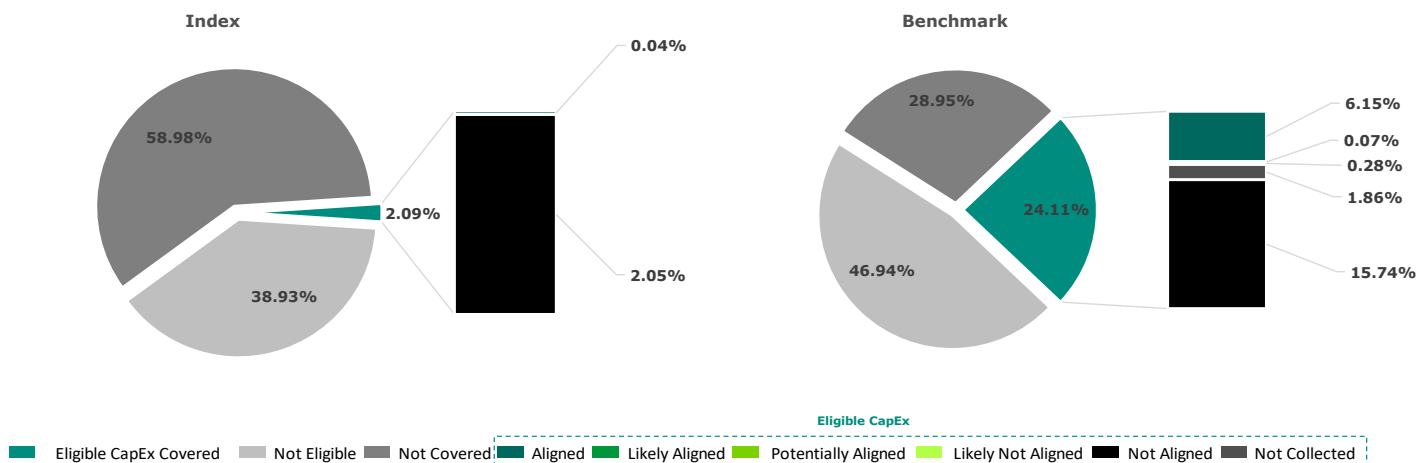

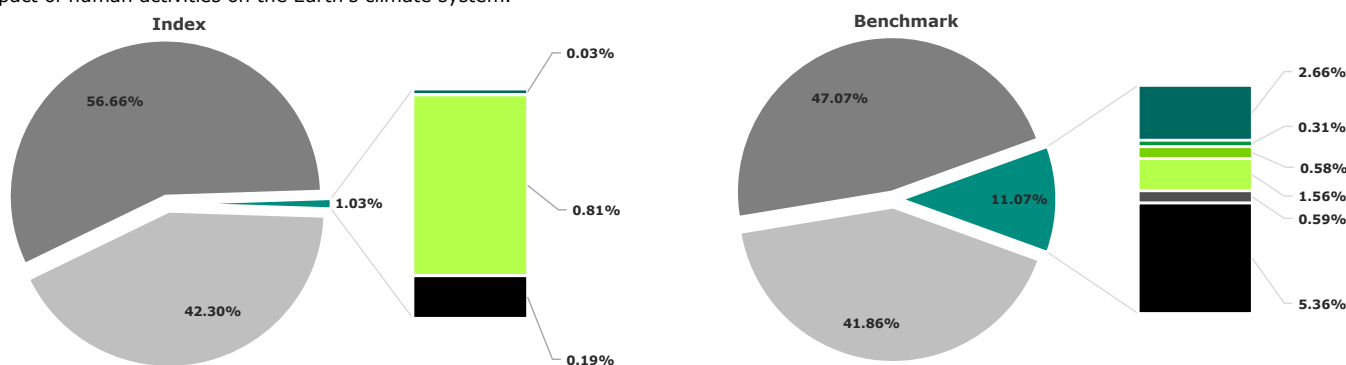
## EU Taxonomy Alignment by pillars

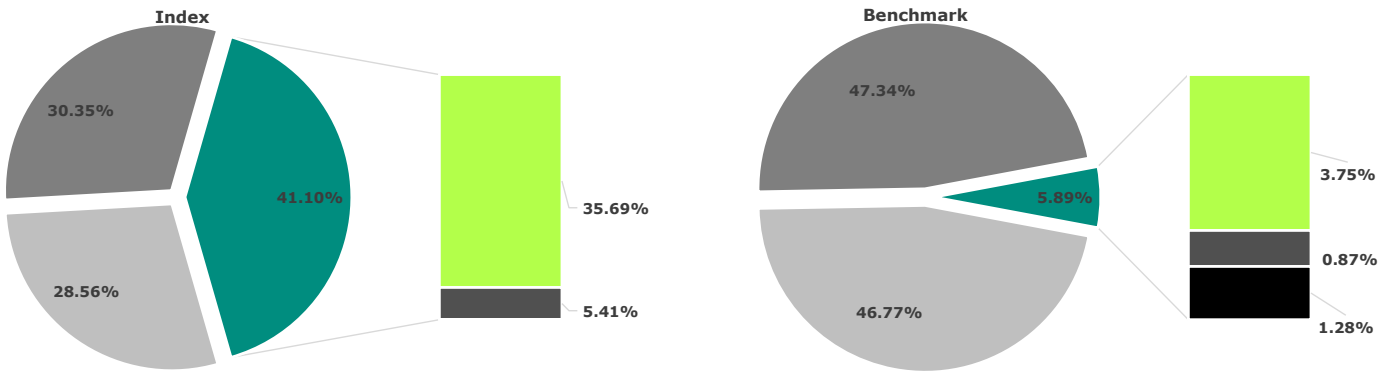
Circular economy

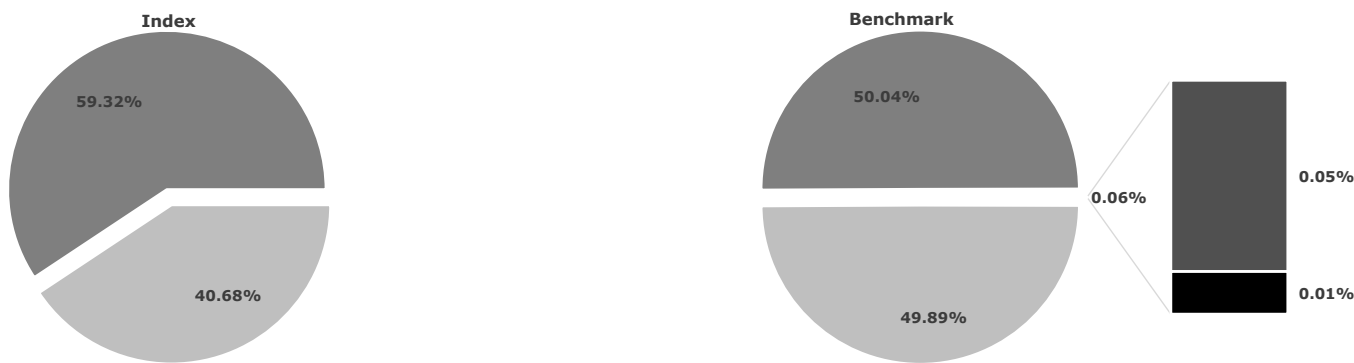
