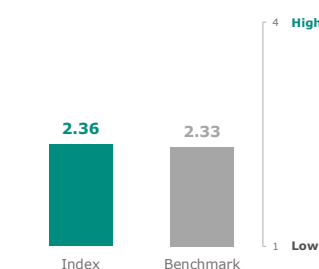

The index serves as a benchmark for biodiversity indices. The index serves as an underlying for structured products, funds, exchange traded funds and futures. 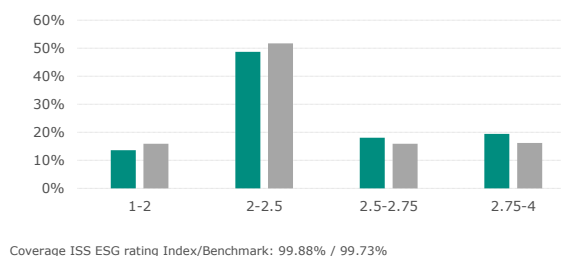

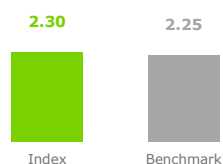
Weighted average ESG rating



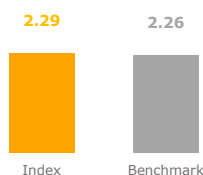
ESG score distribution



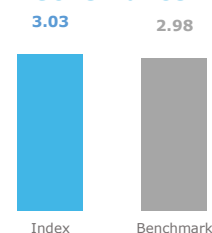

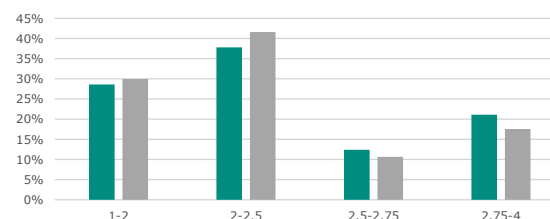

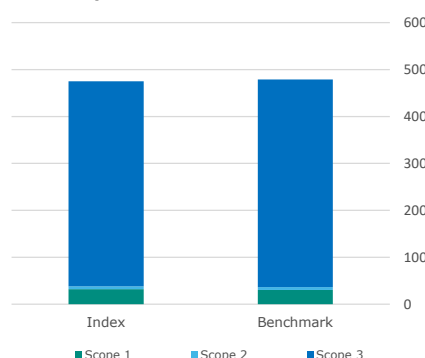
Environmental score distribution



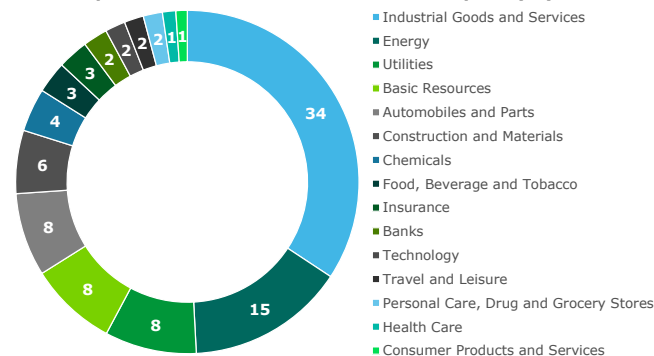

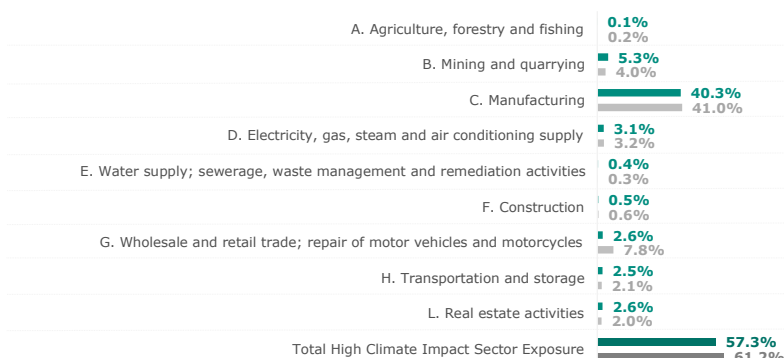
Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 0.82% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 2.85% higher than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 87.91% of the total weight of the index, 89.69% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 64.95% for the index and 66.60% for the benchmark.

The Estimated Trust Score on scope 1,2 is 0.92 for the index and 0.91 for the benchmark. The Reported Trust Score assessing the reliability of issuer-reported emissions data is 0.89 for the index and 0.89 for the benchmark.

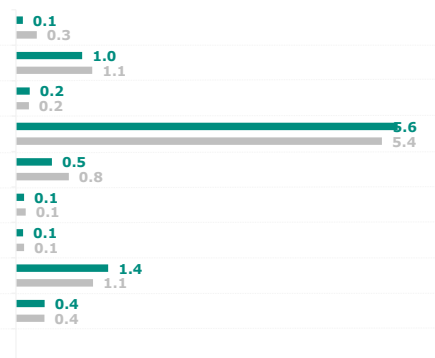

High Climate Impact Sectors Exposure (NACE)



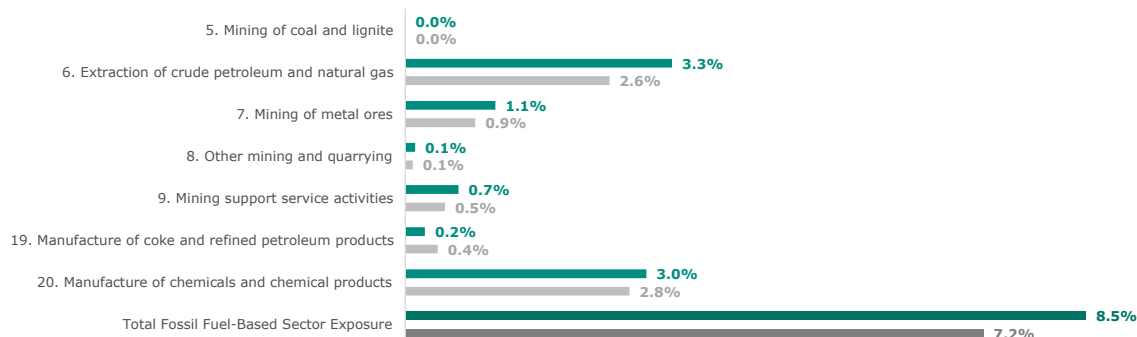

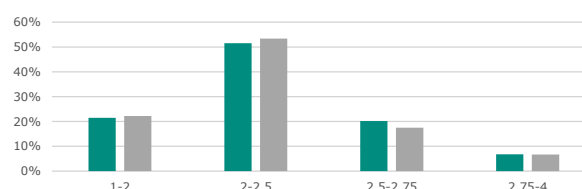

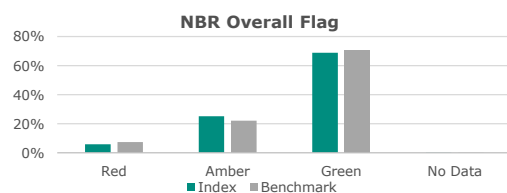

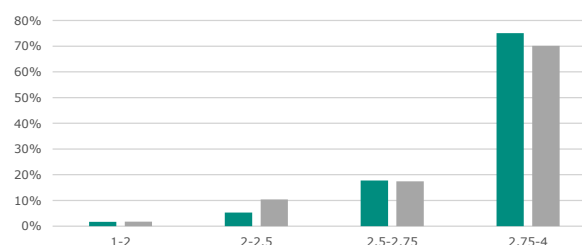

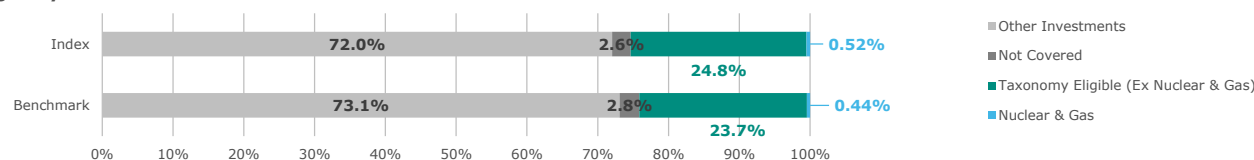
Top Eligible Activities of the Index (%)

Eligibility Breakdown - Nuclear & Gas



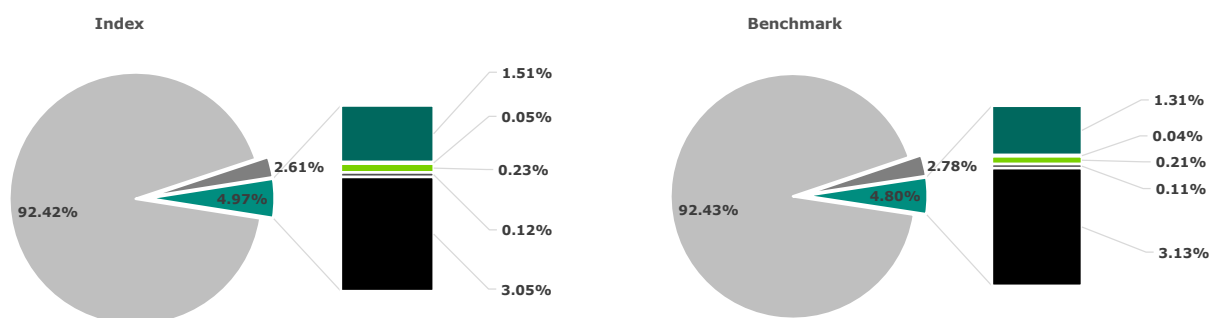
