## Objective

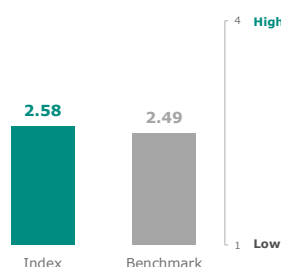

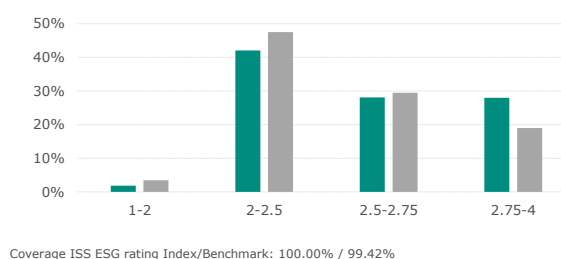

### Weighted average ESG rating



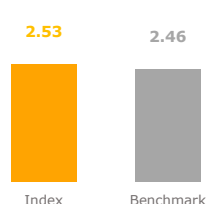
### ESG score distribution



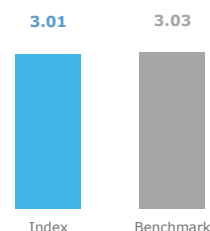

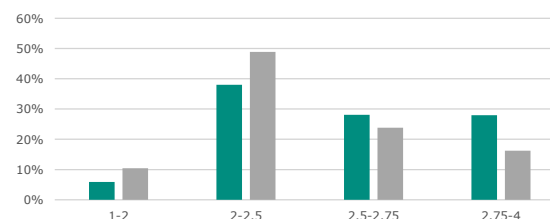

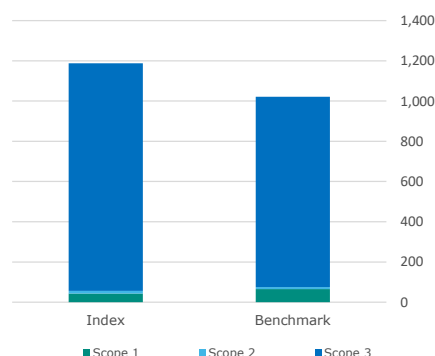
### Environmental score distribution



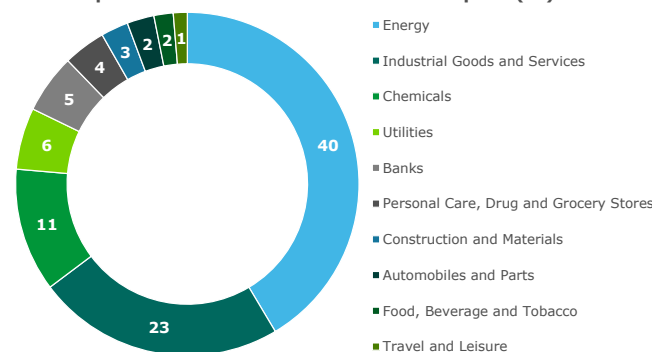

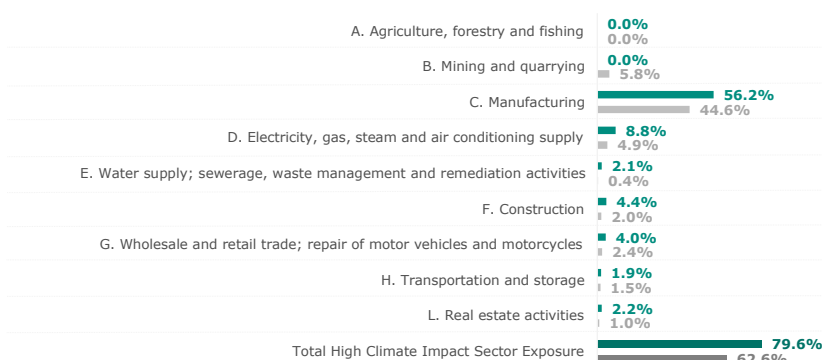
Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 16.36% higher than the benchmark and the GHG intensity scope 1,2,3 of the index is 16.80% higher than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 97.91% of the total weight of the index, 99.05% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 81.76% for the index and 78.50% for the benchmark.

The Estimated Trust Score on scope 1,2 is 0.00 for the index and 0.89 for the benchmark. The Reported Trust Score assessing the reliability of issuer-reported emissions data is 0.92 for the index and 0.92 for the benchmark.

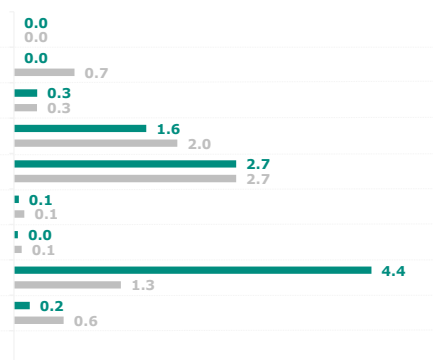

## High Climate Impact Sectors Exposure (NACE)



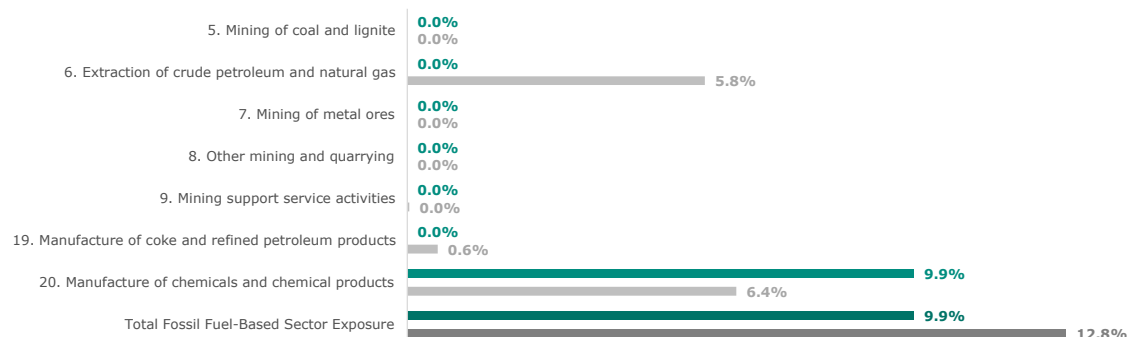

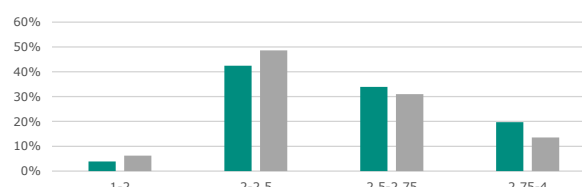

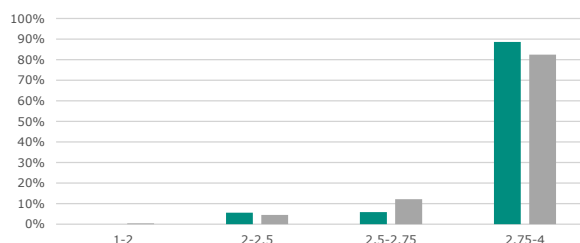

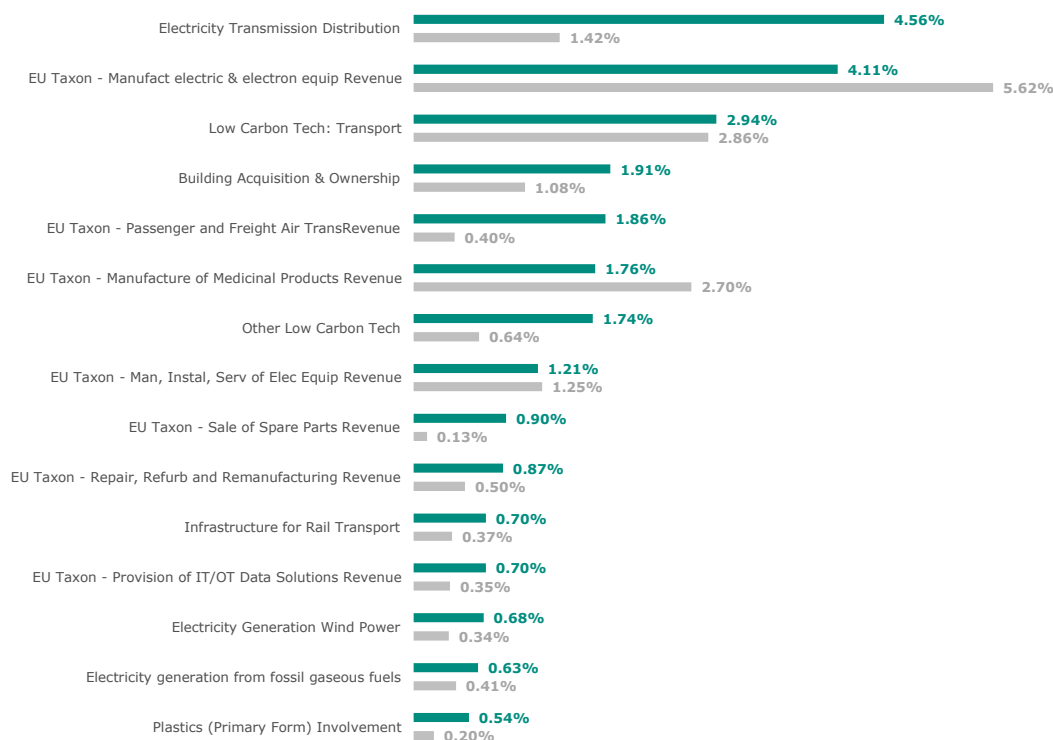

## Eligibility Breakdown - Nuclear & Gas



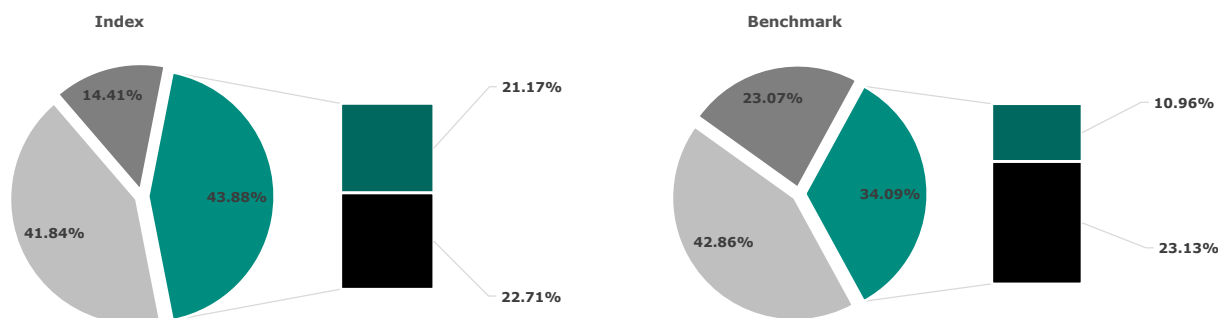
