## Objective

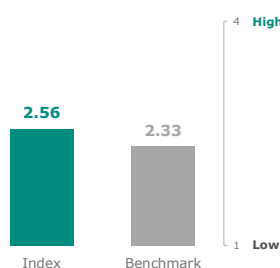
The Euronext® CDP Environment Transatlantic EW index selects all companies included in the 200 Largest US/CA stocks as well as the 200 Largest European stocks which are part of the Euronext® Europe 500 index, in term of free float market capitalisation. The companies that form the index universe are screened on involvement in Controversial Weapons, Military, Civilian Firearms, Tobacco, Pornography and Gambling. After this screening, remaining companies will be ranked on both the Social score as well as the Governance score. The 10% worst companies based on the Social scores, as well as the 10% worst companies based on the Governance score are excluded. The companies that remain will be ranked on their environmental score. Euronext® CDP Environment Transatlantic EW index is an equal-weighted index. The index serves as an underlying for structured products, funds and exchange traded funds. The index rules are available on our website. Euronext acts as Supervisor. 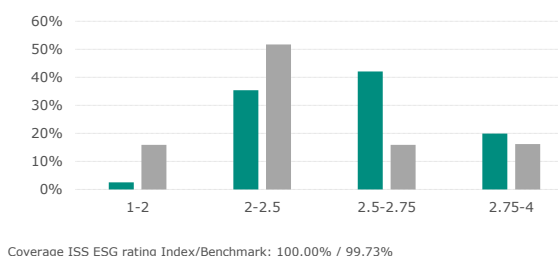

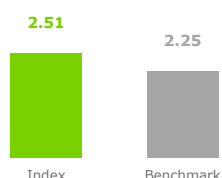
Weighted average ESG rating



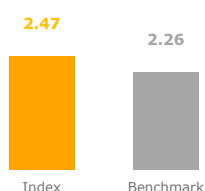
ESG score distribution



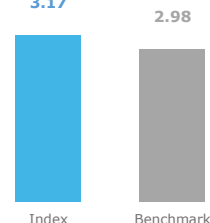

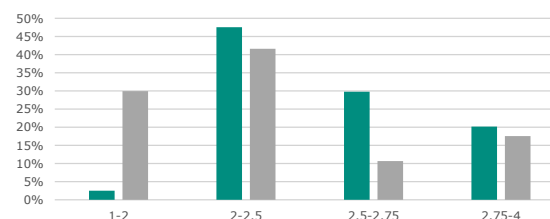

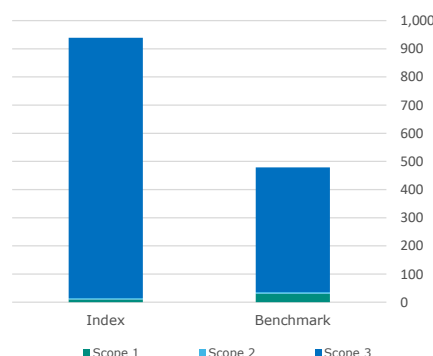
### Environmental score distribution



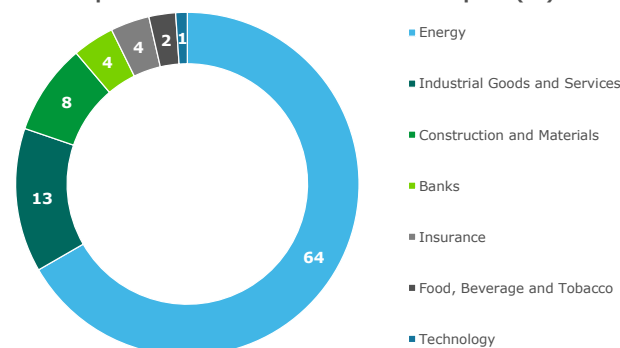

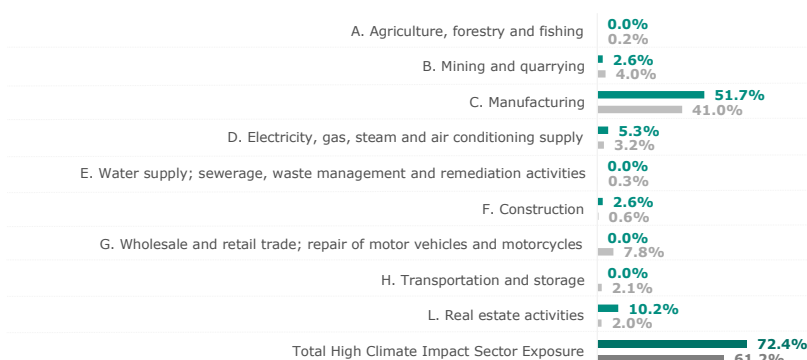
Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 96.00% higher than the benchmark and the GHG intensity scope 1,2,3 of the index is 81.89% higher than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 100.00% of the total weight of the index, 89.69% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 90.16% for the index and 66.60% for the benchmark.

The Estimated Trust Score on scope 1,2 is - for the index and 0.91 for the benchmark. The Reported Trust Score assessing the reliability of issuer-reported emissions data is 0.93 for the index and 0.89 for the benchmark.

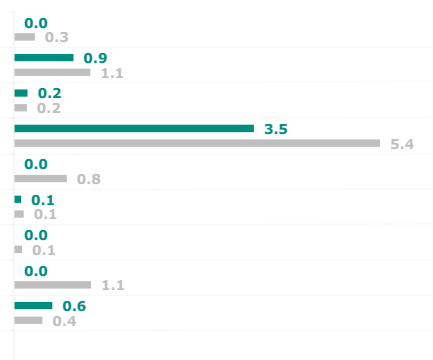

## High Climate Impact Sectors Exposure (NACE)



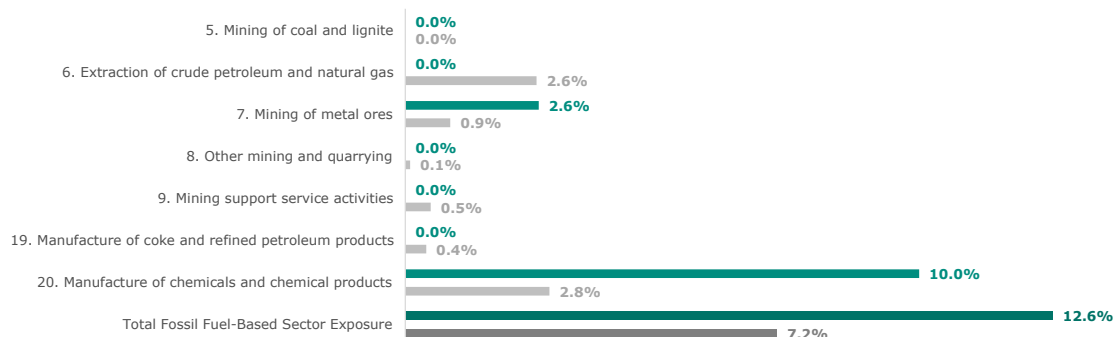

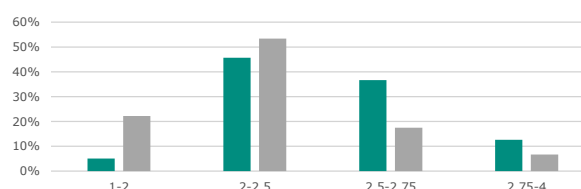

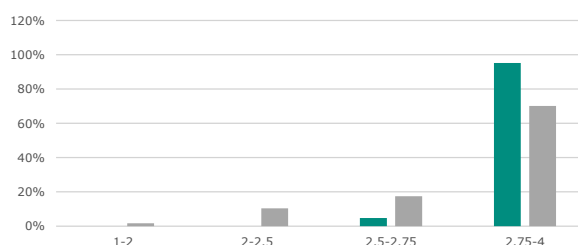

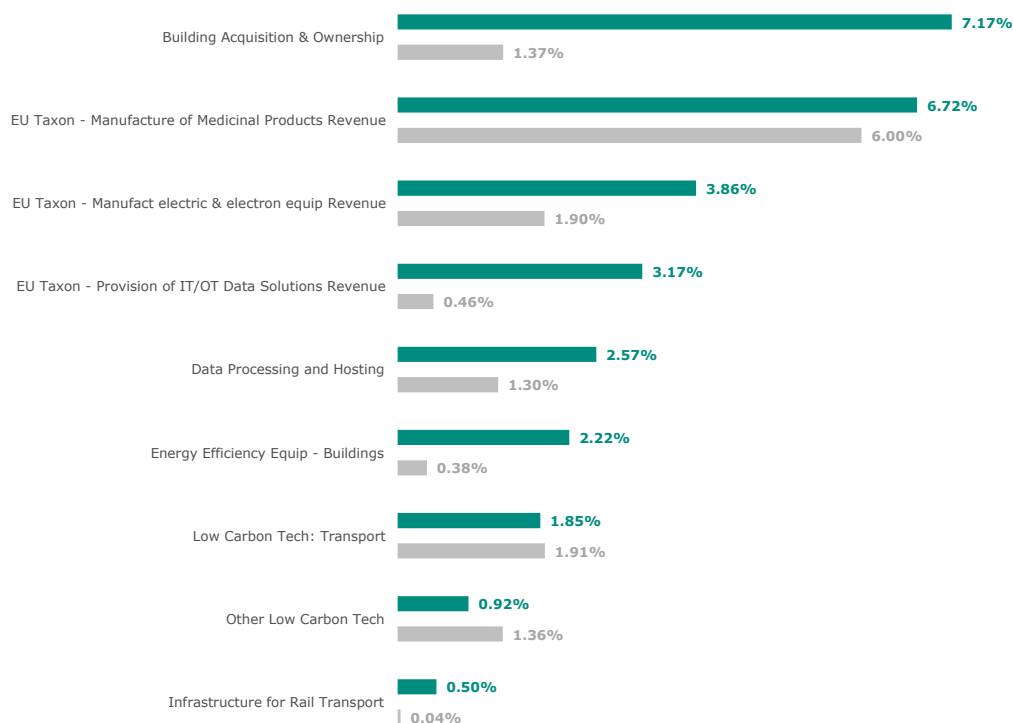

## Eligibility Breakdown - Nuclear & Gas



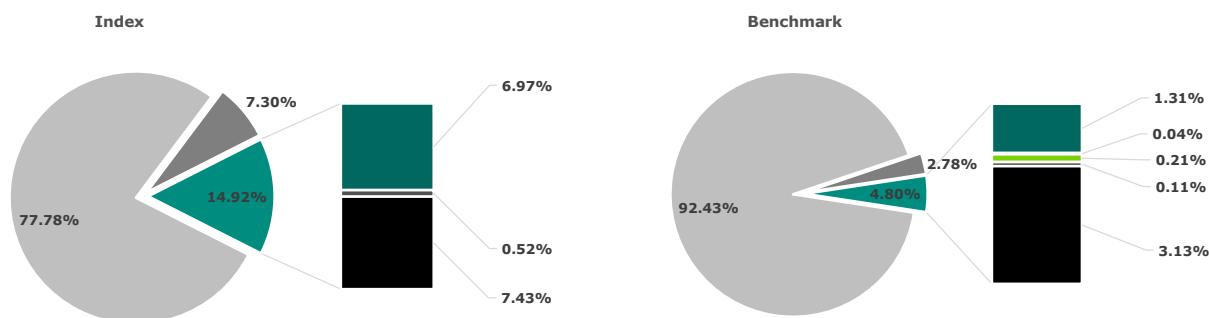
