The ESG scores are provided by CDP and Moody's ESG. Constituents are reviewed once a year and their weights are reset on equally weight quarterly.

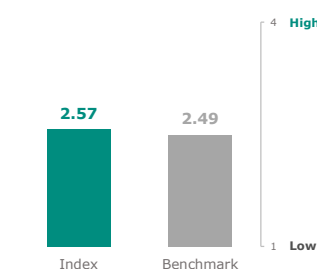

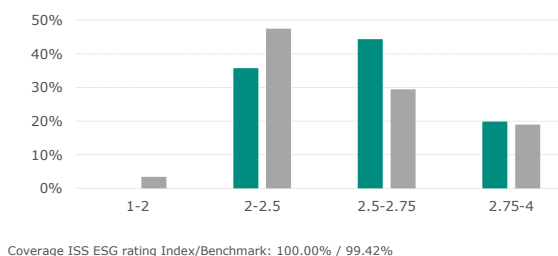

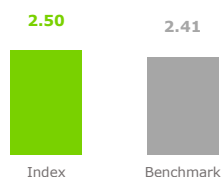
Weighted average ESG rating



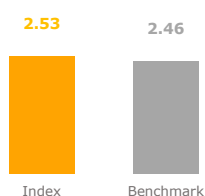
ESG score distribution



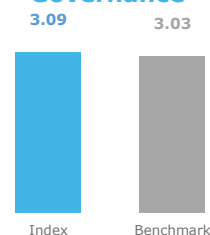

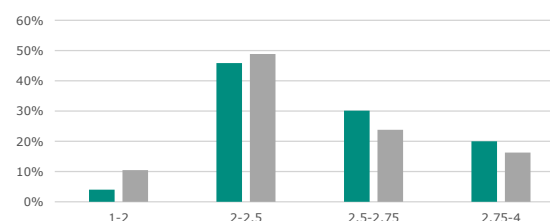

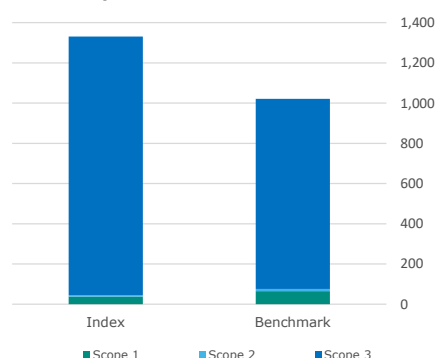
Environmental score distribution



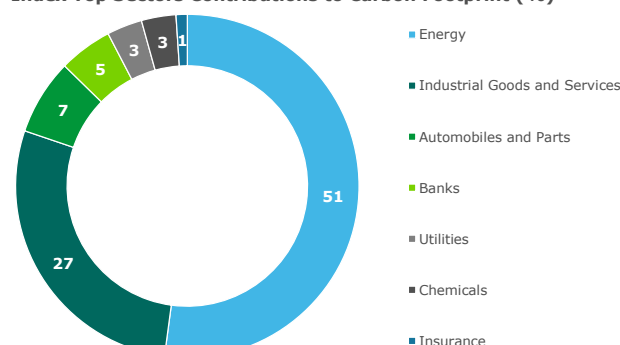

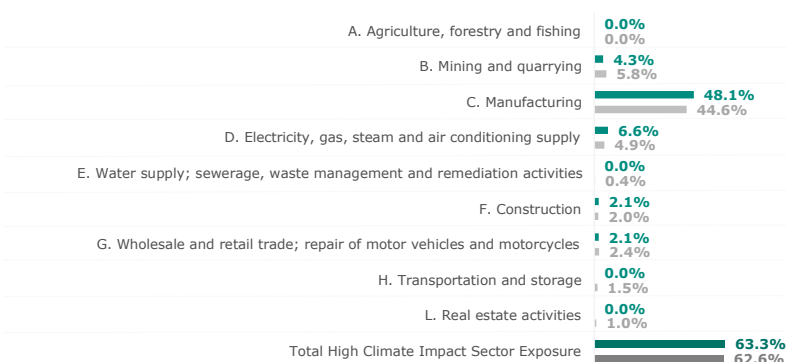
Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 30.32% higher than the benchmark and the GHG intensity scope 1,2,3 of the index is 26.51% higher than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 100.00% of the total weight of the index, 99.05% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 79.88% for the index and 78.50% for the benchmark.

The Estimated Trust Score on scope 1,2 is - for the index and 0.89 for the benchmark. The Reported Trust Score assessing the reliability of issuer-reported emissions data is 0.92 for the index and 0.92 for the benchmark.

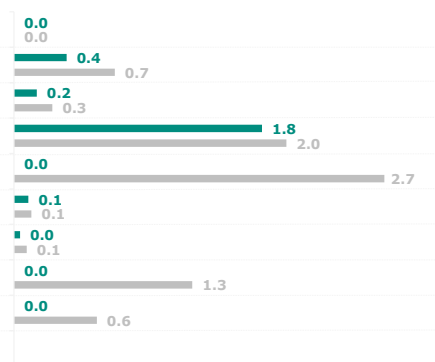

High Climate Impact Sectors Exposure (NACE)



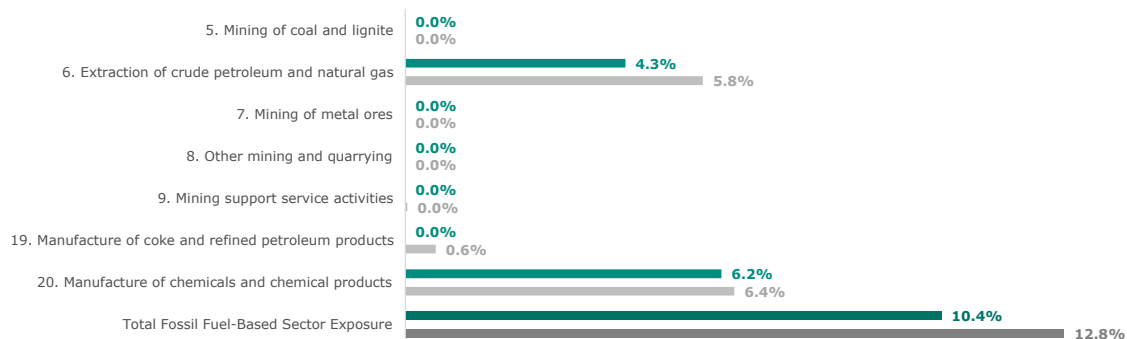

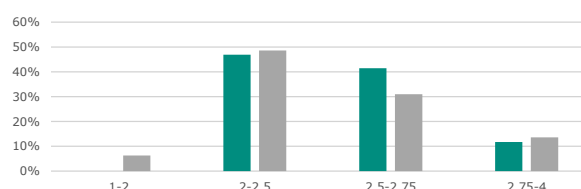

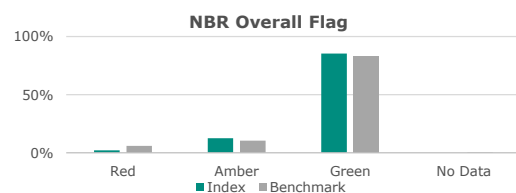

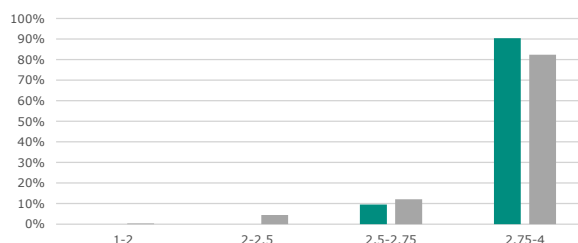

Total Monetary Losses from Corruption














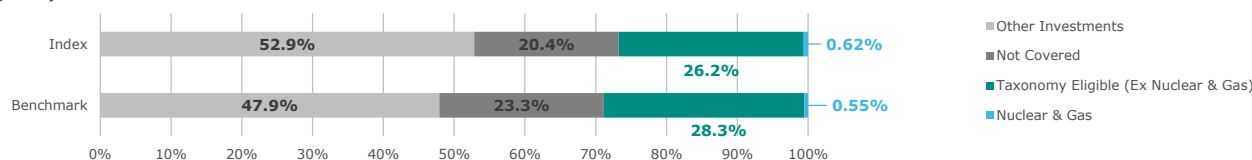
Top Eligible Activities of the Index (%)
