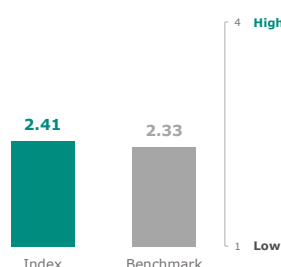

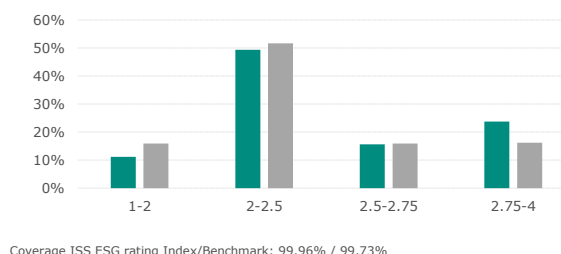

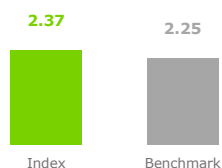
**Weighted average ESG rating**



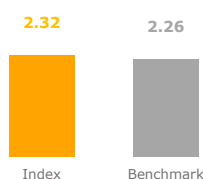
**ESG score distribution**



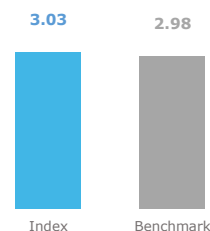

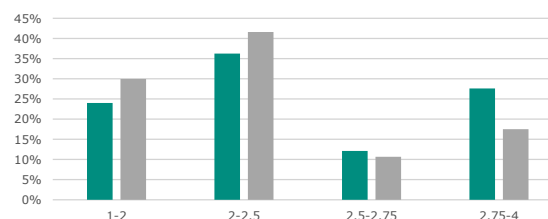

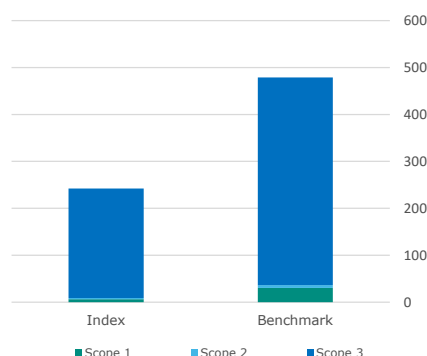
### Environmental score distribution



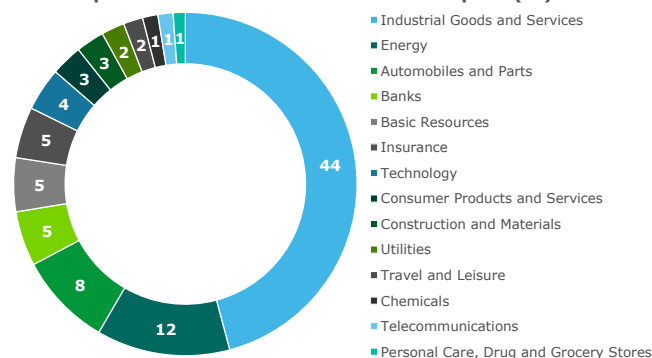

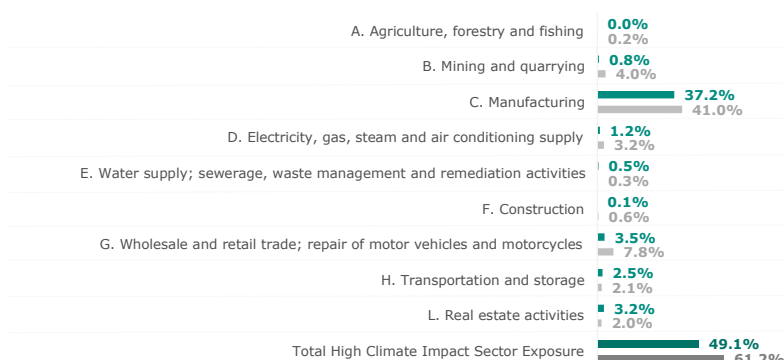
Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 49.41% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 39.43% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 87.69% of the total weight of the index, 89.69% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 68.77% for the index and 66.60% for the benchmark.

The Estimated Trust Score on scope 1,2 is 0.91 for the index and 0.91 for the benchmark. The Reported Trust Score assessing the reliability of issuer-reported emissions data is 0.88 for the index and 0.89 for the benchmark.

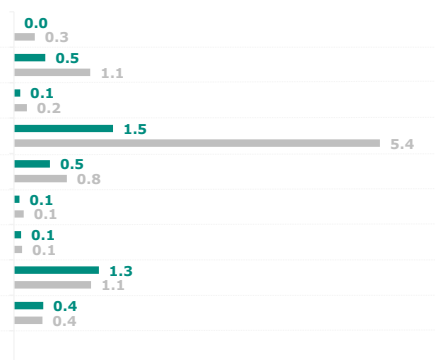

## High Climate Impact Sectors Exposure (NACE)



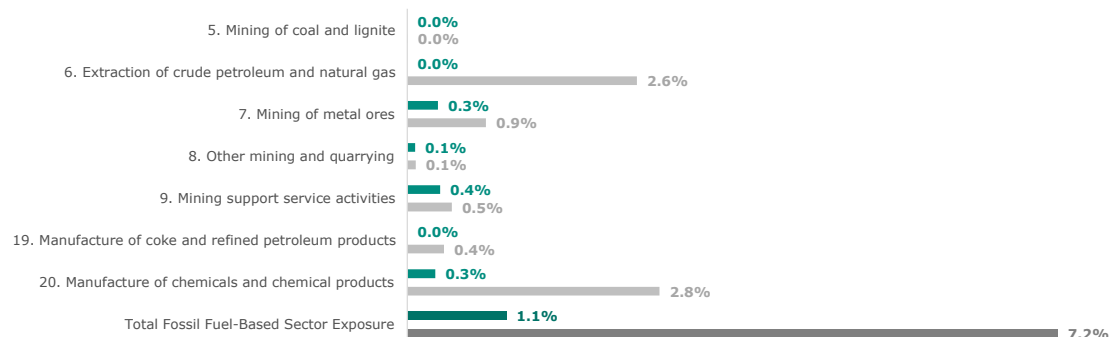
## Energy Consumption per High Climate Impact Sectors

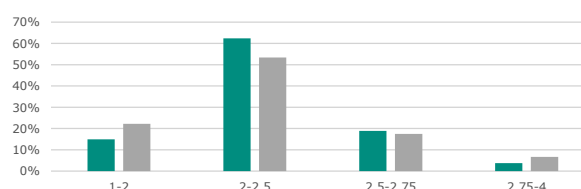

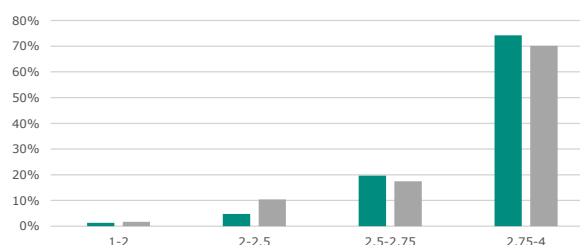

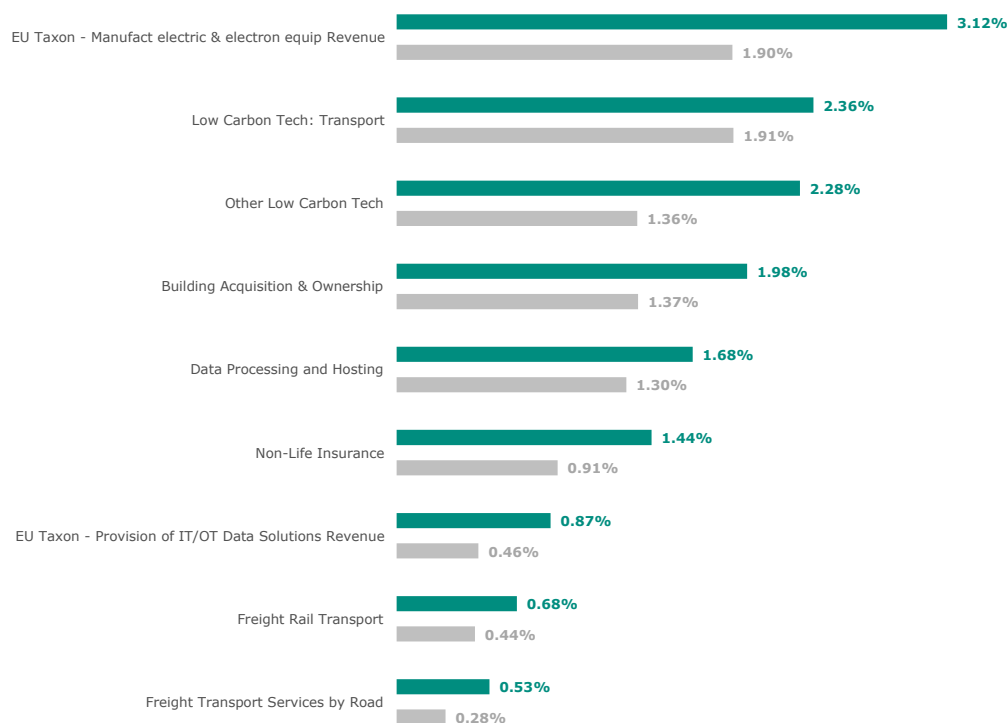

### Top Eligible Activities of the Index (%)

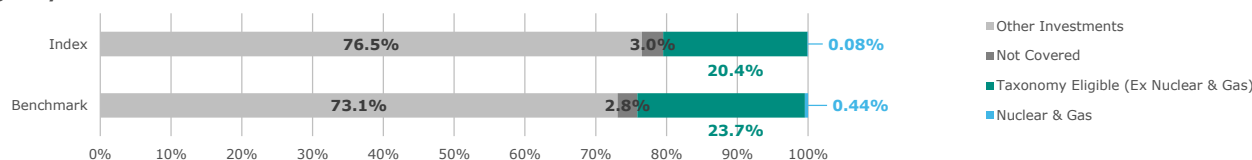
