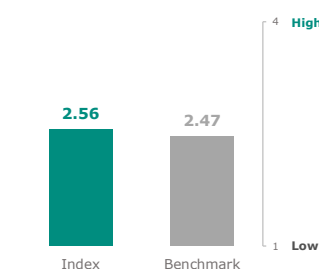
The Euronext® Europe SBT 1.5 index is a free float market capitalisation weighted index that reflects the performance of companies from the Euronext® Europe 500 index with approved Science Based Targets 1.5°C on Scope 1 & 2 and below 2°C on Scope 3. The index also excludes companies involved in controversial activities, tobacco, controversial weapons, thermal coal extraction; shale energy, oil sands and arctic oil & gas extraction; or assessed Non-Compliant with regards to the UN Global Compact principles. The index is powered by SBTi, a partnership between CDP, the United Nations Global Compact, World Resources Institute (WRI) and the World Wide Fund for Nature (WWF). The index serves as an underlying for structured products, funds, exchange traded funds, options and futures. The index rules are available on our website. Euronext acts as Supervisor. 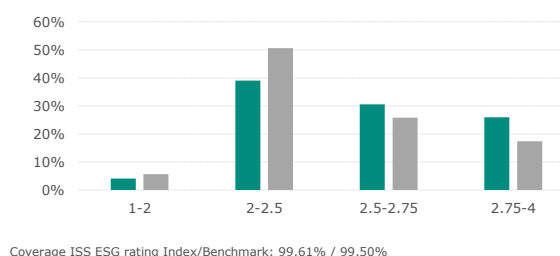

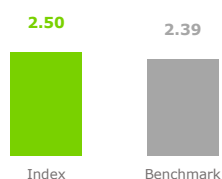
Weighted average ESG rating



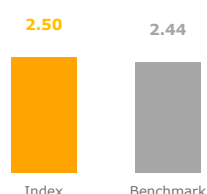
ESG score distribution



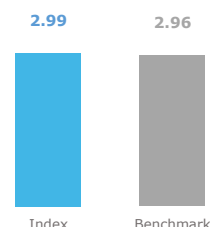

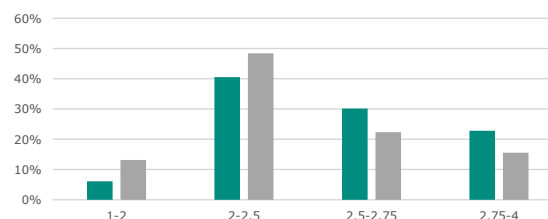

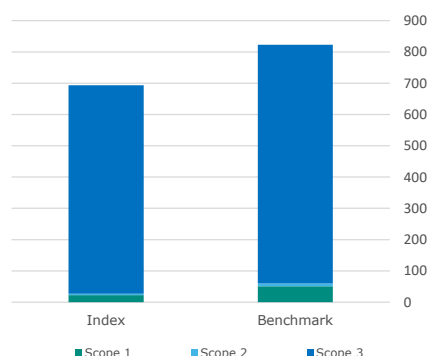
Environmental score distribution



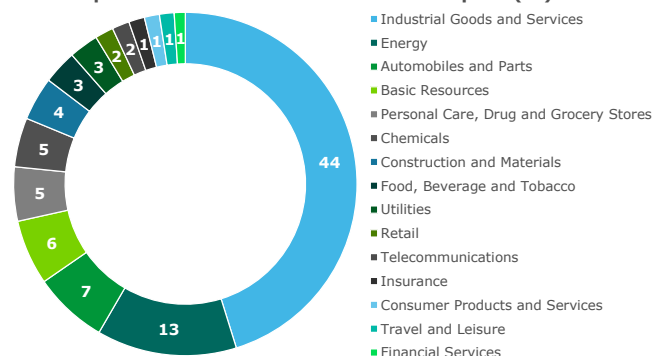

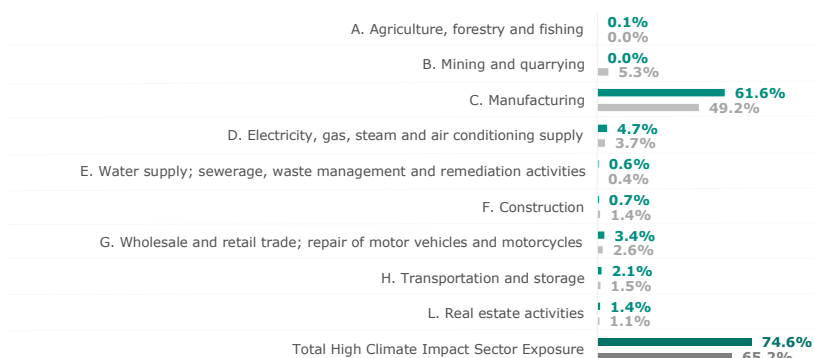
Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 15.78% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 1.29% higher than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 99.77% of the total weight of the index, 99.32% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 82.28% for the index and 78.69% for the benchmark.

The Estimated Trust Score on scope 1,2 is 0.00 for the index and 0.92 for the benchmark. The Reported Trust Score assessing the reliability of issuer-reported emissions data is 0.94 for the index and 0.92 for the benchmark.

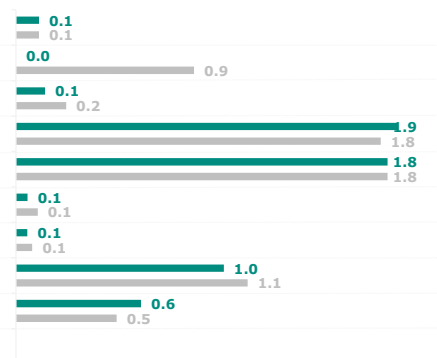

High Climate Impact Sectors Exposure (NACE)



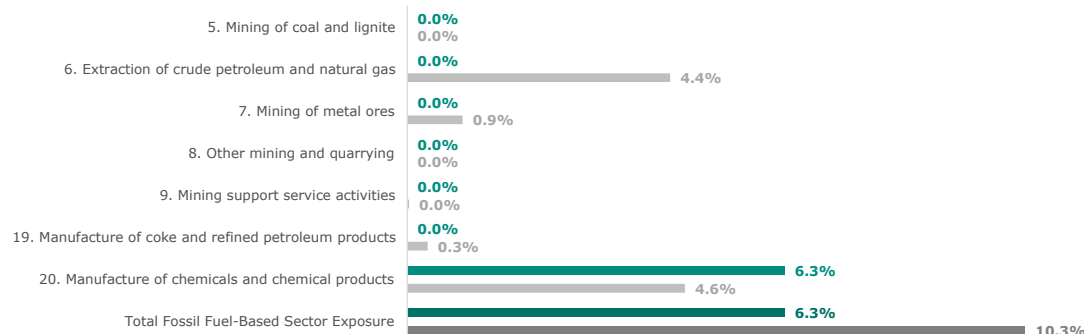

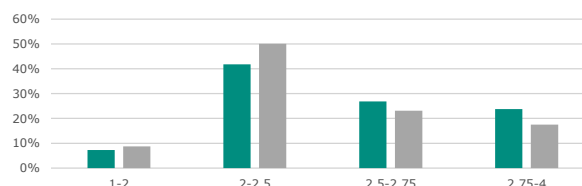

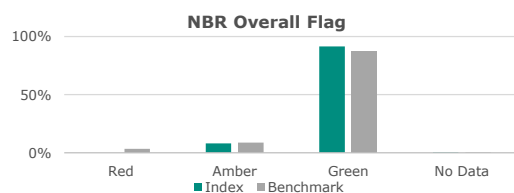

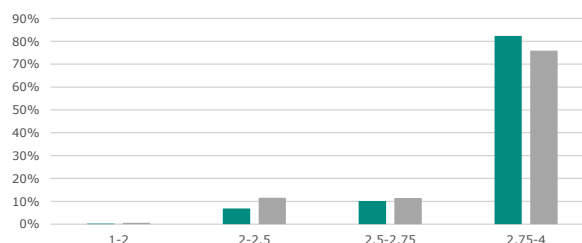

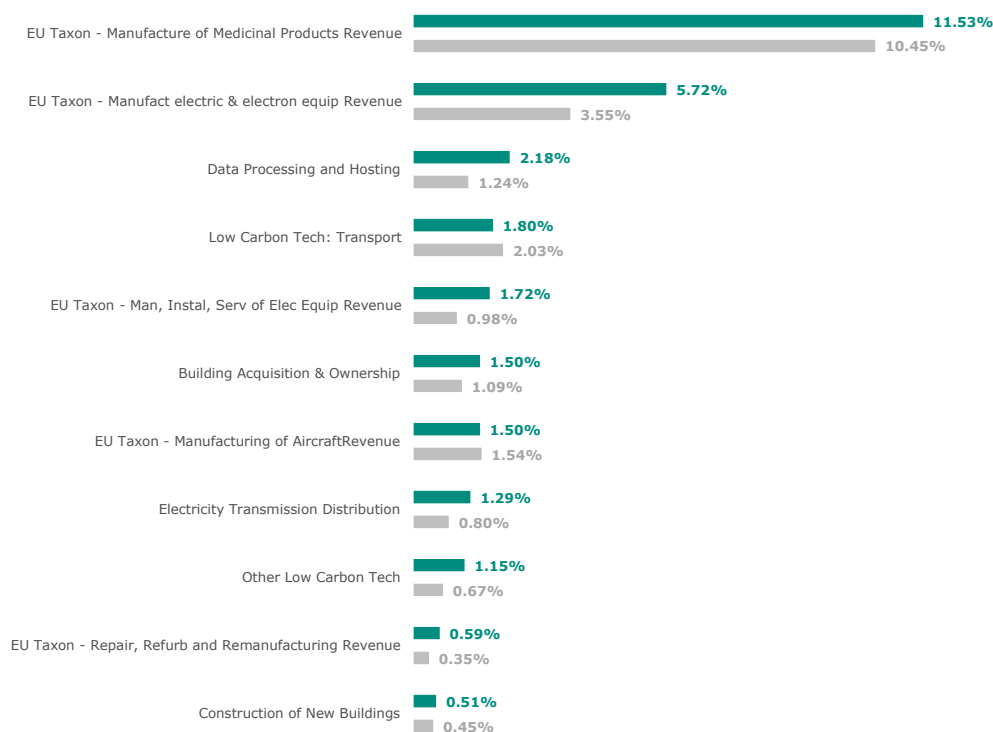

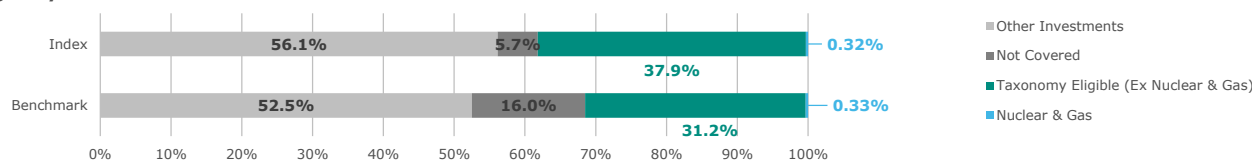
Top Eligible Activities of the Index (%)

Eligibility Breakdown - Nuclear & Gas



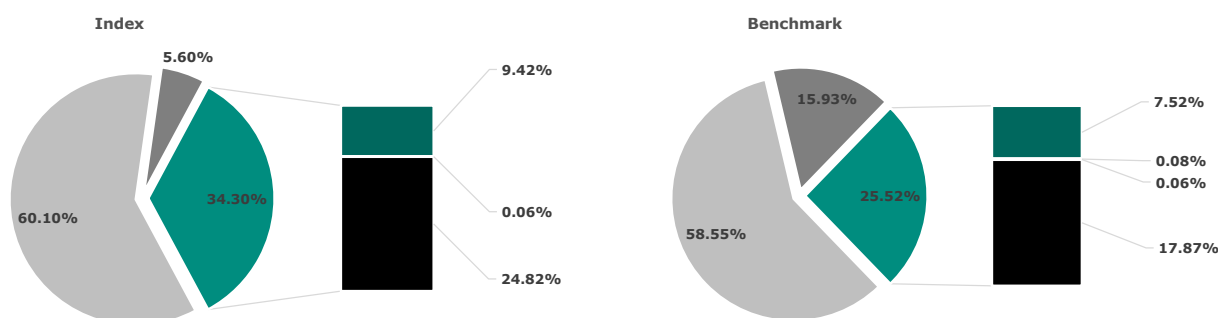
