Objective

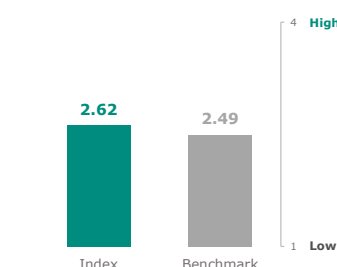
The Euronext Eurozone ESG Large 80 is a free float market capitalisation index that includes the top Energy Transition scored companies within each sector of the Euronext Eurozone 300 index. The index excludes companies with a critical UNGC controversies as well as the 20% worst companies in term of Social and Governance scores, companies involved in coal, tobacco or weapons. The scores are provided by Moody's ESG. The index serves as an underlying for structured products, funds, derivatives and exchange traded funds. The index rules are available on our website. 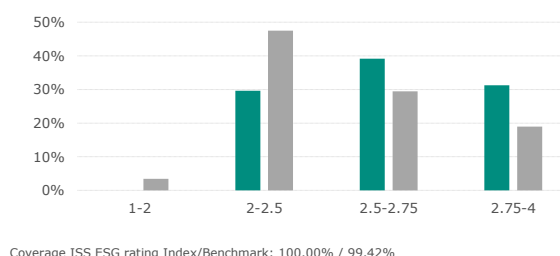

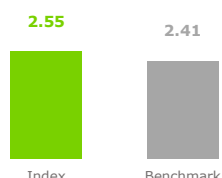
Weighted average ESG rating



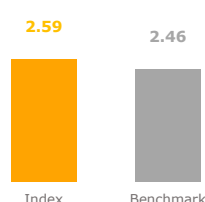
ESG score distribution



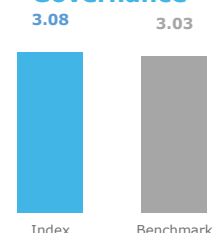

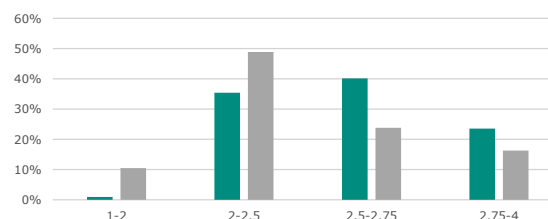

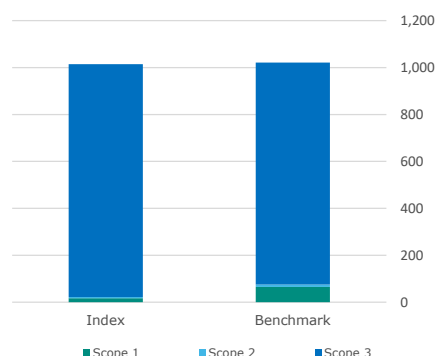
Environmental score distribution



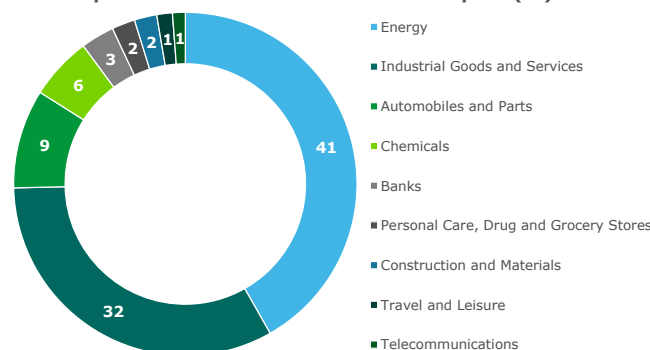

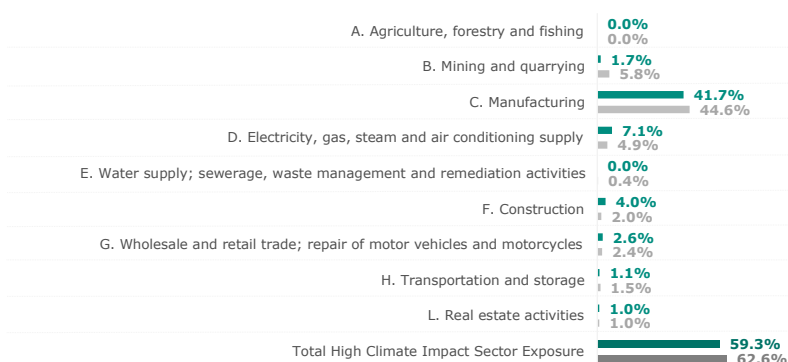
Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 0.64% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 12.13% higher than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 99.50% of the total weight of the index, 99.05% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 82.75% for the index and 78.50% for the benchmark.

The Estimated Trust Score on scope 1,2 is 0.00 for the index and 0.89 for the benchmark. The Reported Trust Score assessing the reliability of issuer-reported emissions data is 0.95 for the index and 0.92 for the benchmark.

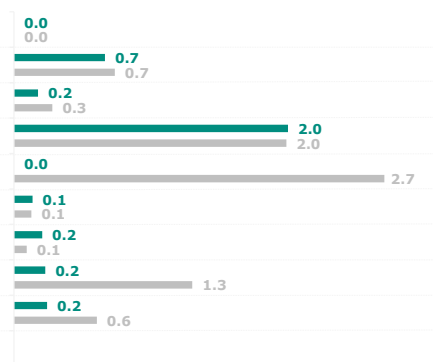

High Climate Impact Sectors Exposure (NACE)



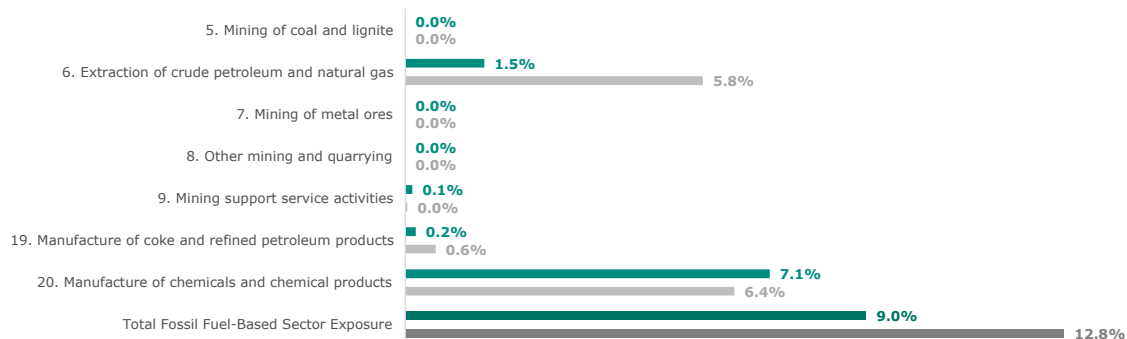

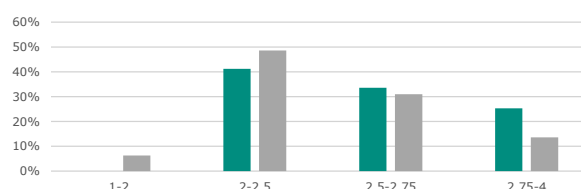

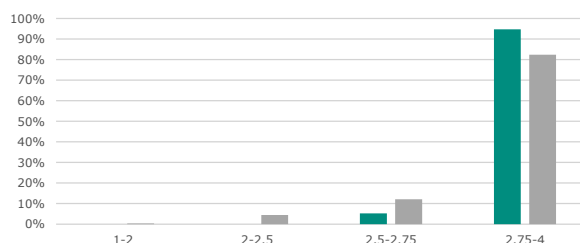

Total Monetary Losses from Corruption














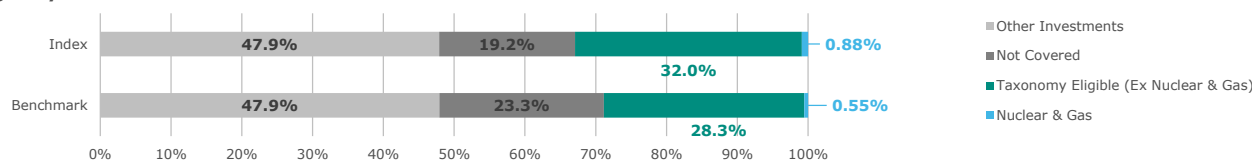
Top Eligible Activities of the Index (%)
