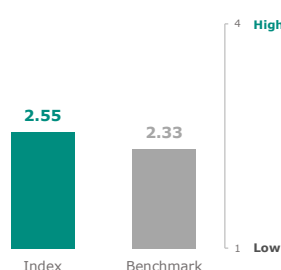

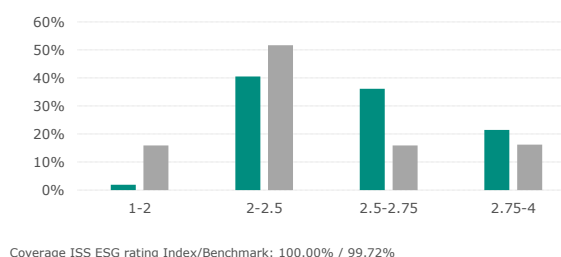

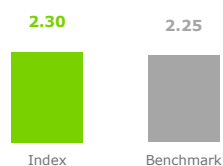
**Weighted average ESG rating**



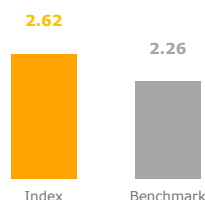
**ESG score distribution**



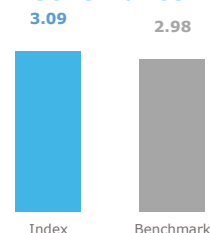

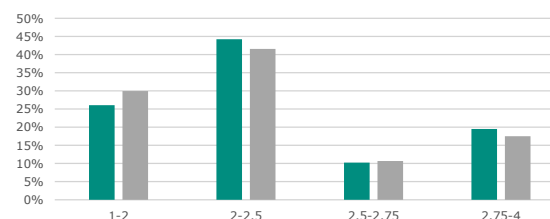

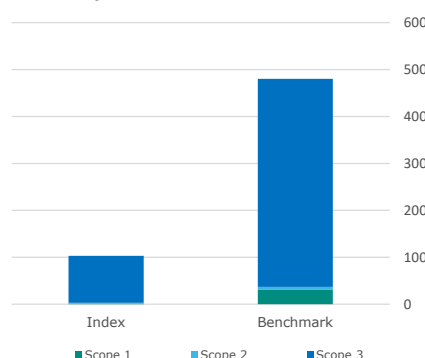

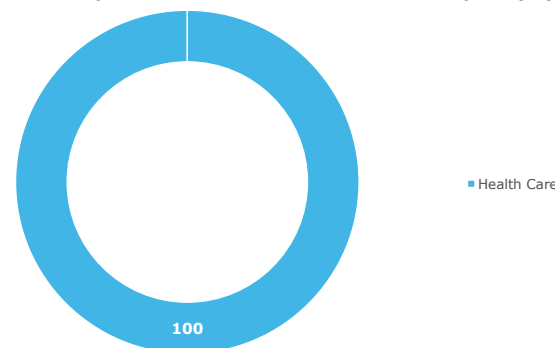

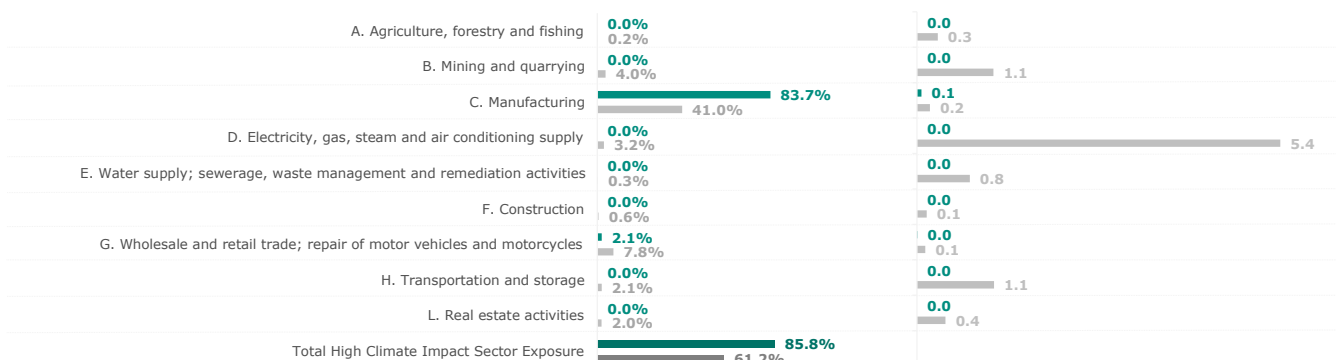
Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 78.56% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 79.44% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 93.69% of the total weight of the index, 89.70% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 61.40% for the index and 66.59% for the benchmark.

The Estimated Trust Score on scope 1,2 is 0.00 for the index and 0.91 for the benchmark. The Reported Trust Score assessing the reliability of issuer-reported emissions data is 0.88 for the index and 0.89 for the benchmark.

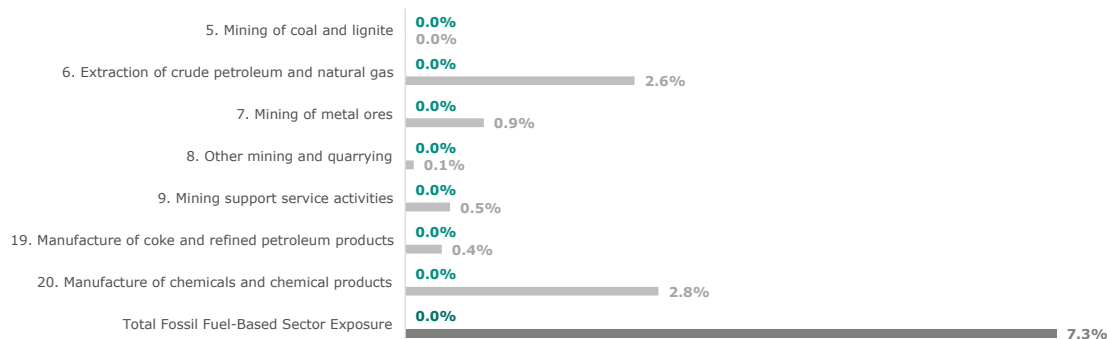
## High Climate Impact Sectors Exposure (NACE)

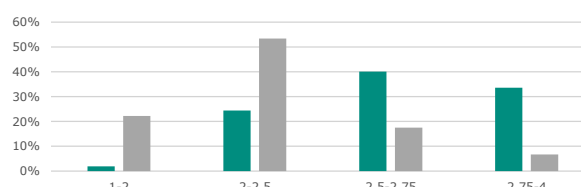

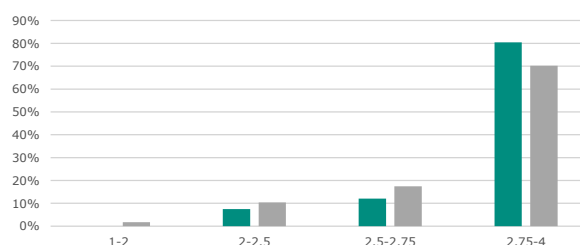

## Eligibility Breakdown - Nuclear & Gas



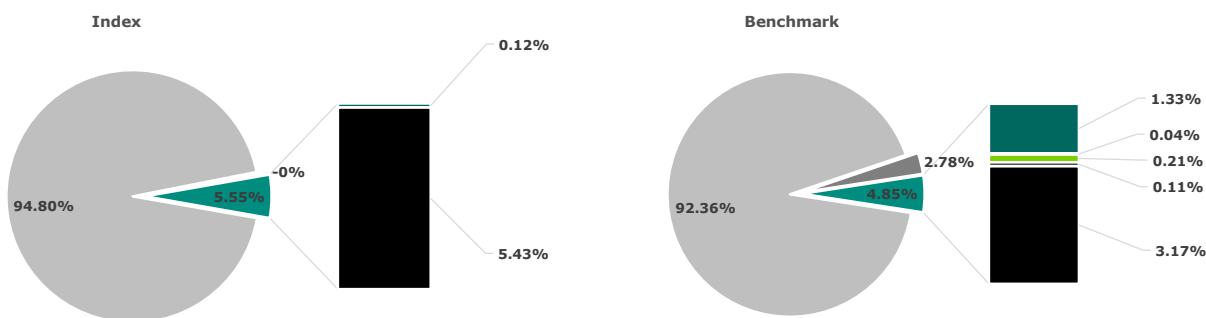
