## Objective

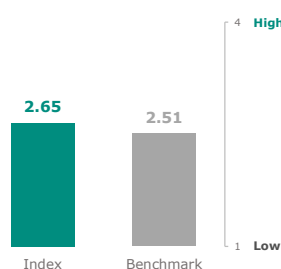

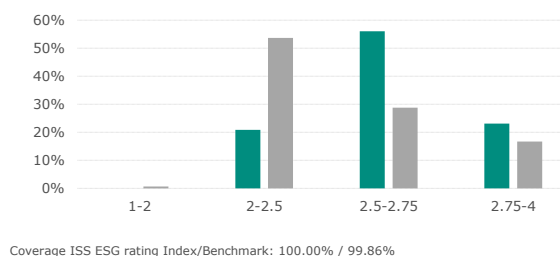

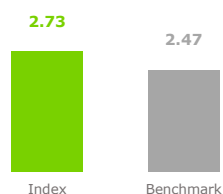
Weighted average ESG rating



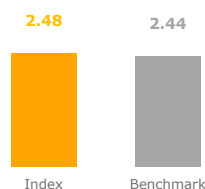
ESG score distribution



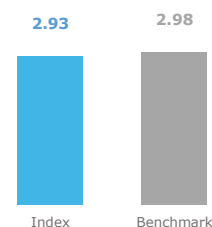

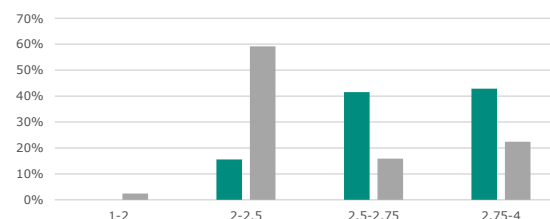

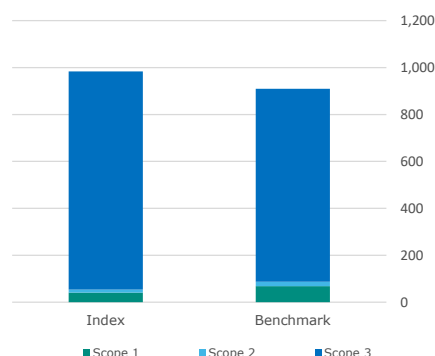
### Environmental score distribution



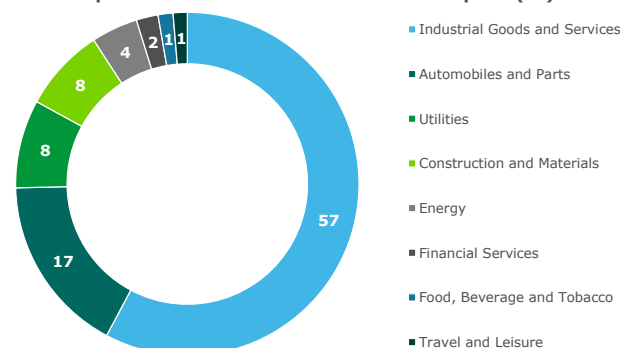

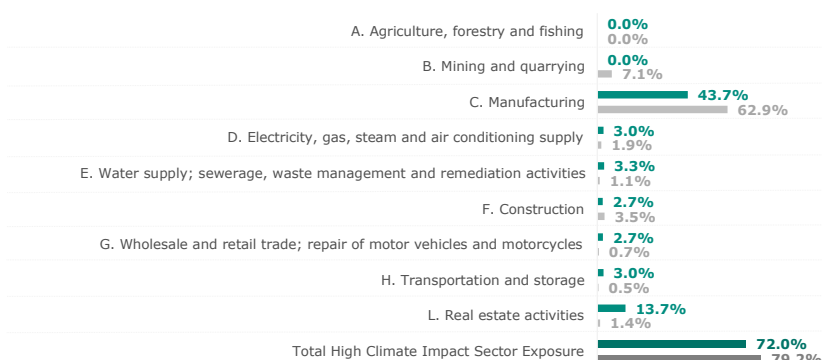
Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 8.11% higher than the benchmark and the GHG intensity scope 1,2,3 of the index is 10.87% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 100.00% of the total weight of the index, 99.15% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 88.53% for the index and 80.72% for the benchmark.

The Estimated Trust Score on scope 1,2 is - for the index and 0.94 for the benchmark. The Reported Trust Score assessing the reliability of issuer-reported emissions data is 0.91 for the index and 0.94 for the benchmark.

## High Climate Impact Sectors Exposure (NACE)



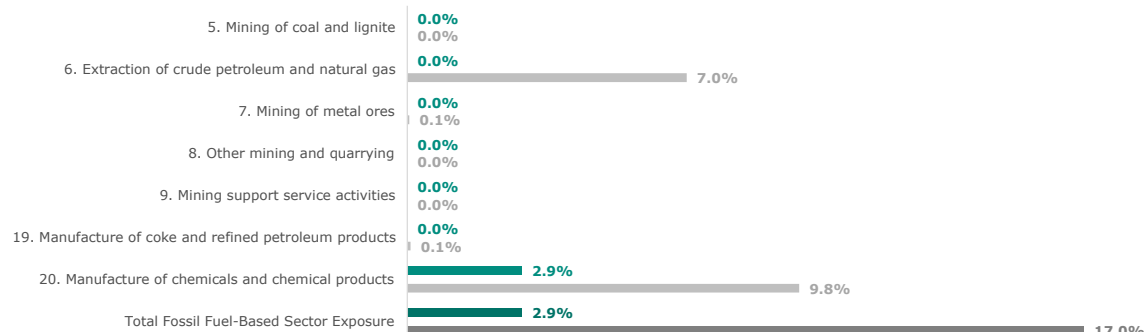
## Energy Consumption per High Climate Impact Sectors

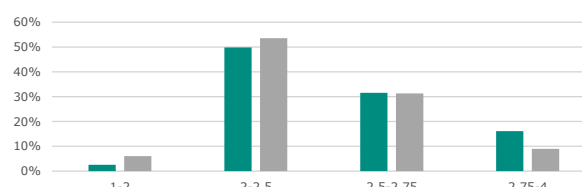

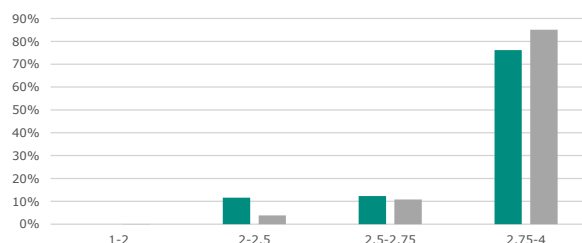

## Eligibility Breakdown - Nuclear & Gas



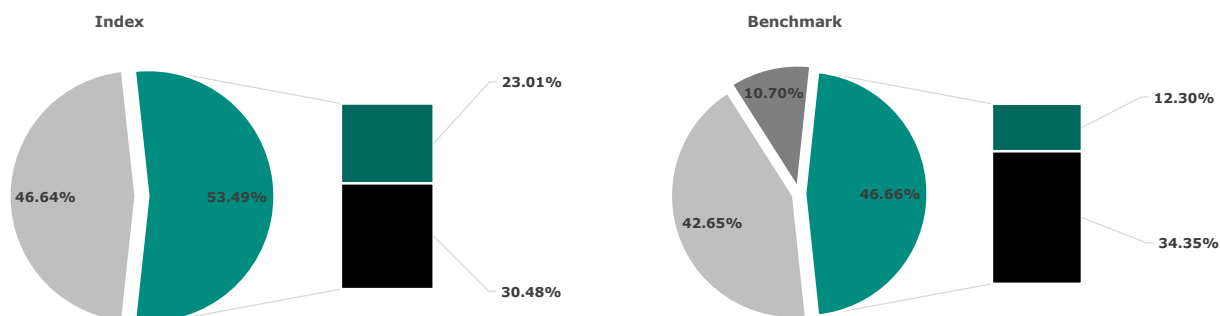
