Objective

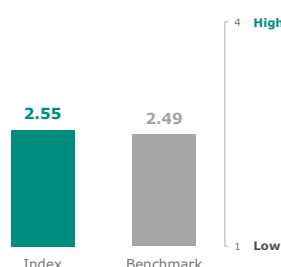
The Euronext® Sustainable Euro 120 index consists of companies included in the Eurozone Equities Universe, covering the 500 issuers amongst the largest free-float market capitalisations in the Eurozone. Companies may be excluded if their level of commitment is insufficient with regard to their overall score or their score in one of six key areas reviewed in the Equities methodology or are subject to serious, proved, or recurrent controversies. Then 120 highest ranking companies are selected according to their overall Equities score. The index is Non-Market capitalisation weighted, weighting are based on the overall Equities scores. The index serves as an underlying for structured products, funds and exchange traded funds. The index rules are available on our website. Euronext acts as Supervisor. 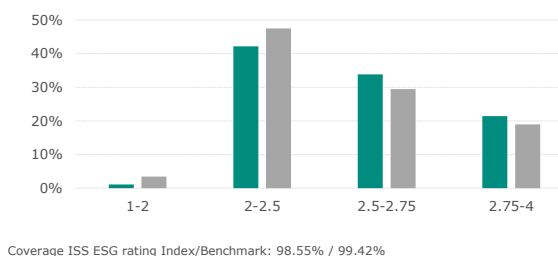

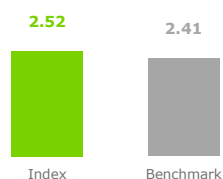
Weighted average ESG rating



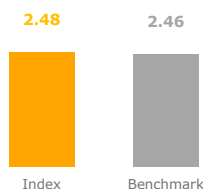
ESG score distribution



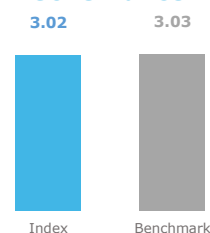

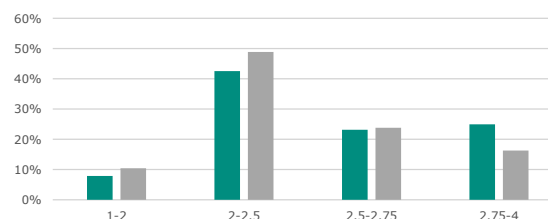

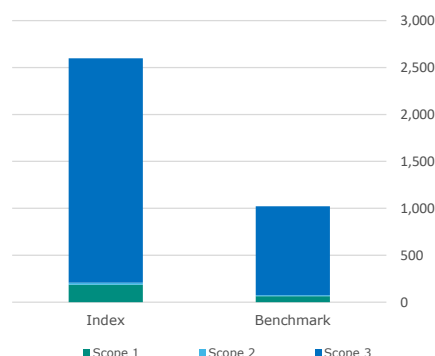
Environmental score distribution



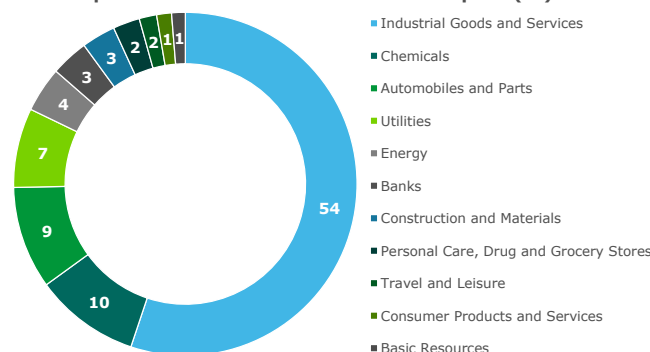

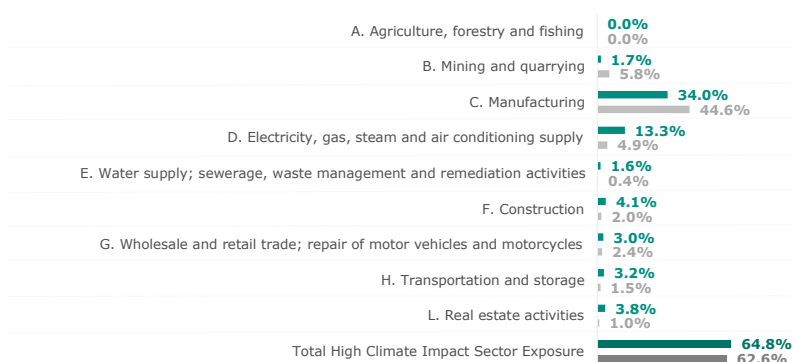
Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 154.54% higher than the benchmark and the GHG intensity scope 1,2,3 of the index is 3.34% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 98.13% of the total weight of the index, 99.05% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 84.08% for the index and 78.50% for the benchmark.

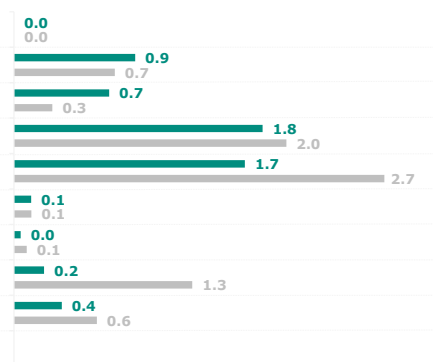

High Climate Impact Sectors Exposure (NACE)



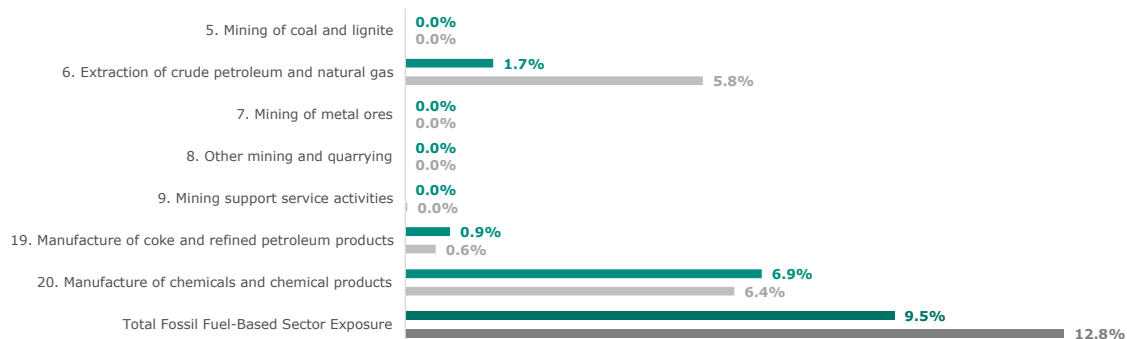

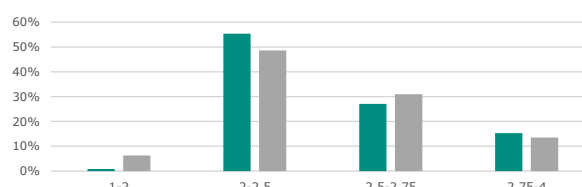

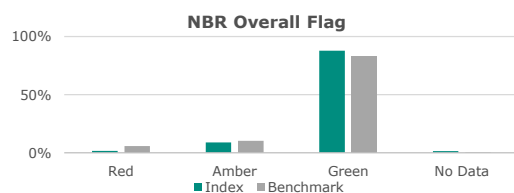

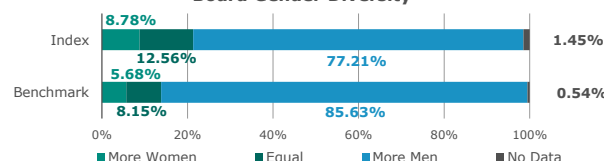

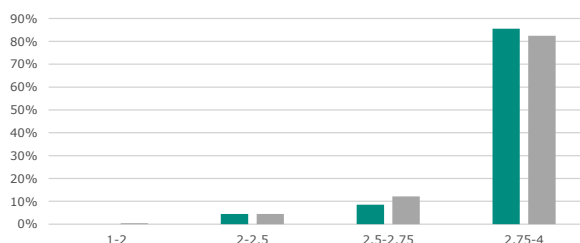

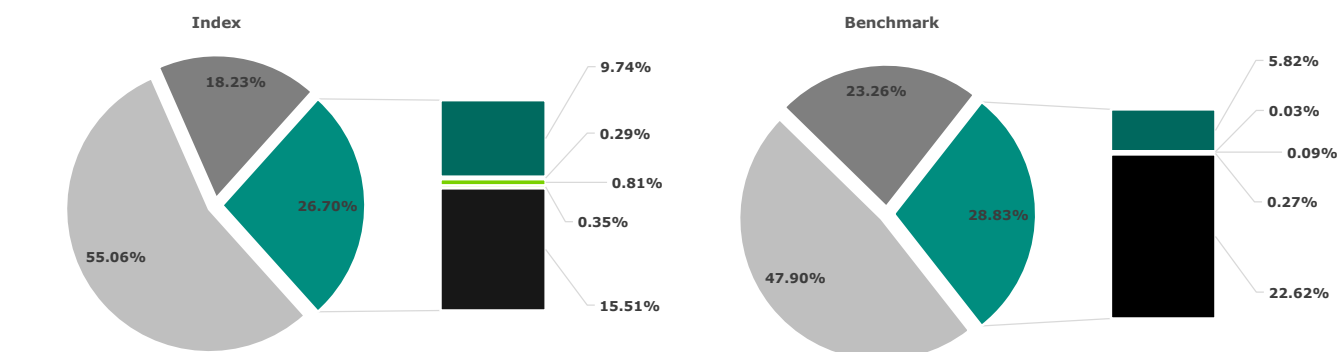

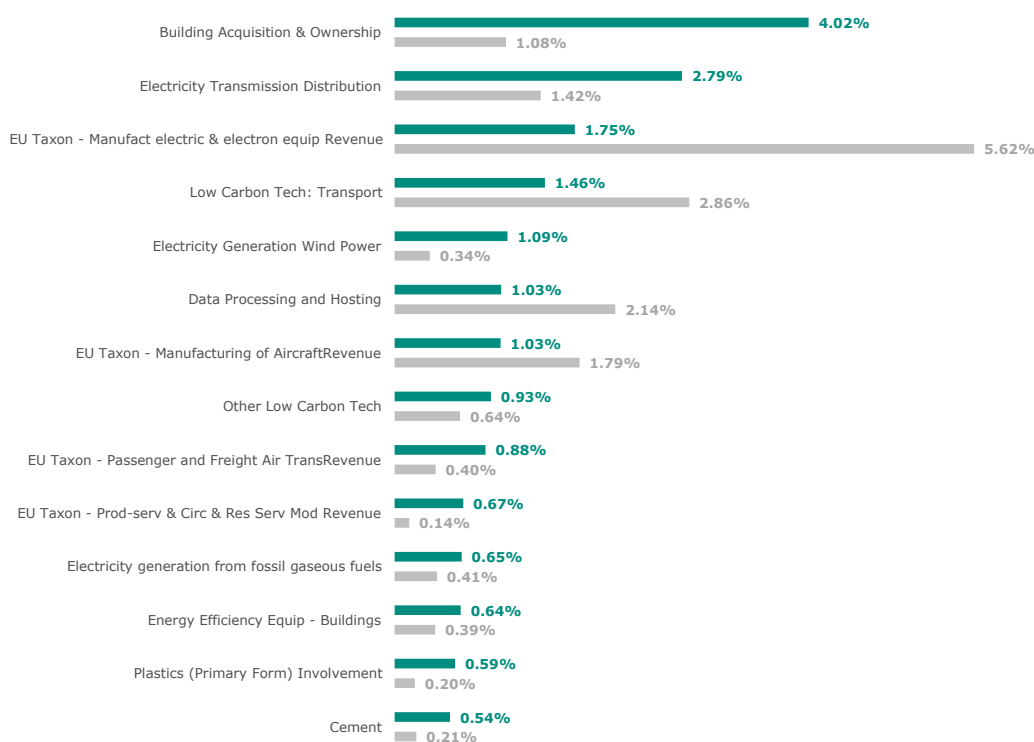

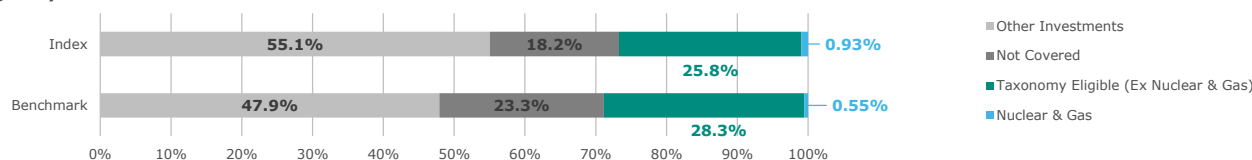
Top Eligible Activities of the Index (%)

Eligibility Breakdown - Nuclear & Gas



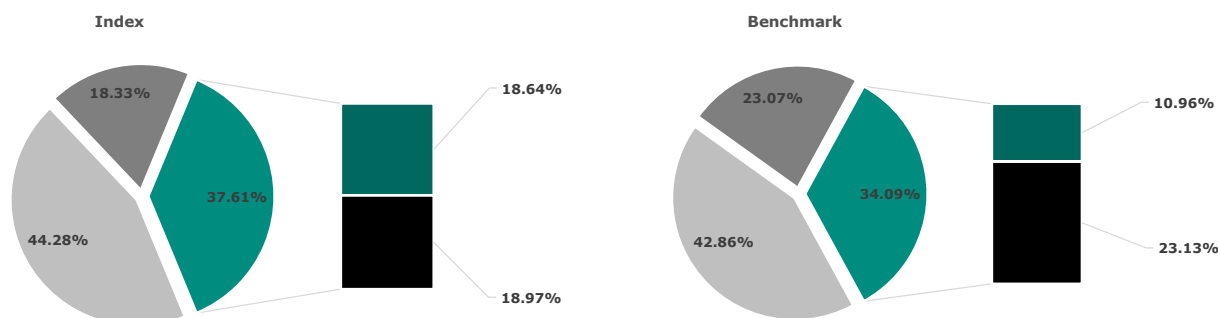
