## Objective

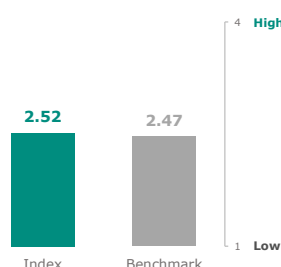
The Euronext® Sustainable UK 20 index consists of companies included in the UK Equities Universe, covering the major largest free-float market capitalisations in UK. Companies may be excluded if their level of commitment is insufficient with regard to their overall score or their score in one of six key areas reviewed in the Equities methodology or are subject to serious, proved, or recurrent controversies. Then 20 highest ranking companies are selected according to their overall Equities score. The index is Non-Market capitalisation weighted, weighting are based on the overall Equities scores. The index serves as an underlying for structured products, funds and exchange traded funds. The index rules are available on our website. Euronext acts as Supervisor. 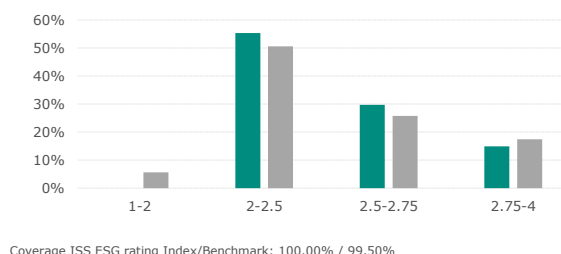

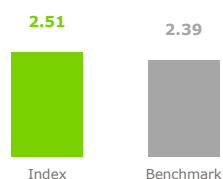
Weighted average ESG rating



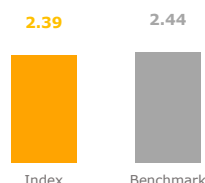
ESG score distribution



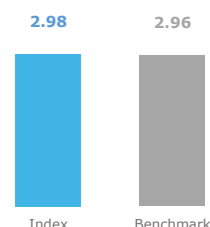

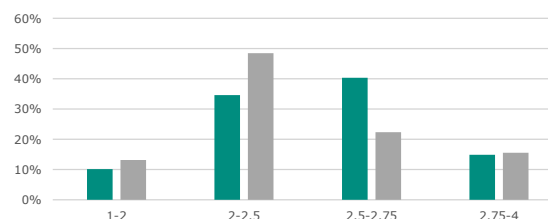

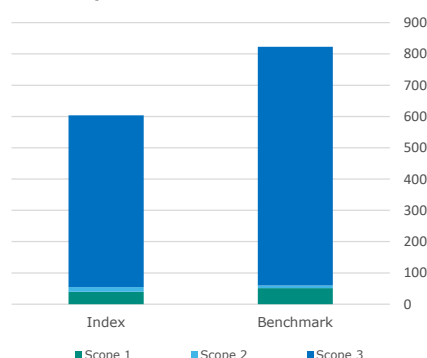
### Environmental score distribution



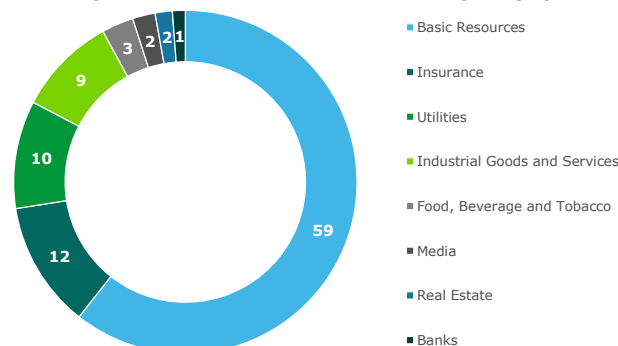

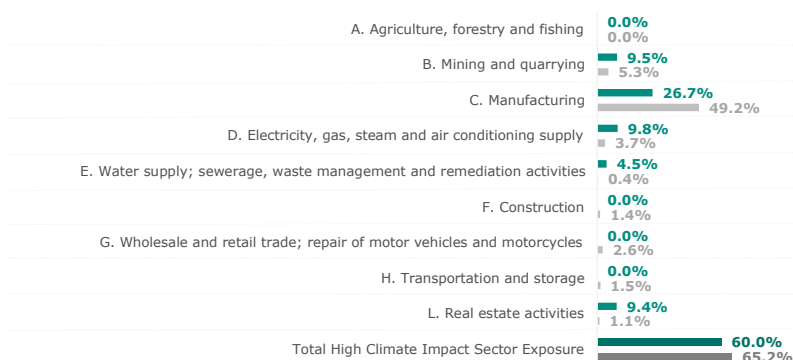
Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 26.68% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 13.66% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 100.00% of the total weight of the index, 99.32% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 84.86% for the index and 78.69% for the benchmark.

The Estimated Trust Score on scope 1,2 is - for the index and 0.92 for the benchmark. The Reported Trust Score assessing the reliability of issuer-reported emissions data is 0.96 for the index and 0.92 for the benchmark.

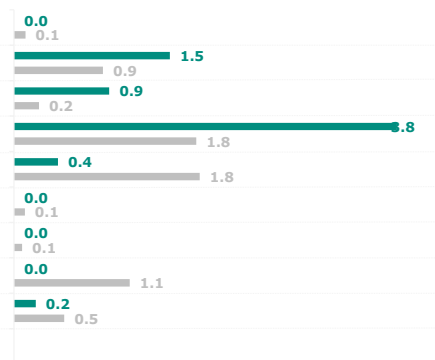

## High Climate Impact Sectors Exposure (NACE)



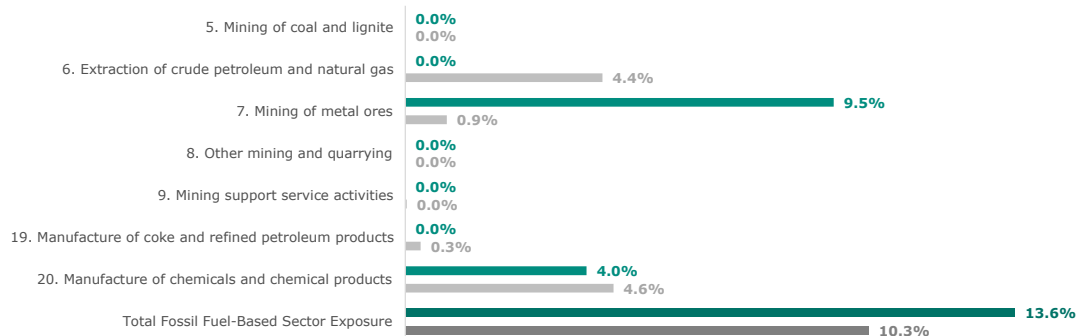

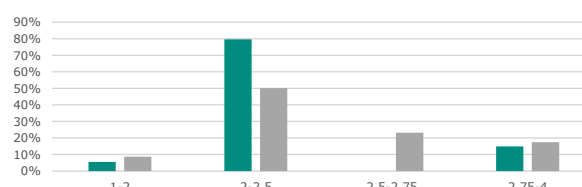

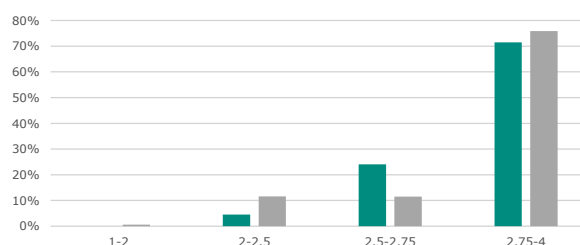

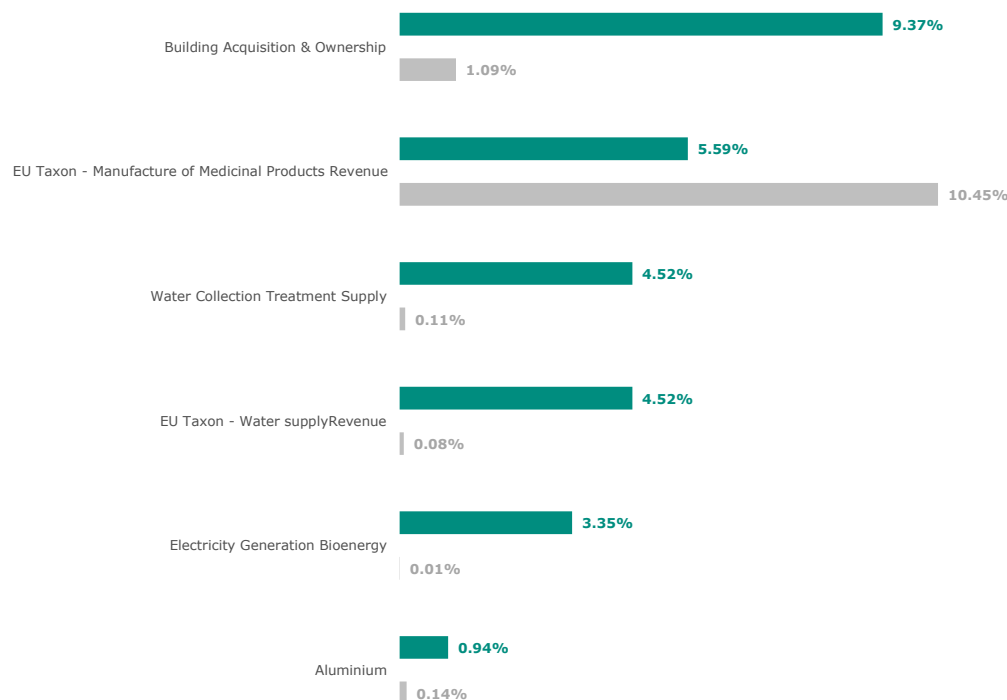

### Top Eligible Activities of the Index (%)

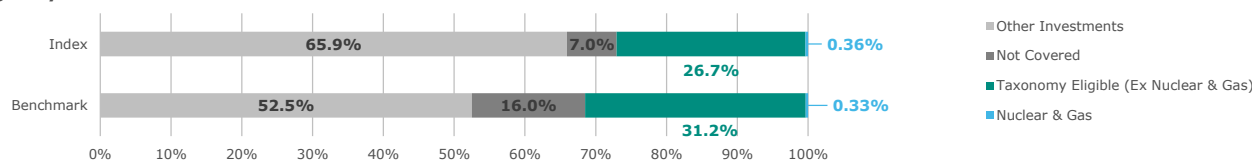

## Eligibility Breakdown - Nuclear & Gas



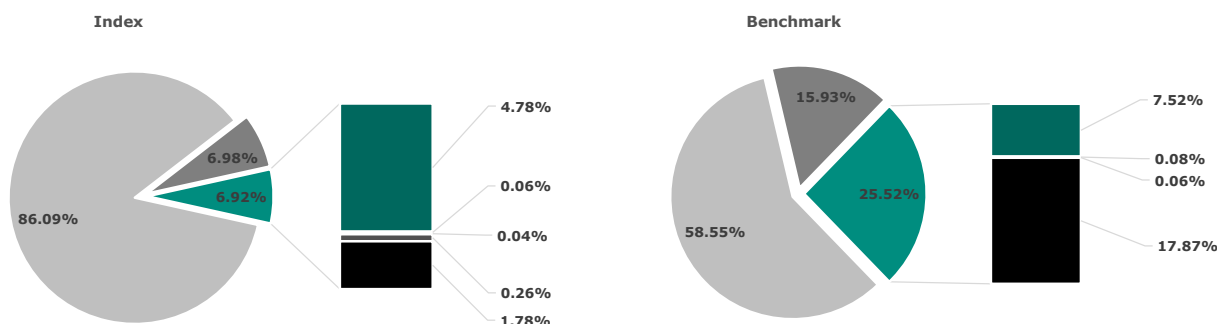
