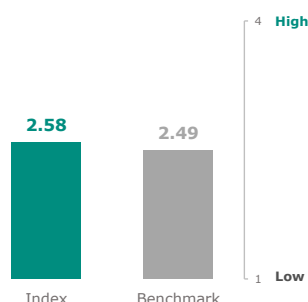

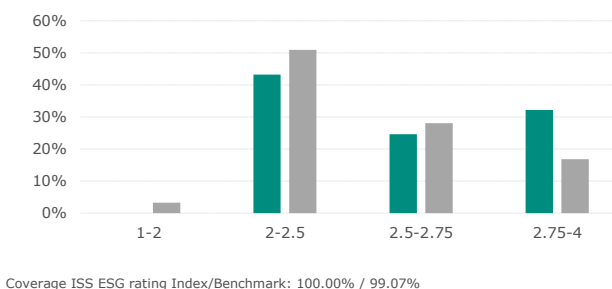

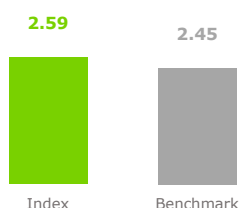
**Weighted average ESG rating**



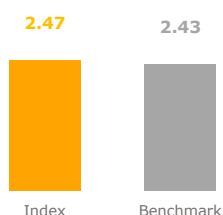
**ESG score distribution**



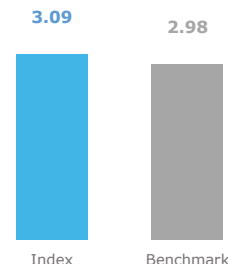

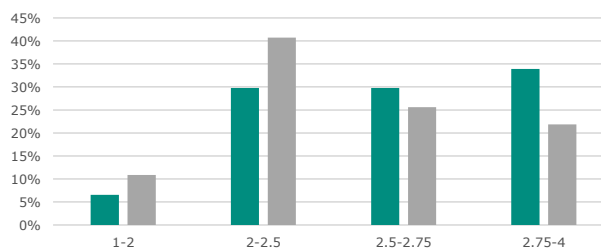

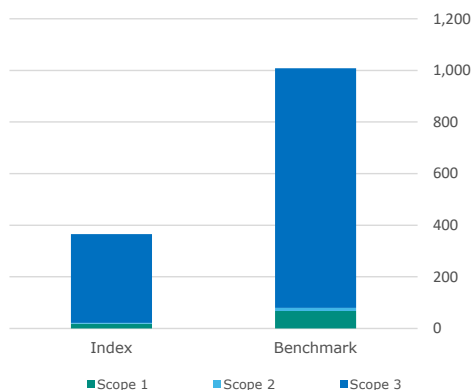

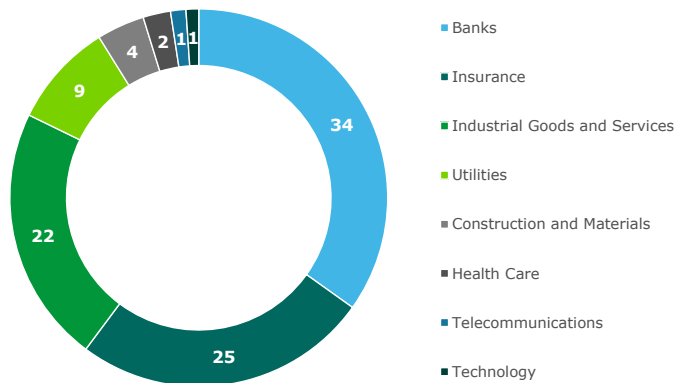

Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 63.71% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 22.93% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 100.00% of the total weight of the index, 98.14% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 89.13% for the index and 80.82% for the benchmark.

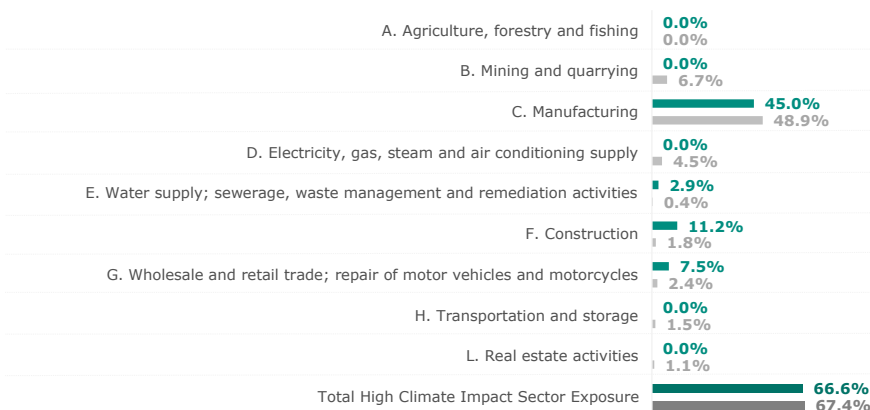

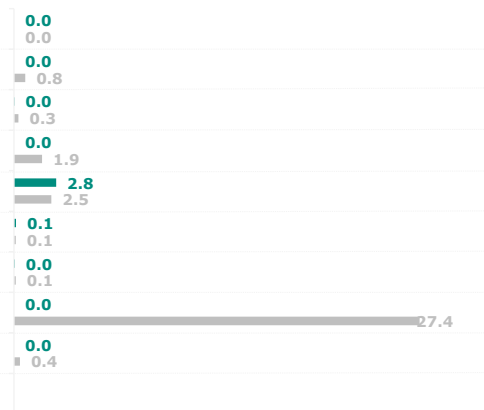

## High Climate Impact Sectors Exposure (NACE)



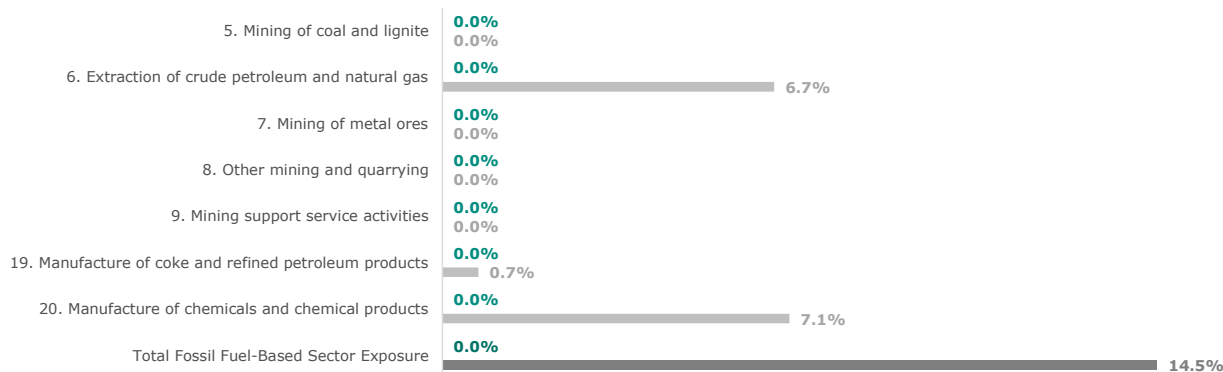
## Energy Consumption per High Climate Impact Sectors

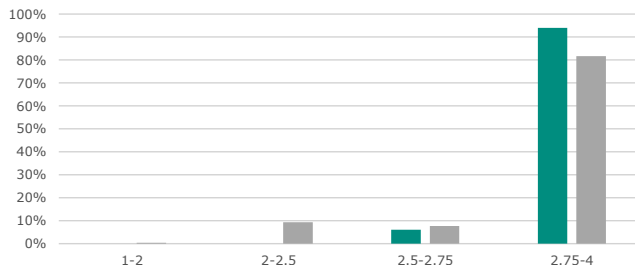
