









Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 52.42% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 12.87% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG intensity scope 1 + 2 is 96.78% of the total weight of the index, 96.07% for the benchmark.


Energy Consumption per High Climate Impact Sectors







Eligibility Breakdown - Nuclear & Gas




