



#### **ESG** score distribution









Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 62.03% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 36.50% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG intensity scope 1 + 2 is 97.52% of the total weight of the index, 97.89% for the benchmark.


### **Energy Consumption per High Climate Impact Sectors**







#### **All Objectives EU Taxonomy Alignment**



#### Top Eligible Activities of the Index (%)




