
The Euronext® Euro 50 ESG EW, is an equal weighted index that reflects the performance of the top 50 stocks, based on their corporate responsibility score as provided by Moody's ESG, out of the 300 largest Free Float Market capitalisation in Eurozone. Constituents are reviewed on a quarterly basis and their weights are reset to equal weight at the quarterly rebalances. The index serves as an underlying for structured products, funds and exchange traded funds. The index rules are available on our website. Euronext acts as Supervisor. 







Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 17.36% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 8.35% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG intensity scope 1 + 2 is 100.00% of the total weight of the index, 97.89% for the benchmark.


Energy Consumption per High Climate Impact Sectors









Eligibility Breakdown - Nuclear & Gas




