The scores are provided by Moody's ESG. The index serves as an underlying for structured products, funds, derivatives and exchange traded funds. The index rules are available on our website. 







Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 46.81% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 30.98% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG intensity scope 1 + 2 is 99.49% of the total weight of the index, 97.89% for the benchmark.



High Climate Impact Sectors Exposure (NACE)


Energy Consumption per High Climate Impact Sectors




