







Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 27.61% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 20.98% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 98.03% of the total weight of the index, 97.77% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 72.10% for the index and 79.38% for the benchmark.


Energy Consumption per High Climate Impact Sectors









Top Eligible Activities of the Index (%)


