







Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 10.91% higher than the benchmark and the GHG intensity scope 1,2,3 of the index is 6.99% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 100.00% of the total weight of the index, 97.25% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 83.23% for the index and 72.75% for the benchmark.

The Estimated Trust Score on scope 1,2 is - for the index and 0.90 for the benchmark. The Reported Trust Score assessing the reliability of issuer-reported emissions data is 0.94 for the index and 0.89 for the benchmark.



High Climate Impact Sectors Exposure (NACE)


Energy Consumption per High Climate Impact Sectors







Top Eligible Activities of the Index (%)


