



Weighted average ESG rating




ESG score distribution







Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 11.46% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 18.65% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG intensity scope 1 + 2 is 96.72% of the total weight of the index, 99.52% for the benchmark.


Energy Consumption per High Climate Impact Sectors




Social score distribution






