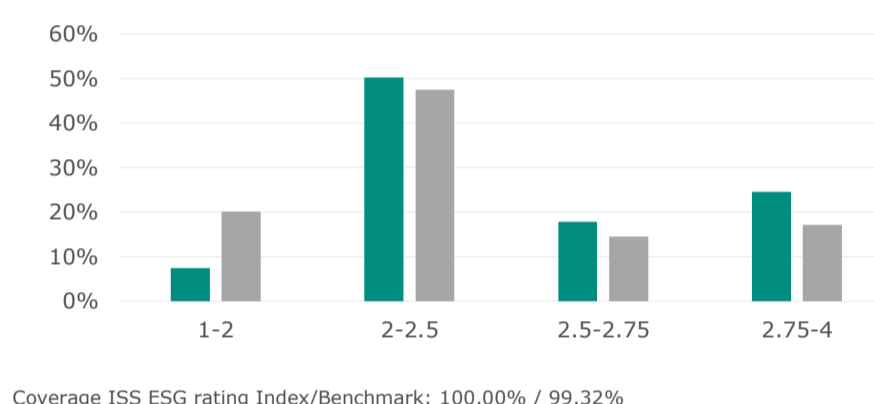

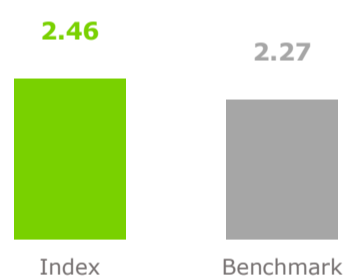
**Weighted average ESG rating**



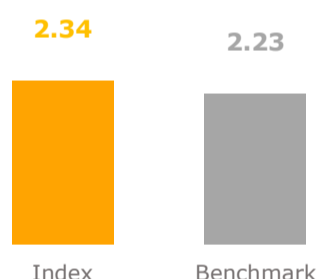
**ESG score distribution**



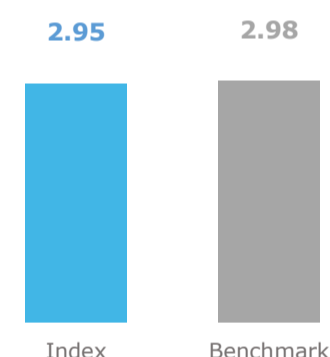

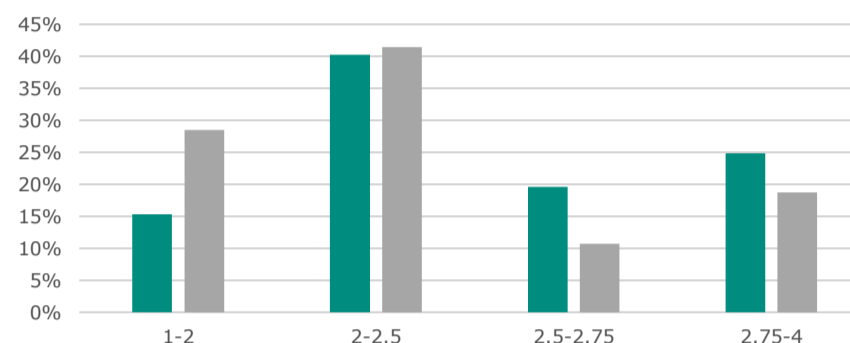

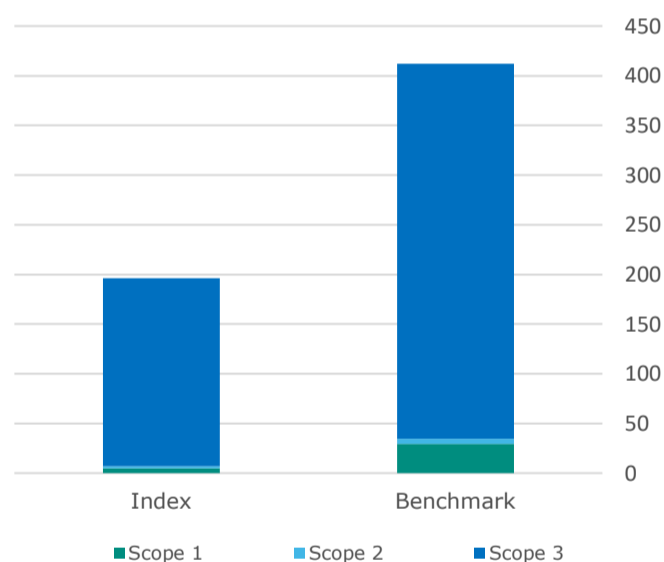
### Environmental score distribution



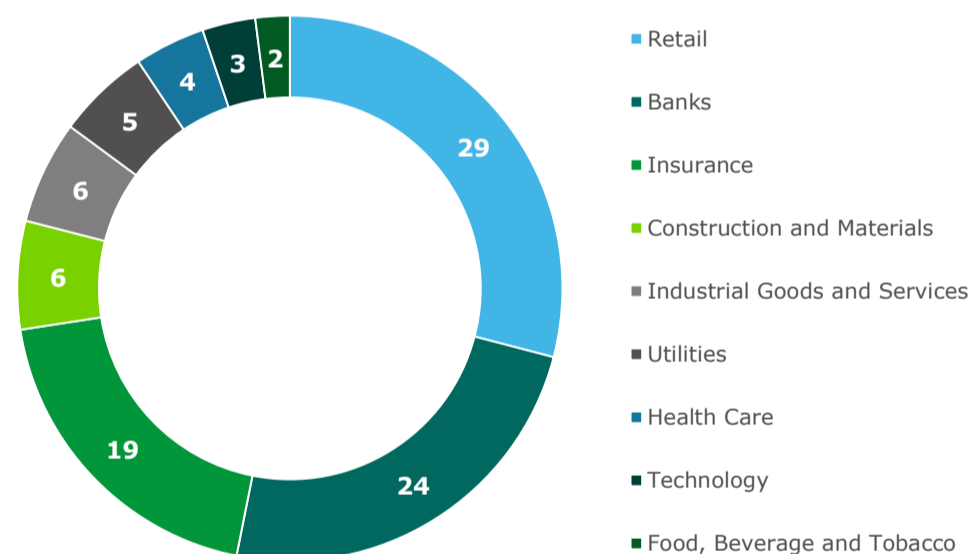

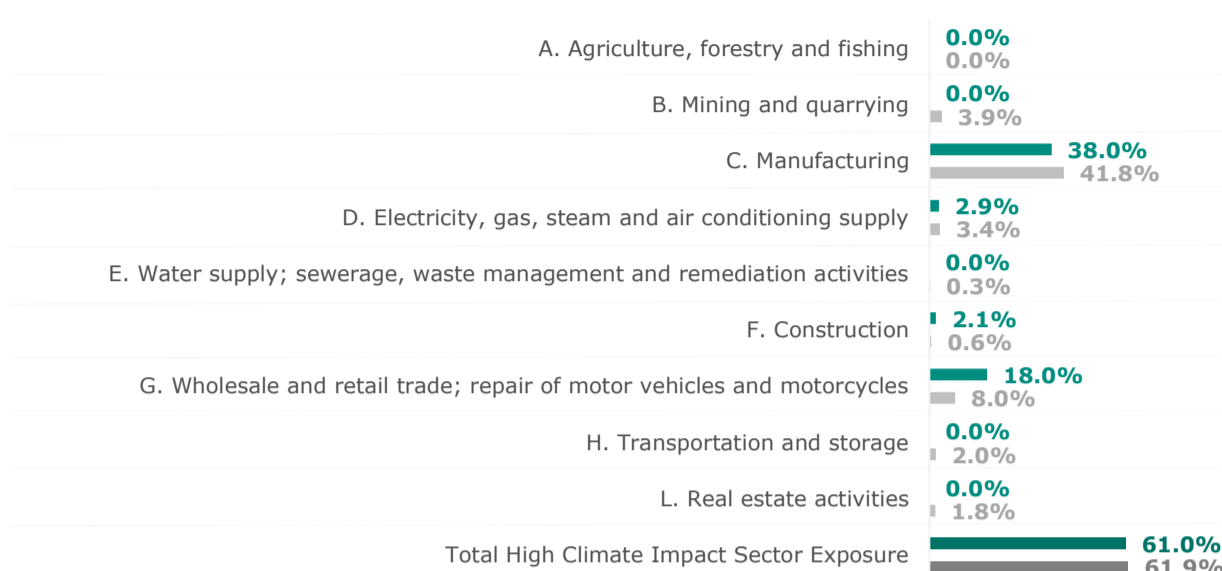
Based on ISS ESG data, the carbon footprint scope 1,2,3 of the index is 52.43% lower than the benchmark and the GHG intensity scope 1,2,3 of the index is 45.28% lower than the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 1 + 2 is 100.00% of the total weight of the index, 96.92% for the benchmark. The percentage of GHG emissions reported versus estimated on GHG scope 3 is 84.04% for the index and 73.82% for the benchmark.

The Estimated Trust Score on scope 1,2 is - for the index and 0.90 for the benchmark. The Reported Trust Score assessing the reliability of issuer-reported emissions data is 0.94 for the index and 0.89 for the benchmark.

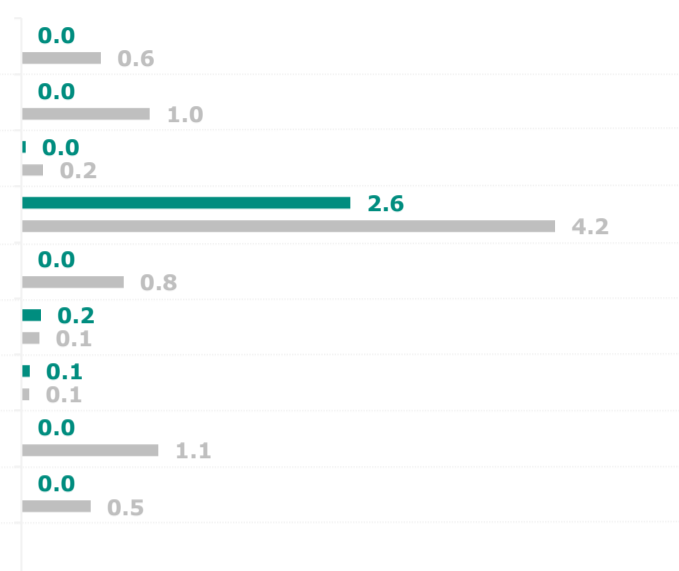

## High Climate Impact Sectors Exposure (NACE)



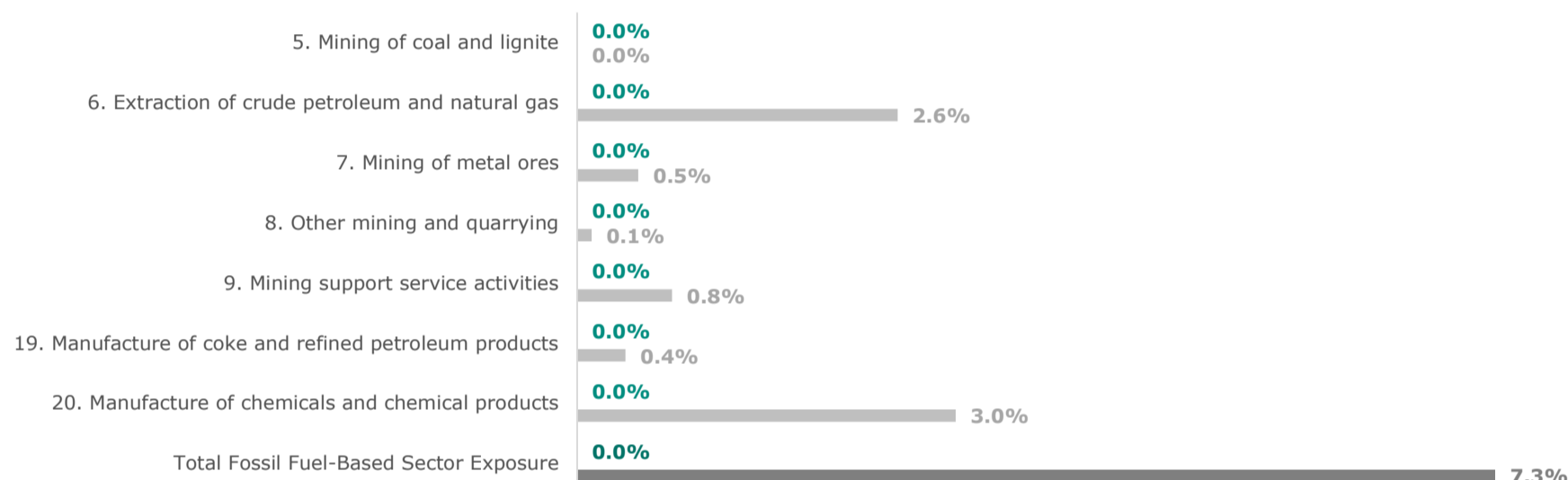

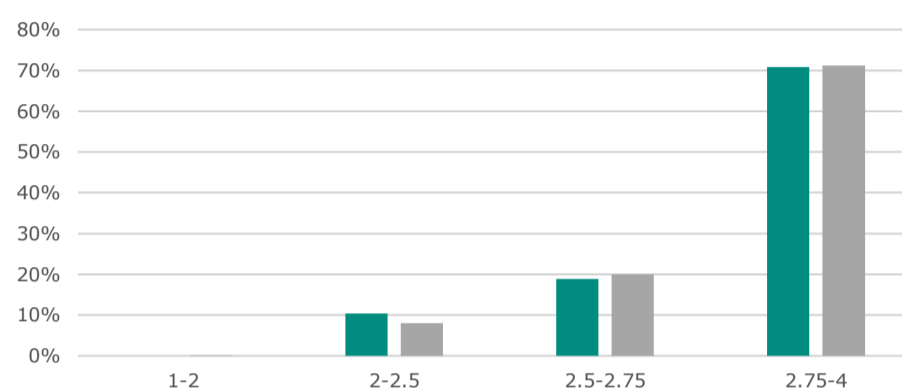

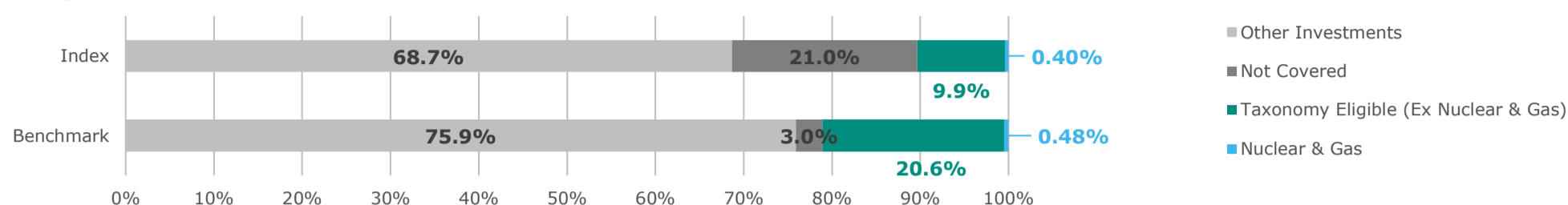

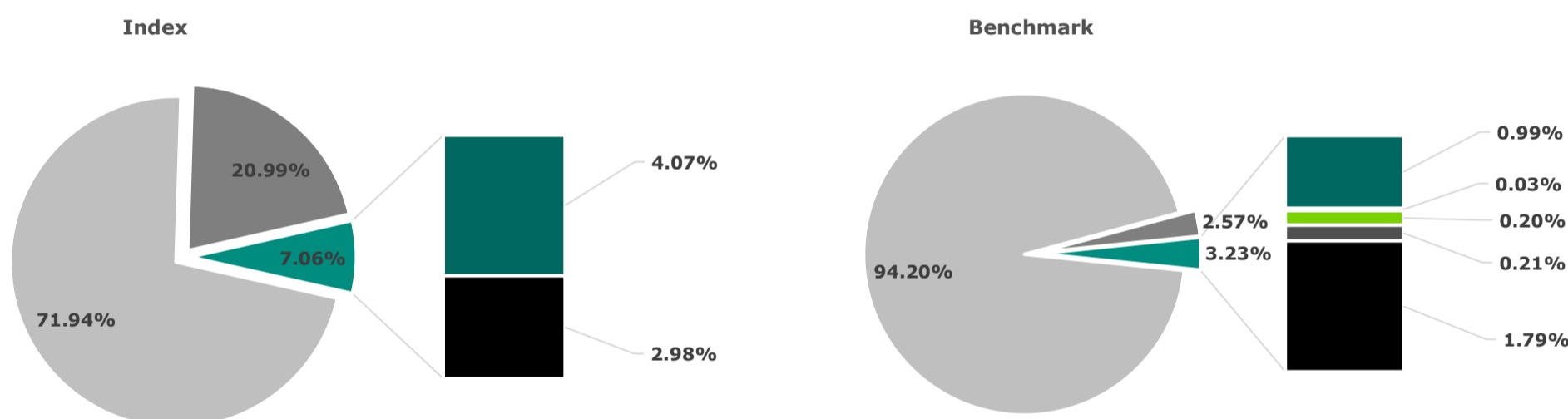
