1. INDEX ANNOUNCEMENT POLICY

1.1 INTRODUCTION

This document describes the procedure regarding the announcement period and methodology in case of changes to the index, its components or its rules.

As a rule, the announcement periods that are mentioned below will apply and the overview in chapter 2 shows the details per index. However, urgent treatments or late notices may require to deviate from the standard timing.

1.2 COMMUNICATION CHANNELS

Euronext Indices Corporate Actions Calendar (EICC)

All changes will be announced in the Euronext Indices Corporate Actions Calendar (EICC) which will be available on the Euronext Corporate Actions Portal, a web-based platform for the distribution of corporate actions data.

Euronext Indices Announcement (EIA)

Review results and rule changes are announced by an Euronext Indices Announcement (EIA). Clients with a subscription to the EICC will automatically get access to the EIA's.

The Euronext Press department is informed about each index change. They may decide whether or not the announcement should be sent in the form of a press release as well. The text of the announcement in the EIA or EICC is leading.

1.3 EURONEXT CORPORATE ACTIONS PORTAL

Euronext has launched a web-based distribution platform, the Euronext Corporate Actions Portal, for the distribution of its Cash Markets and Derivatives Markets Corporate Actions Notices, Stock/Dividend News and Index Corporate Actions Calendars and Notices.

Customers that wish to enter into an Euronext Corporate Actions Notices & Calendars license agreement with Euronext for the first time or that wish to update their existing Euronext Corporate Actions data license agreements, should contact the Euronext Licensing Team at databyeuronext@euronext.com.

1.4 REVIEWS

Review results are announced with an EIA. Every index has defined dates when the index composition will be reviewed.

The Review announcement date is the date on which, after the market close, the changes relating to the periodical review are announced.

The Review effective date is the date on which, after the market close, the changes relating to the periodical review are being effectuated in the index portfolio

The Review composition announcement date is the date on which, after close, the full details are announced regarding the index composition that will come into effect after the review effective date. This includes numbers of shares, free float factors and capping factors of all components included in the new index portfolio.

- For most indices (specified in the table) the Review announcement date is at least 6 trading days before the Review effective date. For a limited number of indices the Review Announcement Date is shorter before the Review Effective Date as per specification in the rulebook.
- For other indices, the index changes resulting from a review (composition and referential data) will be communicated at the Review composition announcement date.
- The Review composition announcement date usually is at least 2 trading days before the Review effective date.

1.5 CORPORATE ACTIONS AND OTHER INDEX ADJUSTMENTS

In case of an event that will affect one or more index constituents, index adjustments will be published in the EICC on the trading day before the effective date of such adjustment.

Forthcoming corporate actions

By publishing forthcoming corporate actions Euronext Indices would like to inform clients about upcoming non-periodical changes. The Administrator will inform the market about the intended treatment of the event in the

index shortly after firm details have become available and have been confirmed. Once the corporate action has been effectuated, the Administrator will confirm the changes in a separate announcement. Regular dividends are not included in the forthcoming corporate actions. The forthcoming corporate actions are published on a daily basis and are subject to change.

1.6 RULE CHANGES

Rule changes

Barring exception, a period of at least two months should pass between the date a proposed change is published and the effective date. Exceptions can be made only if the change is not in conflict with the interests of an affected party.
