#### 1. GENERAL

This document is applicable to the Euronext Developed World Index family ("Index Family"), which consists of all the Indices as mentioned in the Reference Table.

The Index Family is designed to reflect the price level trends in Large and Mid cap shares in global developed markets. The Index aims to cover at least 85% of the Free Float Market Capitalization of Global Developed markets.

Euronext Amsterdam is the Administrator of this Index Family. For this Index Family no Independent Supervisor is appointed.

Euronext N.V. or its subsidiaries (hereinafter jointly "Euronext") owns all intellectual and other property rights to the index, including the name, the composition and the calculation of the index. ### 2. INDEX REVIEWS

#### 2.1 REVIEW FREQUENCY AND RELEVANT DATES

Review frequency:	Semi-Annual Review in March and September
Review Effective Date:	After the market close of the third Friday of March and September.
Review Cut-Off Date:	After the market close of the penultimate Friday of February and August.
Review Announcement Date:	At least six trading days before the Review Effective Date.
Review Weighting Announcement Date:	Two days before the Review Effective Date.

#### 2.2 **REVIEW SELECTION**

#### **Step 1: Index Universe**

#### **Index Universe definition**

The Index Universe consists of Companies listed on global Developed markets. Developed Markets are those markets that have been defined as Developed Markets as per the Euronext Index Market Classification Framework. See Chapter 5 for the eligible countries and exchanges.

#### Step 2: Eligibility screening at reviews

#### Step 2A: Main Listing

Each Company is allocated to one country, each Company is allocated to a country by Index Design based on the relevant volumes, the country of incorporation, and the listing location perceived or presented as primary of the Company. If a Company has several types of securities listed in its assigned country, each of these securities are eligible.

#### Step 2B: Security Type

The following security types are not eligible for inclusion in the index:

- SPAC: A special purpose acquisition company, incorporated for the purpose of completing a merger, share exchange, asset acquisition, share purchase, reorganisation or similar transaction with a target operating company or business (the "Business Combination").
- Cash Shells: Companies whose assets consist wholly or predominantly of cash.
- Open-ended investment funds: A collective investment scheme offering regular creation/redemption of shares/units.
- Closed-ended investment funds: A collective investment scheme that does not offer creation and redemption of shares/units.
- Companies not traded continuously
- Master limited Partnerships, Limited Liability Partnerships and Limited Partnerships.
- Limited Liability Companies.
- Stapled unit and Stapled Securities when at least one of the securities is not eligible
- Chinese companies listed in US Executive Order 13959 and subsequent modifications of it are not eligible.

- Chinese Companies and depositary receipts or depositary shares of Chinese companies listed overseas are not eligible. Chinese Companies are Companies within the Index Universe with the following features:
  - Domiciled in China
  - Incorporated outside of China
  - Having strong ownership ties and main economic links with China
  - $_{\odot}$   $\,$  Over 60% of revenue or assets linked to China

#### Step 2C: Minimum amount of trading

- Companies should be listed for at least 30 trading days on the Review Cut-Off Date to be eligible for index inclusion.
- Companies should trade at least 90% of trading days or more to be eligible

#### Step 2C: Liquidity screening

From the Index Universe only Companies that have a Free Float Velocity of more than 10% eligible for the 12 months up to and including the Review Cut-Off Date to be included in the indices.

Companies should have a Free Float Factor of at least 5% to be eligible for inclusion in the Index.

All securities that are eligible for inclusion in the Index make up the Investable Universe.

#### Step 3: Selection Ranking

Eligible Companies are ranked on their free float market Capitalisation in descending order.

In addition each eligible Company is ranked on their Free Float Market Capitalisation within their assigned country.

The Index aims to cover at least 85% of the Free Float Market Capitalisation of the Investable Universe as well as of each country.

#### **Step 4: Selection of constituents at the reviews**

#### Semi-Annual Reviews

The highest ranking Companies are selected till the Index covers at least 85% of the Free Float Market Cap of the Investable Universe.

In addition the highest ranking Companies from each individual country are selected till the Index covers 85% of the Free Float Market Cap of each country.

- The Euronext Developed North America investable universe if composed of companies admitted to listing on the following MIC : XTSE, NEOE, XNAS, XNYS, XCBO
- The Euronext Developed Asia Pacific investable universe if composed of companies admitted to listing on the following MIC : XHKG, XTKS, XSES, XASX, XNZE
- The Euronext Developed Asia investable universe if composed of companies admitted to listing on the following MIC : XHKG, XTKS, XSES
- The Euronext Developed Pacific investable universe if composed of companies admitted to listing on the following MIC : XNZE, XASX
- The Euronext Developed USA investable universe if composed of companies admitted to listing on the following MIC : XNAS, XNYS, XCBO
- The Euronext Developed Japan investable universe if composed of companies admitted to listing on the following MIC : XTKS

- The Euronext Developed Canada investable universe if composed of companies admitted to listing on the following MIC : XTSE, NEOE
- The Euronext Developed Switzerland investable universe if composed of companies admitted to listing on the following MIC : XSWX
- The Euronext Developed UK investable universe if composed of companies admitted to listing on the following MIC : XLON

#### 2.3 PERIODICAL WEIGHTING UPDATE

#### Weighting method

The index is Free Float Market Capitalization weighted.

The Weighting Factors are explained in the following paragraphs.

#### Number of shares

At each review, the number of shares included in the index will be updated with the number of shares listed on the Review Cut-Off Date, taking into account adjustments due to Corporate Actions.

#### **Free Float factor**

The Free Float Factor is determined based on the Review Cut-Off Date.

#### **Capping Factor**

The Capping Factor is not applied for this Index Family.

The Base Currency of this index family is Euro.

#### 3.3 PUBLICATION

The opening level is calculated using the last known prices of traded constituents or in the case of constituents that have non-traded, halted or suspended status, the previous day reference prices or estimated prices (for IPOs, buyouts and swap offers).

The opening index level is disseminated at the same time as the first index level.

The index is calculated based on the most recent prices of transactions concluded on the main markets in each of the countries that are included in the index. The level of the index is in principle published every 15 seconds. The index is calculated from 09:00 hours until Euronext Markets stop regular daytime trading on the days when the Euronext Markets are open for trading.

The closing level is the last level disseminated on the trading day.
