2.2 REVIEW SELECTION

Step 1: Index Universe

Index Universe definition

The Index Universe consists of all the Companies listed on Euronext Markets.

Step 2: Eligibility screening at reviews

All the companies belonging to the Euronext Tech Leaders Segment will be eligible to the Euronext Tech Leaders index.

Step 3: Selection Ranking

Step 4: Selection of constituents at the reviews

All eligible Companies are selected for the Indices.

2.3 PERIODICAL WEIGHTING UPDATE

Weighting method

The index is Free Float Market Capitalisation weighted with Free Float Factors set at 1 for all constituents.

The Weighting Factors are explained in the following paragraphs.

Number of shares

At each review, the number of shares included in the index will be updated with the number of shares listed on the Review Cut-Off Date.

Free Float factor

The Free Float Factor is set at 1 for all constituents.

Capping Factor

At each review, the constituents are subject to a maximum weighting of 15%. The capping factors are determined based on closing prices observed on the Review Weighting Date.
