Editorial

Unlike 12 months ago, August 2012 has been a quiet month. The market volatility we saw last year was very much expected for this Summer, which led many market participants to close their positions at the end of July or at least not to open any new ones approximately until mid-August.

As a result, the activity on Warrants & Certificates in August was around **11%** lower than in July, which was already a slow month. When compared to August 2011, the decrease is much more important. In terms of value traded, August 2012 is nearly **35%** lower than 12 month ago, the number of trades is down **48%**, and the number of orders received dropped by **59%**, while the average number of products available for trading each day of the month was roughly the same as in August 2011.

For the first time in many months, probably since they were launched at the end of 2010, the activity on Leverage and Short certificates (linked to leveraged indices) has significantly decreased from one month to another, at least in terms of value traded. Between July and August, these products lost 5% market share, falling from 18% to 13%. Société Générale, who drive more than 92% of these business, were therefore the most impacted, which explains in part their market share drop of more than 4.5 points. As a result, the other top issuers have gained relative strength. In August, the top 3 issuers in terms of value traded were RBS (24.2%), Société Générale (20.8%) and ABN Amro (15.8%). In terms of number of transactions, the top 3 issuers were RBS (20.6%), Société Générale (16.2%) and ING (16.0%).

The activity drop on Leverage and Short certificates also had an impact on the top two countries of origin of the underlyings. Since most this activity is done on the CAC40 index and French stocks, France, as a country of origin, has lost its first place to The Netherlands. The market shares of these 2 countries are the same as last months, but inverted: in August, Dutch underlyings represented nearly **37%** of the value traded, while French underlyings fell to **32.5%**.


The number of new listings in August is only marginally higher than in July (nearly **5,700** vs. **5,500**) but the overall number of listings available for trading at the end of the month is significantly higher than at the end of last month (over **23,500** vs. nearly **21,700**). This could be due to the lower market volatility which resulted in fewer KO's than in July.

The subscription period for the launch of Extended Trading Hours on Warrants & Certificates on NYSE Euronext Paris was quite successful. Four months after the launch of Extended Trading Hours on NYSE Euronext Amsterdam, French investors will finally be able to trade some products between 8:0am and 6:30pm.

The Info-Flash sent to Exchange members on August 29 detailed the issuers who will go live with Extended Trading Hours Certificates on NYSE Euronext Paris on September 28. For those who did not receive it, this Info-Flash can be accessed <u>here</u>.

Barclays, Citi, Commerzbank and UniCredit will take part in the first phase on NYSE Euronext Paris. As we did after the launch of Extended Trading Hours on NYSE Euronext Amsterdam, a second subscription period could be announced after the launch on NYSE Euronext Paris for other issuers to join.















Number of transactions


The historical graph below displays the weight of the traded volume of each issuer over the total traded volume across all NYSE Euronext markets.



Number of transactions


The historical graph below displays the weight of the traded volume of each product type over the total traded volume across all NYSE Euronext markets.



Market trend: Underlying types




The historical graph below displays the weight of the traded volume of each underlying type over the total traded volume across all NYSE Euronext markets.



Market trend: Underlying countries



Number of transactions


The historical graph below displays the weight of the traded volume of each underlying country of origin over the total traded volume across all NYSE Euronext markets.




The chart below displays the number of trades per product type for each issuer active in an NYSE Euronext market.




The chart below displays the number of new product listings during the month per underlying type for each issuer active in an NYSE Euronext market.


















The historical graph below displays the weight of the traded volume of each issuer over the total traded volume on NYSE Euronext Amsterdam.




The historical graph below displays the weight of the traded volume of each product type over the total traded volume on NYSE Euronext Amsterdam.




The historical graph below displays the weight of the traded volume of each underlying type over the total traded volume on NYSE Euronext Amsterdam.




The historical graph below displays the weight of the traded volume of each underlying country of origin over the total traded volume on NYSE Euronext Amsterdam.




The chart below displays the number of trades per product type for each issuer active on NYSE Euronext Amsterdam.




The chart below displays the number of new product listings during the month per underlying type for each issuer active on NYSE Euronext Amsterdam.










The historical graph below displays the weight of the traded volume of each product type over the total traded volume on NYSE Euronext Brussels.








The historical graph below displays the weight of the traded volume of each underlying country of origin over the total traded volume on NYSE Euronext Brussels.




The chart below displays the number of trades per product type for each issuer active on NYSE Euronext Brussels.




The chart below displays the number of new product listings during the month per underlying type for each issuer active on NYSE Euronext Brussels.

















The historical graph below displays the weight of the traded volume of each issuer over the total traded volume on NYSE Euronext Lisbon.






The historical graph below displays the weight of the traded volume of each product type over the total traded volume on NYSE Euronext Lisbon.




The historical graph below displays the weight of the traded volume of each underlying type over the total traded volume on NYSE Euronext Lisbon.




The historical graph below displays the weight of the traded volume of each underlying country of origin over the total traded volume on NYSE Euronext Lisbon.








The chart below displays the number of new product listings during the month per underlying type for each issuer active on NYSE Euronext Lisbon.
















The historical graph below displays the weight of the traded volume of each issuer over the total traded volume on NYSE Euronext Paris.




The historical graph below displays the weight of the traded volume of each product type over the total traded volume on NYSE Euronext Paris.




The historical graph below displays the weight of the traded volume of each underlying type over the total traded volume on NYSE Euronext Paris.




The historical graph below displays the weight of the traded volume of each underlying country of origin over the total traded volume on NYSE Euronext Paris.




The chart below displays the number of trades per product type for each issuer active on NYSE Euronext Paris.




The chart below displays the number of new product listings during the month per underlying type for each issuer active on NYSE Euronext Paris.


