Editorial

Our latest analysis on Extended Trading Hours (ETH) revealed that a significant number of orders is received during the early (8:00-9:05) and late (17:30-18:30) extended hours. Orders received during the early and late trading sessions in November were approximately 80% and 60% respectively of the 60-minute average during normal trading hours, yielding approximately 15% of the daily average orders.

Compared to the 12-month rolling average, we saw an increase of nearly 4% in early orders and almost 1% in early trades in November.

The most active products in early trading are those whose underlying are Indices and Leveraged Indices. In November 2013 on Leveraged Indices, the number of orders received during early trading represented 115% of the average number of orders received per hour during normal trading. The weight is 85% for Warrants & Certificates on Indices. In terms of transactions, the weights are 110% and 82% respectively.

While the number of trades declined by 2% for all Euronext markets, the value traded increased as opposed to the previous month. This is mostly attributed to an increase for the most popular product types such as Leveraged KO Open -End, Leveraged KO Open-End BEST and Vanilla Warrants.

ABN AMRO introduced its Leveraged KO Open-End BEST products in the middle of November. During the remaining period of November, when ABN AM-RO was competing on Euronext Amsterdam on these products, they gained 11% market share in terms of value traded and 3% in terms of trades.

For indices we observed an month-on-month increase of 21% in daily average value traded, yielding an average of \notin 32 million. German underlyings recovered from their decline in October with an increase of nearly 60% in November, making them ranked third in daily average traded value per underlying country.

The number of trades on Gold has decreased by 30% whereas the DAX gained popularity (+60% in terms of daily average traded value).








Top 10 underlying countries







The historical graph below displays the weight of the traded volume of each issuer over the total traded volume across all Euronext markets.





Number of transactions


The historical graph below displays the weight of the traded volume of each product type over the total traded volume across all Euronext markets.



MARKET TREND: UNDERLYING TYPES




The historical graph below displays the weight of the traded volume of each underlying type over the total traded volume across all Euronext markets.



MARKET TREND: UNDERLYING COUNTRIES



The historical graph below displays the weight of the traded volume of each underlying country of origin over the total traded volume across all Euronext markets.





The chart below displays the number of trades per product type for each issuer active in an Euronext market.





The chart below displays the number of new product listings during the month per underlying type for each issuer active in an Euronext market.




















The historical graph below displays the weight of the traded volume of each issuer over the total traded volume on Euronext Amsterdam.




The historical graph below displays the weight of the traded volume of each product type over the total traded volume on Euronext Amsterdam.




The historical graph below displays the weight of the traded volume of each underlying type over the total traded volume on Euronext Amsterdam.



The historical graph below displays the weight of the traded volume of each underlying country of origin over the total traded volume on Euronext Amsterdam.





The chart below displays the number of trades per product type for each issuer active in an Euronext market.





The chart below displays the number of new product listings during the month per underlying type for each issuer active in an Euronext market.










The historical graph below displays the weight of the traded volume of each issuer over the total traded volume on Euronext Brussels.




The historical graph below displays the weight of the traded volume of each product type over the total traded volume on Euronext Brussels.








The historical graph below displays the weight of the traded volume of each underlying country of origin over the total traded volume on Euronext Brussels.




The chart below displays the number of trades per product type for each issuer active on Euronext Brussels.






























The historical graph below displays the weight of the traded volume of each issuer over the total traded volume on Euronext Paris.




The historical graph below displays the weight of the traded volume of each product type over the total traded volume on Euronext Paris.



MARKET TREND: UNDERLYING TYPES




The historical graph below displays the weight of the traded volume of each underlying type over the total traded volume on Euronext Paris.




The historical graph below displays the weight of the traded volume of each underlying country of origin over the total traded volume on Euronext Paris.



The chart below displays the number of trades per product type for each issuer active on Euronext Paris.





The chart below displays the number of new product listings during the month per underlying type for each issuer active on Euronext Paris.




