Editorial

April was a calmer month compared to April 2014 Year-to-Date. The daily average value traded was down by 2.6% and the daily average number of trades by 1.7% across all markets. Compared to March 2014, the daily average value traded in April was down by 6.1% and the daily average number of trades by 5.1%. However, compared to April 2013, the daily average value traded in April 2014 was up by 5.1% and there were on average 6.9% more trades per day. This number is even higher when comparing to the monthly average over the last 12 months: the daily average value traded was up by 12% and the daily average number of trades by 14%. In particular, it was a good month for Euronext Lisbon where the daily average number of trades by 15% compared to March.

The strong listing trend has regained momentum again. In April there were 12K new listings yielding a total of 36K live listings at the end of the month. This is 8% more live listings compared to the previous month and 26% more when compared to April 2013. On Euronext Paris there were almost 10K new listings for a total of 22K at the end of the month.

Among some issuers there has been a shift in the ranking in terms of the market share in value traded. Commerzbank, ranked third in March, is now ranked second. ING gained 1.2% market share and is now ranked third and has also almost caught up with Commerzbank (only 0.5% difference in market share between them). ABN Amro, ranked second in March, lost almost 4% market share and is now ranked fourth. Value traded on RBS products accounted for 27% of the total value traded in April. The gap between RBS and the second ranked issuer Commerzbank is therefore 11.3% in terms of market share in value traded.

Among the product types there have been no major changes. The market shares and ranking of the product types remained almost the same as in March. This holds true for the underlying types with exception of single stocks which gained 3.5% market share in April. The activity of single stocks increased by 11% and leveraged stocks with 23% in terms of daily average value traded.








Top 10 underlying countries







Number of transactions


The historical graph below displays the weight of the traded volume of each issuer over the total traded volume across all Euronext markets.



MARKET TREND: PRODUCT TYPES




The historical graph below displays the weight of the traded volume of each product type over the total traded volume across all Euronext markets.



MARKET TREND: UNDERLYING TYPES




The historical graph below displays the weight of the traded volume of each underlying type over the total traded volume across all Euronext markets.



MARKET TREND: UNDERLYING COUNTRIES



Number of transactions


The historical graph below displays the weight of the traded volume of each underlying country of origin over the total traded volume across all Euronext markets.



The chart below displays the number of trades per product type for each issuer active in an Euronext market.





The chart below displays the number of new product listings during the month per underlying type for each issuer active in an Euronext market.




















The historical graph below displays the weight of the traded volume of each issuer over the total traded volume on Euronext Amsterdam.




The historical graph below displays the weight of the traded volume of each product type over the total traded volume on Euronext Amsterdam.




The historical graph below displays the weight of the traded volume of each underlying type over the total traded volume on Euronext Amsterdam.



The historical graph below displays the weight of the traded volume of each underlying country of origin over the total traded volume on Euronext Amsterdam.






The chart below displays the number of trades per product type for each issuer active in an Euronext market.



The chart below displays the number of new product listings during the month per underlying type for each issuer active in an Euronext market.




















The historical graph below displays the weight of the traded volume of each underlying country of origin over the total traded volume on Euronext Brussels.







The chart below displays the number of new product listings during the month per underlying type for each issuer active on Euronext Brussels.
















The historical graph below displays the weight of the traded volume of each issuer over the total traded volume on Euronext Lisbon.
























The historical graph below displays the weight of the traded volume of each issuer over the total traded volume on Euronext Paris.




The historical graph below displays the weight of the traded volume of each product type over the total traded volume on Euronext Paris.



MARKET TREND: UNDERLYING TYPES




The historical graph below displays the weight of the traded volume of each underlying type over the total traded volume on Euronext Paris.




The historical graph below displays the weight of the traded volume of each underlying country of origin over the total traded volume on Euronext Paris.



The chart below displays the number of trades per product type for each issuer active on Euronext Paris.





The chart below displays the number of new product listings during the month per underlying type for each issuer active on Euronext Paris.




