














The historical graph below displays the weight of the traded value of each issuer over the total traded value across all Euronext markets.



The historical graph below displays the weight of the traded volume of each issuer over the total traded volume across all Euronext markets.




The historical graph below displays the weight of the traded value of each product type over the total traded value across all Euronext markets.



The historical graph below displays the weight of the traded volume of each product type over the total traded volume across all Euronext markets.




The historical graph below displays the weight of the traded value of each underlying type over the total traded value across all Euronext markets.


The historical graph below displays the weight of the traded volume of each underlying type over the total traded volume across all Euronext markets.




The historical graph below displays the weight of the traded volume of each underlying country of origin over the total traded volume across all Euronext markets.




The chart below displays the number of trades per product type for each issuer active in an Euronext market.




The chart below displays the number of new product listings during the month per underlying type for each issuer active in an Euronext market.


















The historical graph below displays the weight of the traded value of each issuer over the total traded value on Euronext Amsterdam.



The historical graph below displays the weight of the traded volume of each issuer over the total traded volume on Euronext Amsterdam.




The historical graph below displays the weight of the traded value of each product type over the total traded value on Euronext Amsterdam.



The historical graph below displays the weight of the traded volume of each product type over the total traded volume on Euronext Amsterdam.




The historical graph below displays the weight of the traded value of each underlying type over the total traded value on Euronext Amsterdam.


The historical graph below displays the weight of the traded volume of each underlying type over the total traded volume on Euronext Amsterdam.




The historical graph below displays the weight of the traded volume of each underlying country of origin over the total traded volume on Euronext Amsterdam.




The chart below displays the number of trades per product type for each issuer active in an Euronext market.




The chart below displays the number of new product listings during the month per underlying type for each issuer active in an Euronext market.
















The historical graph below displays the weight of the traded value of each issuer over the total traded value on Euronext Brussels.



The historical graph below displays the weight of the traded volume of each issuer over the total traded volume on Euronext Brussels.




The historical graph below displays the weight of the traded value of each product type over the total traded value on Euronext Brussels.



The historical graph below displays the weight of the traded volume of each product type over the total traded volume on Euronext Brussels.




The historical graph below displays the weight of the traded value of each underlying type over the total traded value on Euronext Brussels.


The historical graph below displays the weight of the traded volume of each underlying type over the total traded volume on Euronext Brussels.



The historical graph below displays the weight of the traded value of each underlying country of origin over the total traded value on Euronext Brussels.




Number of transactions

The historical graph below displays the weight of the traded volume of each underlying country of origin over the total traded volume on Euronext Brussels.




The chart below displays the value traded per product type (in million Euros) for each issuer active on Euronext Brussels.


The chart below displays the number of trades per product type for each issuer active on Euronext Brussels.




The chart below displays the number of new product listings during the month per underlying type for each issuer active on Euronext Brussels.






The historical graph below displays the weight of the traded value of each issuer over the total traded value on Euronext Lisbon.



The historical graph below displays the weight of the traded volume of each issuer over the total traded volume on Euronext Lisbon.




The historical graph below displays the weight of the traded value of each product type over the total traded value on Euronext Lisbon.



The historical graph below displays the weight of the traded volume of each product type over the total traded volume on Euronext Lisbon.




The historical graph below displays the weight of the traded value of each underlying type over the total traded value on Euronext Lisbon.


The historical graph below displays the weight of the traded volume of each underlying type over the total traded volume on Euronext Lisbon.



The historical graph below displays the weight of the traded value of each underlying country of origin over the total traded value on Euronext Lisbon.



The historical graph below displays the weight of the traded volume of each underlying country of origin over the total traded volume on Euronext Lisbon.




The chart below displays the value traded per product type (in million Euros) for each issuer active on Euronext Lisbon.


The chart below displays the number of trades per product type for each issuer active on Euronext Lisbon.




The chart below displays the number of new product listings during the month per underlying type for each issuer active on Euronext Lisbon.














The historical graph below displays the weight of the traded value of each issuer over the total traded value on Euronext Paris.



The historical graph below displays the weight of the traded volume of each issuer over the total traded volume on Euronext Paris.




The historical graph below displays the weight of the traded value of each product type over the total traded value on Euronext Paris.



The historical graph below displays the weight of the traded volume of each product type over the total traded volume on Euronext Paris.




The historical graph below displays the weight of the traded value of each underlying type over the total traded value on Euronext Paris.


The historical graph below displays the weight of the traded volume of each underlying type over the total traded volume on Euronext Paris.








The chart below displays the number of trades per product type for each issuer active on Euronext Paris.






