Subject: Orpea Corporate Action Treatment Adjustment

## Details:

Given the specific circumstances on the highly dilutive right issue on Orpea (FR0000184798) Euronext Index Design has decided to adjust the corporate action treatment on Orpea as performed after the close of Monday 27/11 (effective Tuesday 28/11). In order for the Index to represent the economic reality of what it intends to measure, Euronext Index Design has decided in line with Chapter 2 of the Euronext Corporate Action rulebook, to adjust the timing of this corporate action treatment. This would concretely mean:

- The Corporate Action adjustment effective 28/11 will be cancelled and postponed to Monday 04/12. The changes effective 28/11 will be reversed. This means no Orpea shares coming from the rights issue are added to the Index per 28/11 and the Orpea rights line stays in the Index against the last traded price (0.001).
- Per Monday 04/12, the new shares will be added to the Index against the subscription price. The rights will be removed from the Index at a price of 0.

As a consequence, Index level broadcasted after this announcement are indicative for the Indices mentioned below. The Index closing levels of 28/11 will be updated and the correct Index closing levels of 29/11 will be reflected in the official closing levels of the Indices.
